A Christmas Gift From God

Read: James 1:13-18, Malachi 4, Matthew 1:18-24

The first Sunday in December marks the first day of the Christmas Advent season. Advent means "coming or arrival." It is the anticipation of the coming of the Lord, not the baby Jesus, but the second coming of Christ to rule over His kingdom. The first Advent celebration, which was started by the church in Spain/France in the 4th and 5th century was instituted to prepare new converts for baptism on Epiphany Sunday - Jan 6.

It was in the 6th century that the Roman church first tied the Advent celebrations to the coming of Christ. Advent is celebrated by the church from Christmas Eve thru January 6th and it covers five Sundays in December and ends on January the 6th, Epiphany Sunday, the day the Magi came to worship The Christ child. Pope Gregory I, the first pope approximately (550AD) established the church rule of Advent celebration. Today the believing churches are to celebrate by anticipating the return of Christ to take over His kingdom (Hebrews 1:2-3). The Catholic (Universal) church, has been blessed to establish traditional church ceremonies, so as to build Christian traditions based upon the life of Christ. This expectation is the same expectation as it were of the Old testament Jew to the coming of the awaited Messiah. The difference today is that we await the second coming of Christ instead of his first, as a baby. "O come, O come Emanuel" is the traditional hymn which expresses this glorious expectation.

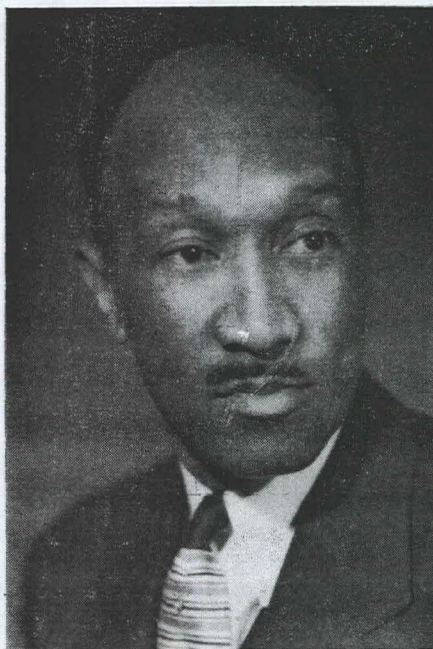



Whereas, death is a certainty, it always comes unexpectedly. The entire Mutual Family was saddened by the passing of Clifford R Alexander in Philadelphia on June 6, 1958. This brings to a close 24 years of unselfish and loyal service on the part of Mr Alexander for North Carolina Mutual. He started his career in September, 1933, as a Special Agent on the East Baltimore District. In June, 1934, he was made Assistant Manager of that district. In April, 1942, he was made Manager of the Savannah District. It was my good fortune to be associated with Mr J L Wheeler at the installation of Alex as Manager of this district. This was the beginning of a personal friendship that existed between us until his untimely death. In February, 1946, he was made an Agency Supervisor; in January, 1951 - Regional Supervisor; and in January, 1957, Assistant to the Agency Director, which office he held until his death.

Alex was not only loved and respected by his associates, but enjoyed the respect and honor of everyone in the life insurance profession. He lived a full life, participating in many organizations, namely: Omega Psi Phi Fraternity, of which he was Past Grand Keeper of Records and Seal; former Vice President of the Agency Section of the National Insurance Association; member of the Frontiersmen Club of America; member of the N A A C P; and Judge of Elections of the City of Philadelphia.

He was married to the former Marjorie W Jackson who survives him, along with two fine children - Marjorie Grace and Clifford, Jr.

WHEREAS, he was widely recognized by all of his associates and by his many friends throughout the life insurance business as an extremely able and conscientious administrator who played an important role in the growth of North Carolina Mutual during the twenty-four years he served the Company; and

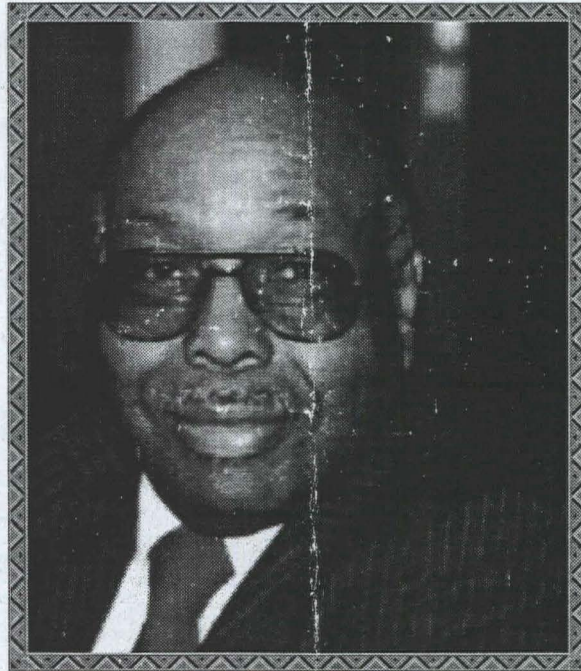
WHEN I AM DEAD

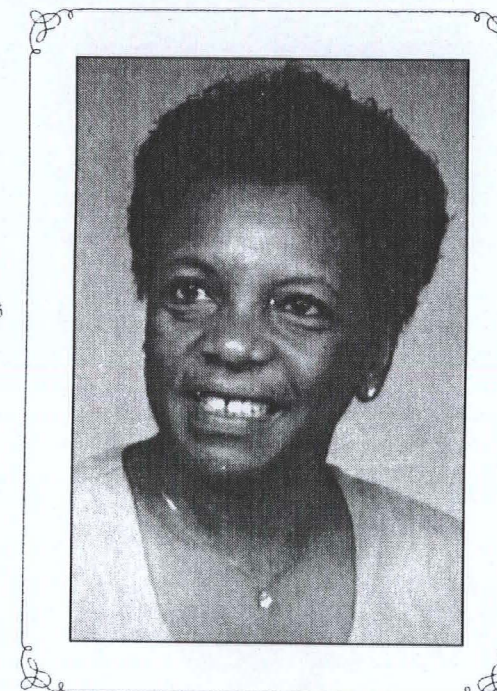

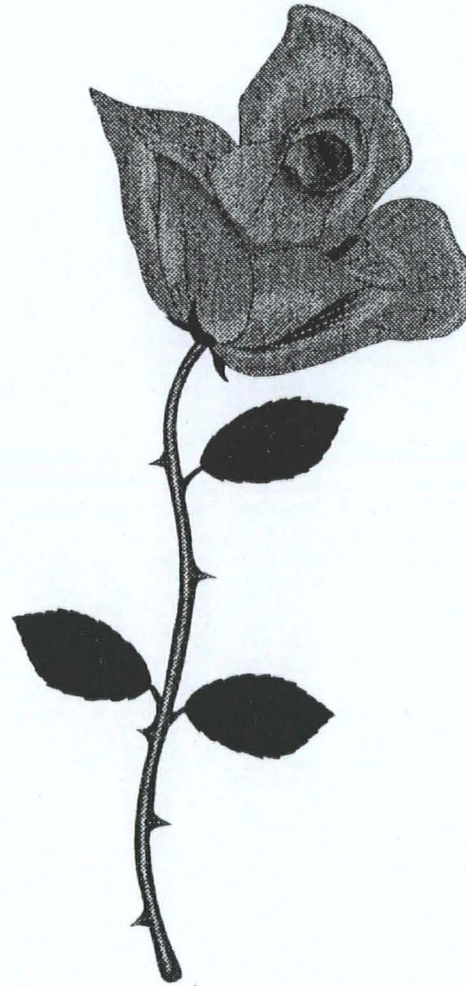
Obituary

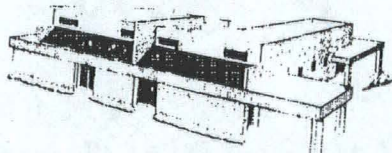

Early Friday morning, January 20th, 1995, during the quiet of the new day, God chose one of His special angels to deliver the soul of his beloved G. Wesley Allen, M.D., from the toils of earthly labor to the reward of peaceful eternal rest.

He was born May 17th, 1916, to the late Jabez and Ethel Allen in Savannah Lamar, Jamaica. He was orphaned at the age of twelve years old. He came to the United States and moved to Philadelphia, Pennsylvania. He educated himself at Lincoln University and Meharry Medical School. His post graduate medical study was at the University of Pennsylvania.

After graduation from medical school in 1941, he was joined in holy matrimony to Miss Sylvia Ximines. After marriage they began their lives together by moving to Fayetteville, North Carolina. This union was blessed with eight children.

Dr. Allen's professional career spans more than fifty years as an obstetrician and gynecologist. During this period he delivered more than 11,000 children, found homes for more than one hundred orphans and founded a special school for black handicapped youth, as well as an one hundred and twenty bed nursing home for the elderly.

In addition to his medical career, Dr. Allen was an important civic leader. He was instrumental in bringing integration to Fayetteville in a nonviolent manner. Providing financial and planning resources, Dr. Allen was an advocate of advancement through work, education, and community participation. After many years of service to the American Cancer Society he was awarded a lifetime board membership.

In addition to providing medical services through his medical practice and nursing home, Dr. Allen helped found Seabrook Park, United National Bank, and the Cape Fear Industries, Inc. He was a past president of the Fayetteville NAACP.

Dr. Allen was a public servant his entire life. He kept his medical office at 1804 Murchison Road open until his death.
