The Grand Master submitted the following Communication ; which was read ; and the same was disposed of in the usual manner :

As the wheels of time have again, in their regular and undisturbed revolutions brought around the season at which you have from time been accustomed to assemble, suffer me to congratulate you on the favorable circumstances under which you have met to deliberate upon the various subjects which may be presented for your consideration and deliberation. We continue to receive from the hands of a kind and indulgent Providence the blessings of health, prosperity, and happiness ; and we would fall far short of our duties, as Christians and Masons, if we failed to make devout acknowledgments to a Benificent Creator for these and other mercies which have been unsparingly lavished upon us.

The time allotted me, from my official and domestic duties, to attend to my Masonic, has been so limited, that I flatter myself with the hope that the GRAND LODGE will pardon me for being brief in this address ; which has been thrown together under a press of business that I felt bound to accomplish, as an officer of the State. By resolution of the last GRAND LODGE, it was made the duty of the Grand Secretary to draw off and submit a statement of all the transactions in his department, as connected with

this Grand Body ; and I respectfully refer you to his statement for the number of Lodges chartered during our last communication, and the names of those which have been organized under Dispensations during the present year ; amounting to sixteen. I also refer you to his Report, for such other matters as he may think proper and advisable to bring to your notice. I have been able to bestow but a limited portion of my time and attention to the examination of the large number of Proceedings of our Sister GRAND LODGES, as received at the hands of our Grand Secretary ; but from this partial examination I am prepared to state, that the institution we so much value is in a prosperous condition, from Maine to Texas—and I can add California. This newly initiated Sister has, within the present year, organized for herself a GRAND LODGE ; and I will venture the opinion that she will render great benefit to the cause in which she has engaged. This fact, my Brethren, should stimulate us, of older States, to be vigilant in discharge of our Masonic duties—by which we can convince the world that our claims to this superiority and influence, are not based upon mere fancy or fiction, but are established upon the more solid and lasting foundation of Brotherly love, Relief and Truth.

The proceedings of our Sister GRAND LODGES, which have been placed in my hands by the Grand Secretary, have been handed over to the Committee “on communications from GRAND LODGES,” and no doubt will be noticed in detail. You are, Brethren, well acquainted with the violent opposition, and no less malignant persecution, by which Masonry has been assailed, from an early period of its history. The shafts of malice, envy and detraction have been hurled at her very vitals, to destroy her usefulness, and defeat our designs in diffusing Masonic principles among all nations. I derive great pleasure in the reflection, that a period in the history of Masonry has at last arrived, when the tongue of slander and vituperation has been palsied and silenced ; those barriers and impediments which were once planted in our pathway, have been in a great degree removed ; and we now occupy a more elevated position, and stand upon firmer ground, than we have for centuries past. In our creation, the Maker of all things visible and unseen never designed that his intelligent creatures should live for themselves alone. The *poor*, the indigent, and distressed, of every name and grade, should at all times excite our sympathy ; but more especially that class which belongs to our Brotherhood. The Author of our existence delights in a cheerful giver, and smiles upon every act of benevolence, when performed in a proper spirit. Masonry recognises no man for his worldly wealth or honor : and, to use the language of a writer of no ordinary celebrity, “The poor, as well as the rich, may knock at the door of our temple and gain admittance. The unlettered man, if he be honest and above reproach, can become the recipient of the benefits resulting from an introduction into our mysteries. All are

welcome into our society, if found worthy to receive light. It cannot be denied that Masonry infuses into our hearts a spirit of peace, harmony and Brotherly love ; with other kindred virtues which elevate and adorn the character of man. It is a language which is understood and spoken by the craft, wheresoever dispersed ; and it forms a common medium of communication or intercourse among our Brethren of all nations, "kindreds and tongues."

From these reflections upon the excellency and moral tendency of our honored Institution, I will now call your attention, for a few moments, to those of a practical character ; which I hope will not be disregarded by those who place a proper estimate upon the great and lasting benefits which are to be derived from Education. It will be remembered that, as far back as the year 1838, our Past Grand Master, DAVID W. STONE, deceased, introduced a set of resolutions, the object of which was the establishment of a MASONIC SEMINARY for the education of the children attached to our Fraternity ; and, since that period, it has been made a subject of serious and earnest discussion in this body, at nearly every meeting of our GRAND LODGE ; and at our last communication, our agent, in the person of Brother P. W. Archer, was appointed to solicit subscriptions and donations for this purpose ; and I presume, in the Report which he will submit, you will be informed of his success in this laudable enterprise ; the importance of which I doubt not is deeply felt by most of our Brethren present. Our worthy and esteemed Brother, L. L. Stephenson, was appointed Grand Lecturer of the State, at our last Grand Communication ; and clothed with authority to visit every working Lodge in the State, and illustrate the work in the three first degrees. For his success, in this important mission, I refer you to his Report on this branch of operations.

Being informed that Columbus Lodge, No. 102, Pittsborough, had adopted in its proceedings Resolutions concerning the action of this GRAND LODGE had in a case of no ordinary magnitude, and in which that Lodge was deeply involved, I immediately addressed a letter to the Master of Columbus Lodge (Bro. Hanks), demanding a copy of these Resolutions ; which demand was readily complied with ; and they are herewith submitted for your consideration and discussion, marked A.

I have also received information that Eagle Lodge, No. 71, at Hillsborough, has committed the same impropriety in their work for which Columbus Lodge was arraigned at our last Communication. This matter, I presume, will be brought before you in proper form, and in due time, for your investigation.

During the month of July last, the GRAND LODGE received, through the Grand Secretary, a donation of Eighty Dollars from Miss Elizabeth Davies, of Shrewsbury, England, which was accompanied with special instructions to place the amount in the Charity fund for the relief of distressed Masons and their families. I am ignorant of the true cause which prompted this lady to make

this donation ; but I am impressed with the belief that it must be a mutual donation, or interchange of favors which she, or some branch of her family, may have received from us in days gone by. Regardless of the motives which influenced her, you will doubtless take such action in the matter as you may conceive your duty.

I have learned, with regret, that another one of our distinguished brothers, RICHARD DOBBS SPAIGHT, late Past Grand Master of this State, has passed from among us to his reward in Heaven ; and you will no doubt make suitable demonstrations touching this melancholy event.

On the 14th instant, this GRAND LODGE sustained a loss in the death of Brother RICHARD W. ASHTON, who has filled the office of Grand Tyler to this Lodge so acceptably for some 20 years.— These are lessons of sadness to us all, and should teach us, that ere long we shall be called upon to follow them.

Before I close this communication to you, permit me, Brethren, to express to you my kindest and most grateful acknowledgments, for the honor and great indulgence which I have received at your hands—honor in calling me to this, the most responsible station in your gift ; indulgence in passing over the feeble efforts, which have been employed in discharge of my various duties. This closes the term of my eligibility to the station I now occupy, under your constitution. Though not eligible, I shall ever be found advocating the cause of Masonry, and aiding, in every way in my power, to protect and honor its principles.

Permit me now, brethren, to say, in conclusion, Be careful who are admitted into your order. Masonry, unlike other worldly societies, does not derive strength from its numbers ; but has strength in a few, if true and trusty. Let not, then, this feeling of anxiety to increase your numbers cause you to err. This is an error ; and, if not checked, may be a rock upon which Masonry may split, like other institutions.

Masonry never was intended to be extended to the world of mankind. It is always truest in a few hands, if they are faithful. I say, then, admit none but what you know to be worthy and true.

The duty of selecting one to succeed me to the office of Grand Master, will devolve upon you this evening. I trust you may be successful in selecting one that will have a lively sense of his obligation to the order, and one that will be active in spreading and protecting the great principles upon which it is founded.

Accept, each of you, my best wishes for your happiness in this and the world to come.

Bro. William P. Taylor then moved that a Committee of six be appointed on that part of the Grand Master's Communication referring to Columbus Lodge No. 102, Pittsboro' : and Brothers R. S. French, Daniel Coleman, John A. Lillington, John H. Drake,

John G. Bynum and E. G. Speight were appointed that committee.

Brother L. L. Stevenson, Grand Lecturer, transmitted the annexed Report :

To M. W. WILLIAM F. COLLINS, Grand Master of the GRAND LODGE of NORTH CAROLINA.

M. W. Sir and Brother : The Masonic year, for which I was elected and commissioned Grand Lecturer and instructor of the Lodges under the jurisdiction of the GRAND LODGE of North Carolina, is drawing to a close ; and it becomes my duty to render an account of my stewardship in the premises.

During the year, I have visited and given instruction to the following Lodges, viz :

Saint John's Lodge, No. 1, Wilmington ; Saint John's Lodge, No. 3, Newbern ; Phenix Lodge, No. 8, Fayetteville ; Johnston Caswell Lodge, No. 10, Warrenton ; Perseverance Lodge, No. 59, Plymouth ; Charity Lodge, No. 78, Windsor ; Morning Star Lodge, No. 85, Nashville ; Orr Lodge, No. 104, Washington ; Belmont Lodge, No. 108, Duplin County ; Saint Albans Lodge, No. 114, Lumberton ; and Tuscarora Lodge, No. 122, Oxford. Although most of those Lodges were very deficient in the work of the several degrees, and particularly the lectures appertaining thereto, yet, I found among the Brethren much zeal, and an ardent desire for instruction ; which, I flatter myself, none will say I have been backward in giving. It affords me pleasure to be enabled to say, that a portion of those Lodges have learned the work and lectures perfectly ; and others have been much improved.--- In my intercourse with the Brethren, I have, at all times, been treated with the utmost kindness and fraternal regard. I am sorry it has not been in my power to visit the four following Lodges, which have solicited my services, to wit : Eagle Lodge, No. 71, Hillsborough ; Skewarkee Lodge, No. 90, Williamston ; Mount Lebanon Lodge, No. 117, Wilson, Edgecombe County ; and Conoho Lodge, under Dispensation, Hamilton, Martin County. I shall give those Lodges my earliest attention, should it be the pleasure of the GRAND LODGE, to renew my appointment. It is a source of deep regret, that it is entirely out of my power to attend the communication of the GRAND LODGE: I had anticipated much delightful and intellectual communion with my brethren on that occasion ; but circumstances of an afflicting nature have rendered it impossible for me to be with you. It was my desire to have made a full exemplification of the work in open GRAND LODGE, that all who were present might be informed of its minutiae, and also the mode and manner of imparting it. It was also my intention to have given all the instruction that time would permit, to the brethren in attendance.

But we know not what a day may bring forth ; our most settled purposes are sometimes disappointed by an act of Providence, to which it is our duty to bow, with humble submission.

May the Supreme Architect of the Universe, guide and direct the brethren assembled in GRAND LODGE, in all their deliberations, and bring them to such wise conclusions as will redound to the interest of the craft and be to him acceptable.

The Grand Secretary submitted his Report ; which was adopted :

To the Most Worshipful GRAND LODGE of North Carolina :

By a Resolution adopted at your last Annual Communication, it was made the duty of the Grand Secretary to submit a statement of all transactions connected with this body, since that time ; and, in obedience with that resolution, he respectfully submits the annexed statement and expose of such proceedings :

Eight new Lodges were then chartered. Their names and location are—

Palestine, No. 120, Gold Hill ; Logan, 121, Jamestown ; Tuscarora, 122, Oxford ; Franklinton, 123, Franklin county ; Clinton, 124, Louisburg ; Sunbury, 126, Gatesville ; Johnston Caswell, 10, Warrenton.

The Most Worshipful Grand Master has, by dispensation, organized the following sixteen Subordinate Lodges ; which will, we presume, apply for charters, thereby securing for themselves a permanent existence :

1. Leaksville Lodge, Rockingham county ;
2. Dan River, do do
3. Fraternal, Sawyer's Store, do do
4. Pasquanaux, (Star in the East revived,) Elizabeth City ;
5. Stokes, Concord ;
6. Hank's, Franklinsville, Randolph county ;

8. Lafayette, Jacksonville, Onslow county ;
9. Clinton, (revived,) Yanceyville ;
10. Conoho, Hamilton ;
11. Blackmer, Zion, Montgomery county ;
12. Radianee, Snow Hill ;
13. Black Rock, Brunswick county ;
14. Allamance, Graham ;
15. Western Star, Rutherfordton ;
16. Catawba Valley, Morganton.

For dues and other sources of revenue, I have received the sum of \$797 75 ; which I have paid over to the Grand Treasurer ; in which is included the donation from England, referred to by the Grand Master in his Address just read.

I have in my hands the sum of \$17 77 ; which I have retained for postage purposes, but subject to the order and disposal of the Grand Lodge.

The amount due from Subordinate Lodges for the present year will probably vary from seven to eight hundred dollars ; and some few are indebted for past years ; but having received no returns from the last mentioned class for some years past, and not knowing whether they are at work or dissolved, their indebtedness to the Grand Lodge cannot be correctly ascertained.

All of which is respectfully submitted.

The Committee on the Grand Treasurer's and Grand Secretary's accounts presented the annexed Report ; which was read and adopted :

The Committee to whom was referred the accounts of the Grand Treasurer and Grand Secretary, together with their Reports, have diligently considered the same ; and, as the result of their investigations, most respectfully submit :

First, on Grand Secretary's Report and accounts.—We find that he has received, from the report submitted, the sum of seven hundred and ninety-seven dollars and seventy-five cents ; (\$797 75) ; for which he has produced the Grand Treasurer's receipt.

Second, on Grand Treasurer's Report and accounts.—We find that he has received the sum of seven hundred and ninety-seven dollars and seventy-five cents from the Grand Secretary ; the sum of sixteen dollars from the Raleigh Royal Arch Chapter and Hiram Lodge ; and balance on hand, as by Report of the Committee at the Annual Communication, December, 1849, the sum of three hundred and seventy-four dollars and ninety-five cents. Making, in the aggregate, the sum of eleven hundred and eighty-eight dollars and seventy cents. For which he has produced vouchers satisfactory to your Committee of four hundred and twenty-three dollars and sixty-seven cents. We have allowed commissions on seven hundred and ninety-seven dollars and seventy-five cents, at five per cent., being the usual commission heretofore allowed ; leaving a balance in his hands of seven hundred and twenty-five dollars and fifteen cents.

That this Grand Lodge have heard, with deep sensibility, of the death of this distinguished member of our Fraternity, who, at one time, presided over our deliberations. He belonged to one of those old families long identified with the history of North Carolina. His father and grandfather filled the office of Chief Magistrate of our State. He entered public life as a member of the House of Commons in 1819 ; and was a member of the Senate from 1825 to 1835, when he was elected Governor of the State ; being the last Governor elected by the Legislature under the old Constitution. In all the varied and responsible duties which de-

volved upon him, he was fully equal to his station, and was ever distinguished for his purity of life, and patriotic devotion to duty.

Therefore, *Resolved*, That in the death of the Hon. Richard Dobbs Spaight, of Craven, society has lost one of its most useful citizens; our State one of its most patriotic sons; and the Masonic Fraternity one of its "bright and shining lights."

Resolved, as a token of respect to his memory, the members of this Grand Lodge will wear the usual badge of mourning for thirty days.

WHEREAS, the location of the Masonic College is regarded by the Fraternity of North Carolina as a matter of great importance: And whereas, it is desirable that as great a number of the brethren as possible shall be present when the vote shall be taken, in order to give more satisfaction generally among the brethren through the State, and produce harmony and good feeling: And whereas, on a subject so interesting to Masons, a good deal of discussion must necessarily occur:

Therefore, *Resolved*, That the discussion shall cease at nine o'clock to-morrow evening, and that the vote be taken on the location of the said College.

Brother Pender presented the following resolution:

Resolved, That Brother P. W. Archer, agent to obtain subscriptions and donations for the contemplated Seminary of Learning, be requested to submit his report.

Whereupon Brother Archer submitted his report; which was referred to a Committee of seven brethren, whose names are as follows:

Reverend James Reid, C. H. Jordan, C. P. Mendenhall, R. S. French, Luke Blackmer, J. G. Bynum and T. Burr.

AGENT'S REPORT.

That, in pursuance of his duties, he has found the work involved with difficulties and hindrances, of which he previously had no conception. These, however, he is happy to assure you, do not arise from an indisposition upon the part of those who are properly instructed with reference to our object, to lend us their aid; for he has found the Craft almost universally where he has insisted upon a proper presentation of the subject, anxious to assist in this noble work. A large proportion of our Lodges are located in prominent country places, or small villages, and their member-

ship extends over a section of country from 10 to 30 miles.— Their communications are generally held upon occasions of some public assemblage, particularly during court weeks. At any other time it is almost impossible to obtain more than a very meagre attendance—so small indeed, as not to justify them in making any considerable appropriations. And again, the majority of the Lodges have the very proper law incorporated in their bye-laws, that no appropriation of their funds, other than a very inconsiderable amount, for purposes of immediate charity, shall be made at any but the regular meetings of the Lodges. As it has been impossible for the Agent to make his visits correspond with their regular communications, the best that he has been able to do has been, to present the subject as faithfully as he could, and leave the matter for their future action. What has been the action of these Lodges subsequently, he is not prepared to say ; and moreover the past year or two having been a time of unusual prosperity with the Craft in our State, they have in a great many instances, seized upon the opportunity as favorable for repairing their lodge buildings ; so that they have but an inconsiderable amount in their treasuries, or are actually considerably in debt. Not knowing that such a call of the Craft would be made upon their benevolence, they have failed to husband their means with reference to this object, and have expended them liberally upon such subjects as presented themselves. These difficulties and many others, he had considered, however, as of minor importance comparatively. The failure of the Grand Lodge to locate this College, has been to our project an insuperable barrier.

Your Agent has found great difficulty in persuading the Lodges if indeed he has succeeded in doing so ; that the Grand Lodge are in earnest in this work : whether, indeed, in the labours of their Agent they really purposed to do, or mean simply making an experiment to try the feasibility of, their plans. They have taken a correct view of the magnitude of this work, and with faint hearts and doubtful minds, have found themselves unwilling to believe that the herculean task had been actually begun. It is to be hoped that the present Grand Lodge will take such judicious action in the premises, as will settle the minds of the Craft in the State, that they propose to execute what they have so long desired ; and rest assured, brethren, you will be sustained in your action.— Whatever may be the diversity of opinions as to the eligibility of various places claiming its location, the plan of its organization, the practicability of the work, or whatever other feature in which it may be viewed, there is a striking unanimity, almost universal, of desire that it shall be accomplished. The hearts of the members of the fraternity are with this undertaking, and there is rarely to be met with a brother who will not feel proud to render assistance to bring it to its consummation. Divest this subject, as far as you may, of its uncertainties and perplexities, and permit the brethren to display their attachment by their liberality.

In accordance with the direction of the Grand Lodge, your Agent presented for sale scholarships in this Institution. He is fully impressed with the opinion, that this plan of raising funds will meet with the most sanguine expectations of its friends, when the Institution has been located and gives a fair promise of success. He effected the sale of seven scholarships at \$100; but the plan received so little patronage, owing to the circumstances by which we were surrounded, that he deemed it advisable not to close the matter with these seven; and, consequently, did not give out any certificates. Franklinton, Franklin County.—Franklinton Lodge, No. 123, proposes to give \$8,000—\$4,000 to be paid when the buildings are commenced ; the balance in four annual instalments—and a site for its location.

Warrenton, N. C.—Johnson Caswell Lodge, No. 10, proposes to give \$10,000, in five annual instalments, and forty acres of land in the vicinity of Warrenton.

Oxford, Granville County.—Tuscarora Lodge, No. 122, proposes to give \$8,500, and ten acres of land for the site—the money to be paid in five annual instalments.

Germanton Lodge, No. 116, proposes to give \$3,000 cash, and a building worth \$4,000.

Greensboro'.—Greensboro' Lodge proposes to give the buildings, library and furniture of the Institution lately known as the Caldwell Institute, to be conveyed to the Trustees of the Masonic Seminary, to be by them held so long as they shall use it for a Seminary of Learning.

The following resolution was introduced by Bro. James Banks, and adopted :

Whereas, the committee appointed to examine the unsettled account between this and Phoenix Lodge, No. 8, have failed to report ; and it is but right and proper the account should be adjusted : And whereas, it appears that Phoenix Lodge has paid up all her annual dues, and paid into the Treasury twenty dollars in 1846, under the capitation tax to pay a Lecturer, and the Lecturer never having visited said Lodge : And whereas, in 1846, this M. W. Grand Lodge passed a resolution declaring that all monies thus paid should be refunded :

Therefore, it is *Resolved*, That twenty dollars be refunded to Phoenix Lodge, No. 8, and the receipt of the Representative taken for the same.

Bro. P. W. Archer presented the following resolution ; which was adopted :

Resolved, That, upon balloting upon a petition, the applicant is ballotted for to be a Master Mason : It is however proper, if a brother shall desire it, to demand a second ballot upon his application for passing and raising. Upon application of Fellowship, No. 84, to restore John Pool to the rights and benefits of Masonry, from which he had been expelled about six years ago, by Joseph Warren Lodge, No. 92, it appearing to the satisfaction of the Grand Lodge that Fellowship acted by and with the consent and approbation of Joseph Warren Lodge, No. 92 ; and the Grand Lodge being fully certified of the entire reformation of the applicant : It was unanimously Ordered, that Bro. John Pool be, and he is hereby, restored to all the rights and benefits of Masonry.

The Committee on Propositions and Grievances made their report ; which was adopted :

To the M. W. Grand Lodge of North Carolina, now in session :

The Committee on Propositions and Grievances, to whom were referred the following resolutions of inquiry from Saint John's Lodge, No. 1, Wilmington :—1st. Whether an individual can be kept back from the degrees of Masonry, after having taken one degree, upon evidence of improper conduct prior to initiation? 2d. Or whether he has the right to demand an investigation? And 3d. Whether a brother has a right, after an applicant is admitted by one ballot to the degrees, to demand another or separate ballot upon "passing" and "raising"?—Beg leave to Report, that the first and last of said inquiries are answered in the affirmative, and the second in the negative, "*but by Committee out of Lodge.*"

The same Committee, to whom was referred the case of the expulsion of W. S. Hartson, by the vote of Saint John's Lodge, No. 1, Wilmington, charged with "unmasonic conduct," have performed the duty of examining into the said order and report, and recommend the confirmation of said order by the said Lodge.

Bro. W. F. S. Alston submitted the following resolution :

Resolved, That the Committee upon that portion of the Grand Master's communication referring to Columbus Lodge, 102, be discharged ; and that portion be now brought before this Grand Lodge.

Bro. J. R. Herndon introduced the following resolution ; which was adopted :

Resolved, That no censure of the Grand Lodge of North Carolina is conveyed in the resolutions passed by Columbus Lodge, No. 102, Pittsboro'.

Bro. Blackmer's report on the donation from England was read and adopted, and the committee discharged :

To the Most Worshipful Grand Master and Brethren of the Grand Lodge of North Carolina :

Your committee, appointed to take into consideration so much of the Grand Master's Address as relates to the voluntary donation of \$80, from Miss Elizabeth Davies, of England, would respectfully report : That we have been unable to ascertain any facts relating thereto, in addition to those stated by the Grand Master in his Address ; but, feeling assured that the members of this Grand Lodge entertain the liveliest feelings of gratitude for this voluntary act of kindness, coming from one so far removed from us, we would offer the following resolution :

Resolved, That the thanks of the Most Worshipful Grand Lodge of North Carolina are hereby tendered to Miss Elizabeth Davies, of England, for her voluntary contribution of \$80 ; and that the Grand Master be requested to furnish this resolution of thanks to her, with assurances that her kind act of liberality towards us will induce us to be more active in our deeds of charity and labors of love.

The Grand Master appointed Bros. Archer, Pender, Alston, R. P. Taylor and H. J. Macon the Committee on Claims.

Bros. John W. Cosby, James Banks and P. W. Archer were appointed a committee to investigate the case of Eagle Lodge, No. 71, Hillsboro'.

Bro. Joseph Green submitted the following resolution ; which was referred to the Committee on Claims :

Resolved, That this Grand Lodge refund to St. John's Lodge, No. 110, the sum of seventeen dollars ; it being the amount overpaid by said lodge in the way of dues, through a mistake as to the number of members.

Bro. William J. Clarke submitted the following Report ; which was adopted :

To the Most Worshipful Grand Lodge of North Carolina :

The Committee to whom were assigned the duty of preparing a digest of all the Resolutions and regulations of the Grand Lodge now in force, having performed that duty, respectfully Report, that they have examined the proceedings of this Grand Lodge, (with the exception of those for two years, which they were unable to obtain,) and that the following appear to be the most important, to wit :

Resolution adopted 21st December, A. L. 5809.—*Resolved*, That the Grand Master be requested to direct the Grand Secretary

to lay before him all the communications received during the recess of the Grand Lodge, in due time, previous to the Annual communication of this Grand Lodge, so that the Grand Master may lay before this Grand Lodge such abstracts therefrom as he may deem proper for their consideration.

Resolution passed December, 18. A. L. 5823.—*Resolved*, That all Masons under the jurisdiction of the Grand Lodge, shall henceforth, at funeral solemnities, appear dressed in the badges which are peculiar to their Masonic rank.

Resolution adopted December, A. L. 5828.—*Resolved*, That when an applicant for initiation is rejected in any subordinate lodge, it shall be the duty of such lodge, to inform all the other lodges in the State of the same; and it shall be deemed irregular in any lodge to receive a candidate who resides nearer any other lodge.

Resolution adopted January A. L. 5829.—*Resolved*, That it is the sense of this Grand Lodge, that no subordinate Lodge, can try a Master on any charge brought against him during his continuance in office, he being only amenable to the Grand Lodge of the State.

Resolution adopted A. L. 5829.—Amendment to the Constitution of the Grand Lodge.—*Resolved*, That whenever any complaint shall be made to the Grand Master against the Master of any subordinate Lodge for any unmasonic conduct, by a Master Mason, it shall be his duty to appoint a committee of discreet and worthy Master Masons, who shall examine and enquire into the truth of the charges made, after giving the Master so charged notice of the time and place of the investigation, who shall report to the Grand Master the proceedings and result of such investigation; and if they shall report that the charges are true, the Grand Master shall forward the report to a neighboring Lodge, which shall be authorized to proceed to pass such sentence upon said Master as is just and proper, and conformable to the usages of Masonry.

The above was proposed to be amended as follows.—*Resolved*, That on complaint being made to the M. W. Grand Master, against the Master of a Subordinate Lodge, for unmasonic conduct, the Grand Master may order the said Master to be tried by the members of his Lodge, and shall appoint a Brother of skill and prudence to preside at the trial, who shall exercise all the powers of Master of said Lodge until the former Master shall be reinstated, or a new one regularly appointed.

Resolved further, That in case the Master be convicted of the charges preferred against him, he shall stand suspended until the regular communication of the Grand Lodge.

The resolutions and amendments were ordered to lie on the table.

Resolution adopted December A. L. 5833.—*Resolved*, That all subordinate Lodges in this State, now in arrears to the Grand

Lodge, be and they are hereby required to have the same adjusted by or at the next Annual communication ; and if any subordinate Lodge shall fail to comply with this resolution, it shall be the duty of the Grand Secretary to give such Lodge, through their Secretary, three months notice, to appear by their legal representative or representatives, at the annual communication of the Grand Lodge of North Carolina, to be held for the year 1835, to show cause why the charter, jewels and property of such Lodge, shall not be forfeited to the Grand Lodge ; and, if such Lodge shall fail to appear, by representative or representatives, at the time aforesaid, the charter, jewels and property thereof shall be held and deemed to be forfeited.

Resolution adopted December, A. L. 5835.—*Resolved*, That the subordinate Lodges, to this Grand Lodge, be and they hereby, are required, to pay to the Treasurer of the Grand Lodge, the sum of ten dollars as their annual dues from and after this communication: *Resolved*, That all subordinate Lodges in this State, now in arrears to the Grand Lodge, be and they are hereby required to have the same adjusted by or at the next annual communication (1836,) and on failure &c. as in above resolution of (1833.)

Resolved, That the Grand Lodge feel it a duty, which they owe to themselves, as well as to the whole Masonic Fraternity, to declare, that while its individual members are left to the free unmolested enjoyment of their sentiments, upon the various subjects connected with religion and politics, and the right to judge of men and their actions ; they hereby, most solemnly declare, that Masonic bodies have not the right to connect the Institution with the Sectarian or party views of either ; that any attempt thereat, is a gross innovation upon those principles, which among good and correct Masons, are universally acknowledged, and should be practised upon. *Resolved*, That the Grand Lodge, do at this time, as they have hitherto done, declare to the world, that the object of their association and motives for continuing therein are founded upon the principles of Brotherly Love, Relief and Truth. They disclaim the right of Masons to inflict corporal punishments, and acknowledge no other right to enforce obedience from its members than reprimand, suspension and expulsion.

Resolution adopted December, A. L. 5836—suspends the operation of the Resolutions of '34 and '35 in relation to dues of subordinate Lodges until 25th December, 1837:

Adopted December, A. L. 5837.—WHEREAS various errors and informalities have crept into the ceremonies of many of the subordinate Lodges of this State, thereby creating material discrepancies in the mode of working in different Lodges, which ought not to exist.—*Be it therefore Resolved*, That the Grand Master appoint one or more special Grand Lecturers, whose duty it shall be, to visit the several subordinate Lodges of this State, and es-

establish a more uniform mode of working in the same, according to the ancient customs and usages of Free Masons.

And be it further Resolved, That the several Grand Lecturers, be required to call on all such subordinate Lodges as are in arrears to the Grand Lodge, for a settlement of their accounts; and they are hereby authorized, to settle and receipt for the same, and they shall account with the Grand Secretary for all monies so received.

And be it further Resolved, That each of the said special Grand Lecturers shall receive for his services, while employed in visiting the Subordinate lodges, a compensation of three dollars per day, over and above his necessary expenses.

Therefore be it Resolved by this Grand Lodge, that all Subordinate lodges, which have been delinquent for two years, and which shall on application, fail to settle with the Special Grand Lecturer to be appointed, shall be required by him, in the name of the Grand Lodge to surrender their charter, jewels and property.

Resolved, That from and after this time, the price of Dispensation, granted by this Grand Lodge, or by the Grand Master be five dollars, and that the price of a Charter be ten dollars, and that the same be received by the Grand Secretary when he delivers over the Dispensation or Charter.

Resolved further, That the Grand Secretary be entitled to retain out of the monies received for every Dispensation or charter hereafter granted by this Grand Lodge or by the Grand Master, one dollar, as his fee for filling up and making out the form; and that he pay the balance over to the Grand Treasurer of the Grand Lodge.

Resolved further, That the price of a Diploma granted by this Grand Lodge, or by the officers thereof, shall be five dollars; and that the same shall accrue to, and be a part of the perquisites of, the Grand Secretary.

Resolved further, That the Grand Secretary have dispensations, charters and diplomas printed from time to time, as they may be needed, and that the cost of the same be paid out of the funds of the Grand Lodge.

Resolution adopted December, 5838.—*Resolved*, That, from and after the first day of March next, the fees for the Entered Apprentice degree shall be six dollars; for the Fellow Craft's, four dollars; and for the Master's degree, ten dollars; which shall be the fees to be paid to the Subordinate lodges under the jurisdiction of this Grand Lodge, exclusive of the Tyler's fees.

Resolved, That the Subordinate lodges under the jurisdiction of this Grand Lodge be divided into seven districts, corresponding with the Judicial districts of this State; and that there be appointed annually, by the Grand Master, with the concurrence of the Grand Lodge, one Grand Lecturer for each of said districts, who shall reside in the district for which he is appointed.

Resolved, That the said Grand Lecturer shall at least once

in every year, attend the Subordinate lodges in his district, and lecture the same.

Resolved, That as a compensation for the services of said Grand Lecturers, they shall each receive the sum of ten dollars for each and every Subordinate lodge they may visit and lecture, to be paid by the said Subordinate lodge.

Resolved, That the said Grand Lecturers, shall attend the meetings of the Grand Lodge, and in the recess of said meetings, shall lecture on the first three degrees in Masonry.

Resolved, That it shall be the duty of the several Grand Lecturers, to call upon the several Subordinate lodges in their districts to settle up their dues remaining unpaid to the Grand Lodge; and that they are hereby authorized to settle and receipt for the same, which they shall pay over to the Grand Secretary by or before the next annual communication of the Grand Lodge.

Resolution adopted December 5839.—*Resolved*, That from and after the adjournment of this Grand Lodge, it shall be discretionary with the several Subordinate lodges in this State, to establish any ratio of fees they may think proper, for conferring the several Degrees of Entered Apprentice, Fellow Craft, and Master Mason; provided the same shall not be less than the rate fixed by the Grand Lodge at its last annual communication.

Resolution adopted December, 5840.—*Resolved*, That the Grand Secretary be directed to get together copies of the Proceedings of the Grand Lodge, for as many years as he can collect; and that he have them stitched together in three volumes, with a copy of the constitution in each volume; and that the same shall be preserved by the Grand Secretary for the use of the Grand Lodge.

Resolved, That it shall, from this time forth, be the duty of the Grand Treasurer, at each annual communication of the Grand Lodge, to file with the Grand Secretary a statement of the amount of monies and other funds of the Grand Lodge in his hands,—which statement the Grand Secretary shall file among his papers, and preserve for the use of the Grand Lodge.

Resolution adopted December, 5844.—*Resolved*, That, from and after this communication, there shall, annually, be appointed a Committee, consisting of two members, whose duty it shall be to examine the Records of the Grand Lodge, and see that its proceedings have been faithfully recorded.

Resolved, That the M. W. Grand Master be requested to appoint a general Grand Lecturer, suitably qualified for the station, whose duty it shall be to attend the Grand Lodge when in session; to perfect himself in the Lectures, as recommended by the National Convention; to co-operate with the other Grand Lecturers, and to visit any Subordinate lodge requiring his services, provided such lodge afford him reasonable compensation.

Resolution adopted December 5846.—*Resolved*, That a belief in the authenticity of the Holy Scriptures, is essential to the faithful fulfilment of the duties required by the order of Masonry in all

Christian countries, and that a denial of the same is in conflict with the principles of our Institution, calling for reprobation.

2. That this Grand Lodge approves of the proposition to establish a General Grand Lodge, and invites the co-operation of her sister Grand Lodges, by the appointment of Delegates to meet in convention for the purpose of reporting a constitution for the government of the General Grand Lodge.

Resolved, That from and after this Grand Communication the Subordinate lodges shall pay into the Grand Treasury as an annual stipend, the sum of fifteen dollars : Provided that no lodge be required to pay more than one dollar for each of its members.

Resolution adopted December, 5847.—*Resolved*, That hereafter no individual shall act as proxy for more than one lodge at the same time in the sessions of this Grand Lodge, (amended 1848 and extended to three lodges.)

Resolved, That hereafter the Committee on Foreign communications and proceedings of Grand Lodges be required to make their report at the meeting of the Grand Lodge next succeeding their appointment.

Resolutions relative to a Seminary of Learning.

Resolutions ratifying constitution of Supreme Grand Lodge omitted, as a majority of Grand Lodges did not concur.

Resolution adopted 5848. *Resolved*, That from and after this communication, the dues from Subordinate lodges shall not, under any circumstances, be remitted.

Resolutions passed 5849.—*Resolved*, That Brother L. L. Stephenson's work be received as the work of the Craft in this State, and that the Subordinate Lodges conform thereto.

Resolved, That hereafter, the election of the Grand Officers, shall take place on the second night of each annual communication.

Resolved, That the Grand Lecturer be ex officio a member of this Grand Lodge, and that he be authorized to call together the Subordinate lodges in the name of the Grand Lodge, at their respective lodges, and work and lecture them.

Resolved, That the M. W. Grand Master be authorised to supply any vacancy which may occur by resignation or otherwise, in the office of Grand Lecturer or College Agent.

Resolved, That the 2d section of the 8th article of the consti-

tution be amended so as to read as follows : "In the adoption of this constitution, and all amendments hereafter made, and in the election of officers, *and on all other matters in the Grand Lodge, (when demanded,)* the votes shall be taken according to the rights of the several lodges ; and the members of the Grand Lodge, that is to say, every lodge present by its Representation, shall be entitled to three votes, whether represented by one or more brethren ; and every member of the Grand Lodge, otherwise entitled than by being a representative of a particular lodge, shall have one vote ; provided that this shall in no wise affect any rights of the Past Grand officers. In cases of a tie, the Brother in the Chair shall have the casting vote."

Resolved, That the old section be printed.

Bro. Daniel Coleman's resolution was read and adopted :

Resolved, That the Most Worshipful Grand Master appoint one or more Agents, as he may deem advisable, to visit the Subordinate lodges, members of the fraternity, and other persons who may be disposed to aid in the erection and endowment of the contemplated Masonic College, to solicit subscriptions, receive donations, sell scholarships, and to carry out any scheme that may be adopted by the Grand Lodge to raise the means necessary to put said College into successful operation.

Bro. Luke Blackmer presented the following resolution ; which was adopted :

Resolved, That this Grand Lodge appropriate \$100 to the erection of the Washington monument ; and that the Grand Master be requested to forward the same to the Monumental Committee.

Bro. Elias Blount presented the following resolution ; which was adopted :

Resolved, That the resolution adopted at the last Communication of this Grand Lodge, that requires the election of the Grand Officers on the second night of each Annual Communication, be and the same is hereby repealed.

Bro. G. W. Norwood appointed Bro. Robert Peach his proxy for Wake Forest Lodge, No. 97.

Bro. N. T. Green appointed Bro. H. J. Macon his proxy for Sharon Lodge, No. 78.

Bro. Kallum was appointed proxy for Bro. D. W. Stubblefield.

Bro. N. F. Reid appointed Bro. William Closs his proxy.

Bro. T. O. McLanahan was appointed proxy for Wayne lodge, No. 112.

Bro. D. G. McRae, P. G. J. W. was appointed by Bro. James Banks his proxy for Phoenix lodge, No. 8.

The Grand Lodge called from labor to refreshment until tomorrow morning, ten o'clock.

Whereas, Johnston Caswell lodge, No. 10, and Saint John's lodge, No. 3, are desirous of changing their Bye-laws ; and whereas, those Bye-laws are such as to require a concurrence, or presence of two-thirds of all their members :

Be it therefore Resolved, That Johnston Caswell lodge, No. 10, and Saint John's lodge, No. 3, be permitted to alter or amend their said Bye-laws, without the aforesaid requisition.

Bro. James Reid, from the Committee of seven, submitted a Report ; which was laid upon the table.

The Committee to whom was referred the resolution of Bro. Heflin on the Masonic College, and the Agent's Report, beg leave to submit the following Resolutions, namely :

Whereas the Grand Lodge, at this Communication, has fixed upon the site for the location of their contemplated College at or near the town of Oxford, in Granville county :

Therefore, *Resolved*, 1. That the Committee on Incorporation be instructed to procure an act of incorporation from the Legislature of North Carolina, enabling her, through her Trustees, to acquire title to the site presented near the town of Oxford ; which Board of Trustees shall not be more than sixty, nor less than twenty. Seven members shall be a quorum for the transaction of business.

2. *Resolved*, That, in the event of a failure to obtain the act of incorporation, as aforesaid, R. W. Lassiter, Dr. J. R. Herndon, R. T. Taylor, W. W. Young and J. T. Littlejohn are appointed agents to acquire title to the aforesaid lands and premises, for and in the name of the Grand Lodge of North Carolina, for the purpose of erecting a Masonic College thereon.

3. *Resolved*, That the following names be, and they are hereby to be inserted in the act of incorporation as Trustees for the Grand Lodge of the State of North Carolina, namely : R. W. Lassiter, R. T. Taylor, J. R. Herndon, J. Bullock, J. T. Littlejohn, N. E. Canaday, J. C. Taylor, W. W. Young, G. M. Baskerville, C. H. Jordan, J. Whiaker, P. Berry, Z. M. Paschall, A. T. Jenkins, J. A. Taylor, E. L. Winslow, J. H. Wheeler, T. E. Pender, C. P. Mendenhall, W. H. Haywood, P. H. Winston, Jr. P. W. Archery, W. P. Taylor, P. F. Clements, R. S. French, Daniel Coleman, K. Rayner, J. G. Bynum, Dr. Macon, S. Wadkins, and M. A. Outten ; who are by this act of the G. Lodge of North Carolina, elected to the office of Trustees of the Masonic College.

4. *Resolved*, That so soon as twenty-five thousand dollars can be secured by subscription, the Agents or Trustees, as before named, or a quorum of the Trustees or Agents so named, shall proceed to make contracts for the erection of the buildings of the said Masonic College, under such limitations and instructions as this G. Lodge may think proper to give said Trustees or Agents for their

direct government, in all acquirements of property or transfer of the same, in the name of the Grand Lodge of the State of North Carolina.

5. *Resolved*, That, in the opinion of your Committee, your contemplated College cannot be considered safe, and capable of taking her stand with other institutions of the day, with a less sum than fifty thousand dollars : and to effect this object it is recommended that an active Agent or Agents be immediately selected and sent to the several Subordinate lodges, to solicit subscriptions for buildings and endowments, on the same terms as were prescribed by the last Communication of the Grand Lodge of this State in her agency for the Masonic College.

Your Committee have given to the Agent's Report that consideration which its importance demands, and recommend its adoption, and the approval of the course he pursued in behalf of our contemplated College.

All of which is most respectfully submitted to this Grand Lodge.

On motion Ordered, that the Committee to whom was referred the case of Eagle Lodge, No. 71, Hillsborough, be discharged.

Bro. H. J. Macon, was appointed the Trustee of Johnston Caswell Lodge, No. 10, for the Masonic College.

Bro. R. E. Troy, for Saint Alban's Lodge, No. 114.

The annexed resolution submitted by Brother Moore, was read and adopted :

Resolved, That we rescind so much of the resolution of last Grand Lodge, relating to the sale of scholarships, as restricts the Agent to a particular number in the jurisdiction of Subordinate lodges, and that the agent be given discretionary power in that respect.

* The oldest Masonic establishment in the United States was the *Saint John's* Grand Lodge of Boston, which was organized July 30, 1738 : and in 1792 a Grand Masonic Union was formed by the two Grand Lodges, and all distinction between ancient and modern Masons abolished in that State.

† The Grand Lodge of Vermont continued to work regularly

in the Masonic vineyard, until January, 1836, when Masonry virtually ceased work in that State. By regular and authorised adjournments, however, that Grand Body was kept alive until January 14, 1846, when it was convened by the Grand Master, and is at this time in a flourishing condition.

THE GRAND LODGE OF NORTH CAROLINA was first constituted by virtue of a Charter from the Grand Lodge of Scotland, bearing date January 14, 1771, which has been carefully preserved, and occupies a conspicuous place in Masonic Hall. It convened occasionally in Newbern and Edenton, at which latter place the Records were deposited previous to the Revolutionary War. During that sanguinary contest, the Records were destroyed by the British army, and its meetings were, in consequence of this disaster, suspended.

In the year 1787, the members of the Craft convened in Hillsboro' and compiled certain regulations for the government of the Grand Lodge, and again commenced labor.

In December of the year 1797, a Committee was appointed to form a Constitution for their future government; which duty was faithfully performed: and the said constitution was formally adopted and ratified in the City of Raleigh, where the Grand Lodge has continued to hold its meetings annually.

A C A R D .

A connection of thirty years with the Masonic Fraternity has, under all circumstances, engendered a deep and lively interest for its welfare and prosperity; and having during that period, cherished a zealous desire to promote and advance its cause, by such means as I might find in my reach and control; will, I hope, be a sufficient apology for this intrusion upon the attention of my brethren, in submitting, for their consideration, the plan or project I have had in contemplation for some time past.

The Grand Lodges in the Union, the Canadas, and California, with their Secretaries, and the date of their organization :

The officers and members of Subordinate Lodges, with the retired Master Masons under their jurisdiction :

The form of a petition for Initiations, Passing and Raising :

The charges in the three first degrees ; and any other matter which might be deemed useful and beneficial to the Craft.

The Secretaries of Lodges are respectfully requested to submit this plan or project to their respective Bodies, procure subscribers, and forward their names, with the officers, members and retired Master Masons, by the first of August next, at which time I wish to place the manuscript in the hands of the printer.

It is believed that a work of this kind is much wanted ; and to me, it will always be a source of great pleasure and gratification, if this effort to promote the cause and diffuse the principles of Masonry, shall meet with the desired success.

The book will probably cost from 40 to 50 cents per copy.
