To the Most Worshipful Grand Master and other Grand Officers and Members of the Grand Lodge of North Carolina.

Brethren,—Whereas, the committee to whom was referred the petition of Brother James Wilson, having investigated the same, beg leave to report, That they are satisfied the petitioner is the same person whom it appears, from public advertisement, was robbed while in the city of New York of the sum of five thousand seven hundred dollars; and that he is now in pursuit of the thief, and destitute of the means necessary to enable him to prosecute his progress. Your committee is satisfied that Brother Wilson has a family at this time in the city of New York laboring under pressing privations, in consequence of the loss before enumerated, and, from the most satisfactory recommendations, that he is a man of the strictest honor and integrity; they therefore recommend to this Grand Lodge, the adoption of the following resolutions, viz:

Resolved, That the Grand Treasurer be hereby authorised and directed to advance, as a donation to Brother James Wilson, the sum of fifty dollars,

out of any monies in the Treasury not otherwise appropriated.

Resolved, That the Grand Lodge do recommend our Brother James Wilson, to the particular attention of all Lodges and Brethren, and earnestly solicit their assistance in enabling him to recover his property and detecting the thief; and further, that he be presented with a copy of these resolutions and the report annexed thereto, signed by the Grand Officers, and attested by the Grand Secretary.

Brethren,—The committee to whom was referred the proceedings of King Solomon Lodge, No. 18, Jones county, beg leave to report, That they have examined the proceedings of said Lodge, and highly approve the same, believing they were actuated from truly Masonic principles; and that the result thereof has been the cause of healing many dissentions that existed among the brotherhood composing said Lodge; they therefore recommend the adoption of the following resolution:

Resolved, That this Grand Lodge do accept of the Charter of King Solomon Lodge, No. 18, Jones county, North Carolina, and that the funds and Jewels at present in the possession of Zion Lodge, in said county, at this time working under dispensation, be, and the same are hereby granted and acknowledged to be the property of the Master, Wardens, and brethren of Zion Lodge aforesaid, this Grand Lodge waiving all their right, title or interest in the same, being satisfied that the surrender of the original Charter of King Solomon Lodge, No.18, was solely for the purpose of cementing brotherly love and friendship

The committee appointed to examine the several communications received since the last Grand Annual Communication,

submitted the following report:

The committee, to which was referred the foreign correspondence received by the Grand lodge since the last annual communication, respectfully report, That, having carefully examined the mass of papers referred to them, your committee find but little to which they deem it necessary to direct the attention of this Grand Lodge. In the communications received from foreign Lodges, they remark, with pleasure, the growth and spread

of the principles of our order, and the flourishing situation of the Grand Lodges in the United States, the great similarity of views, as regards the grand masonic edifice, which the correspondence exhibits as existing among the different Grand Lodge in this Union, shews conclusively the beneficial effects which must be realised in completing this moral superstructure.

The attention of your committee has been called to the resolutions of the Grand Lodge of New Hampshire, upon the propriety of erecting a Monument at Mount Vernon over the remains, and to the memory of our late distinguished Brother George Washington. Although the funds of the Grand Lodge will not justify your committee, in recommending a sum commensurate with the import nce of the subject proposed, yet, so fully impressed are your committee with the deep interest which every American, more especially every member of the Fraternity, must feel in the accomplishment of the measure, that we feel no hesitation in recommending the adoption of the following resolutions, to wit:

Resolved, that the Grand Lodge of North Carolina most heartily coincide in opinion with the Grand Lodge of New Hampshire, as to the propriety of erecting a Monument at the Grave of Washington at Mount Vernon, by

the Masonic Fraternity.

Resolved, That the sum of five hundred dollars be appropriated for that purpose from the funds of the Grand Lodge of North Carolina, whenever a sufficient sum shall be appropriated by the Grand Lodges of other states, or by voluntary contributions of the Masonic Fraternity, and specific ar-

rangements shall have been made for the erection of the same.

Resolved further, That the M. W. Grand Master, S. G. Warden and G. Secretary be appointed and authorised to sell the stock owned by the Grand Lodge in the State Bank, at a price not less than par, so as to apply the proceeds t ereof to the purposes of the foregoing resolution, in case the G. Treasurer shall advise them that it is necessary; and the said Brethren shall be a committee of correspondence on this subject, and be the proper persons to control the above appropriation.

Resolved, That the said committee be, and they are hereby authorised to call upon the late Master, Wardens and other officers of said Lodge, for all the Jewels, Books, Papers, Furniture, and

other property belonging to said Lodge.

Resolved, That the said committee, after an investigation and settlement of the said accounts, be, and they are hereby authorised to deliver over to the Master, Wardens and other officers of Eastern Lodge, now established in Elizabeth City, all the jewels, furniture, money and other property that shall belong and be due to Camden Lodge.

Resolved, That the said committee consist of Brethren John C. Ehringhause, Isaac N. Lamb and Wilson B. Webster; and that they make a full report of their proceedings at the next annual

meeting of this Grand Lodge.

Resolved, That the Grand Secretary furnish to Brother John C. Ehringhause a copy of the foregoing resolutions under the Great Seal of this Lodge.

Bro. William H. Haywood, jr. who was appointed at the last annual communication of the Grand Lodge to enquire into the loss of Candlesticks and Swords by him purchased for the Grand Lodge, and to recover the amount of their value from those liable for the same, and, in the event of their not being restored, to

purchase others, Reported,

That soon after the adjournment of the Grand Lodge, he wrote on to his agent in Philadelphia, who made the necessary enquiry, and found that said articles had been left, by negligence or mistake in the Master of the vessel, who had given his bill of lading for them, in a warehouse at Philadelphia; and, on that account, their arrival here had been delayed. They were immediately found, however, and forwarded to this place, and are now in the use of the Lodge. He further reports, that the price of the Candlesticks was greater than was reported to the Lodge at the last annual communication. He has hereto attached an account of the whole expense attending it. All of which is respectfully submitted.

To the Most Worshipful Grand Master and other Grand Officers and Members of the Grand Lodge of North Carolina.
