A communication from Zerubabel Chapter, No. 11, was read and referred to the Committee on Grievances.

A communication from the Grand Secretary of the Grand Chapter of Maryland was read and referred to the Committee on Communications.

The proceedings of the several Grand Chapters received since the last annual convocation were referred to the Committee on Communications.

The Grand Secretary made the following report:

That pursuant to a resolution of the Grand Chapter, passed at the last annual Convocation, we notified the following Chapters, and that they have failed to make their returns, or assign any reason therefor:

M. E. Comp. Freeman, from the Committee on Communications, made the following report; which was concurred in, and the resolution therein contained adopted:

The Committee on Communications beg leave to report, that since the last annual Convocation proceedings of the Grand Chapters of the following States have been received, viz. Maine, Vermont, New Hampshire, Massachusetts, Connecticut. Maryland, Virginia, Georgia, Kentucky, and Alabama. Your committee find nothing in them which requires the particular attention of this Grand Chapter, except in the proceedings of the Grand Chapter of Kentucky upon the subject of dissolving the General Grand Royal Arch Chapter of the United States, and the proceedings of the Grand Chapter of Maryland, recommending the several Grand Chapters to take under their recognizance and control the degree of Select Master.

As regards the dissolution of the General Grand Chapter, an opinion has already been expressed by this Grand Chapter, at its fourth annual convocation at Tarborough, in the year 1826, which your committee

deem unnecessary to reiterate.

Your committee further report, that they are informed and believe, that there are several Councils of Select Masters in the State of North Carolina, working, as they allege, under authority granted by Comp. James Cushman, independent of Royal Arch Masonry, a Grand Council, or any general head. They are, therefore of the opinion that it is expedient that the degree be placed under the jurisdiction of the Grand Chapter; and, therefore, recommend the adoption of the following resolution:

Resolved, That the General Grand Chapter of the United States be requested to take the Select Master's degree under its jurisdiction, by an amendment of the Constitution, or otherwise, so as to authorize and compel the conferring the same as a degree immediately preceeding that of the Royal Arch.

All of which is respectfully submitted.

Comp. Nicholson, from the Committe on Grievances, made the following report, which was concurred in, and the resolutions therein contained adopted:

The Committee on Grievances, to whom was referred the present situation and conduct of Zerubabel Chapter, No. 11, Hertford, report, that they have had the same under consideration, and find that it is the unanimous desire of the members of said Chapter, as expressed by a resolution at their last convocation, to change the location thereof from Hertford, Perquimons county, to the town of Edenton, in the county of Chowan, alleging their inability to work at its present location, as but few of its members reside in or near the said town of Hertford. Your committee believe that; for the promotion and welfare of Royal Arch Masonry, the said Chapter should be removed accordingly.

Your committee further report, that in consequence of the difficulties which said Chapter has had to encounter, they are at present unable to discharge the debt of thirty dollars due this Grand Chapter. They therefore recommend for the relief of said Chapter the adoption of the follow-

ing resolutions:

Resolved. That Zerubabel Chapter. No 11, be removed from Hertford, Perquimons county, to the town of Edenton, in the county of Chowan.

Resolved, That a certificate of the foregoing resolution be endorsed on the Charter of said Chapter, under the hands of the grand officers, and the seal of this Grand Chapter.

Resolved further, That the said Chapter have time until the next an-

nual convocation to pay their dues.

Upon the subject of delinquent Chapters, your committee beg to be discharged, as the same has been taken under the consideration of the committee on returns of subordinate Chapters.

Your committee regret to see such gross neglect of the Constitution, Bye-Laws and Edicts of the Grand Chapter, as has been shewn by the subordinate Chapters herein reported as delinquent. Could they attend the annual convocations of the Grand Chapter only by their principal officers, or by proxies, n embers of their several Chapters, the plea of business or expense of traveling, so often urged by delinquent Chapters, might carry with it some weight; but when it is known that proxies can be readily obtained at the places where the Grand Chapter is held, disposed to attend to the instructions of their principals, this pretext is worse than silent neglect.

Your committee, unwilling to recommend extreme measures, and with a hope that the Chapters may yet return to that punctuality so desirable, for their welfare and the prosperity of Royal Arch Masonry. do

commend the adoption of the following resolution:

Resolved, That the delinquent Chapters herein mentioned. be allowed until the next annual convocation to make their returns and pay their dues. Respectfully submitted,

A communication from the High Priest of Mount Arrarat Chapter, No. 3, was read and referred to the committee on returns of subordinate Chapters.

The following preamble and resolution were submitted by Comp. Wiggins:

Whereas, it was resolved at a convocation of the Grand Chapter of North Carolina, held at Fayetteville on the 23rd June, A. D. 1827, that the subordinate Chapters under its jurisdiction should never exalt more or less than three persons at one and the same time, and all three of such persons should be real candidates for the degree or for healing, and neither of them a companion who has already taken the degree, except such as may require healing; and whereas the restriction contained therein retards the progress of masonry, and is unnecessary and inexpedient;

Therefore resolved, that the said resolution be; and the same is

hereby repealed.

On the question "shall the resolution be adopted?" The year and nays were called for: which call being sustained, it was decided in the affirmative.

Comp. Bozman, submitted the following preamble and resolutions:

Whereas, by the 16th article of the Constitution of this Grand Chapter, it is required that to call a convention for the purpose of altering the location thereof, two thirds of the subordinate Chapters shall concur; and whereas the welfare of Masonry requires that the Grand Chapter

should be located in some one town;

Be it therefore resolved. That the Grand Secretary address a circular to the several Chapters subordinate to this Grand Chapter, requesting them to announce to him on or before the 1st day of October next, whether they consent to, or desire a convention, to be held in Raleigh on the day of December next, to make such alterations and amendments to the Constitution of the Grand Chapter of North Carolina as they may deem necessary.

Resolved, That the Grand Secretary advertise in the newspapers published in Raleigh, the time of holding said convention, as soon as he is

informed that eight Chapters assent and agree thereto.

Resolved, That the Secretary of this Chapter be directed to transmit a copy of these proceedings to the next annual convocation of the Grand Royal Arch Chapter, with a request that they may be spread on the re-

cords of the said Grand Chapter.

Resolved, That the above resolutions be published in the North-Carolina Journal and Carolina Observer, that all companiors may take notice thereof, and govern themselves accordingly.

Your committee feel much gratified at the disposition manifested on behalf of some of the subordinate Chapters to comply with the requisitions of their Charters, and performed their duties to the Grand Chapter; but the large number of Chapters which, notwithstanding the repeated indulgence of this Grand Chapter, are still culpably negligent in the discharge of their sacred duties, is a subject deeply to be regretted and la-

mented by all those who have the prosperity of Royal Arch Masonry at heart. Your committee, under the full consideration of the protracted negligence of many of the Chapters, deem it of the utmost importance that some steps should be taken by the Grand Chapter to investigate, and, if possible, correct these abuses, which, of late, are so abundantly springing up; they, therefore, recommend the adoption of the following resolution:

Resolved, That the M. E. Grand High Priest be authorised and requested to appoint some person to visit all the Chapters which are in arrears to this Grand Chapter; to require immediate payment; and in case of refusal, to demand a surrender of their Charters; take into his possession the property of said Chapters, and hold the same subject to the further order of this Grand Chapter.

Maine, Massachusetts, Vermont, Ohio, Kentucky and Georgia, together with the Bye Laws of the Grand Chapter of Rhode Island and a list of the officers of the Grand Chapter of Tennessee. Your committee have taken these communications into their consideration, and do not find any thing in them that requires this Grand Chapter to express any other opinion than that which has already been expressed at previous convocations on the subject of dissolving the General Grand Chapter of the United States.

Your committee have noticed a resolution of the last annual Convocation. requesting the General Grand Chapter to take the Select Master's degree under their jurisdiction, so as to authorize and compel the conferring the same immediately preceding that of the Royal Arch; and your committee are of opinion, from all the information which they have been able to collect on the foregoing subject, that any further proceedings by this Grand Chapter is at the present time unnecessary and uncalled for, no communication having been received from the General

Grand Chapter on this subject.

The committee on Grievances have had under their consideration the report of M. E. Comp. Lloyd upon the situation of Mount Arrarat Chapter, and also a communication from the High Priest of said Chapter, and beg leave to recommend the adoption of the following resolution:

Resolved, That a committee of three be appointed by the Grand High Priest. to visit Mount Arrarat Chapter, and set them to work, if practicable; if not, to receive a surrender of their Charter, and take into possession the property of said Chapter.

Comps. E. B. Freeman, M. L. Wiggins and R. London are the committee.

Comp. Wiggins, from the select committee appointed to inquire into the expediency of appointing a Grand Lecturer, made the following report, which, together with the accompanying resolutions, was adopted:

The select committee, to whom was referred the resolution directing them to inquire into the expediency of appointing a Grand Lecturer, to visit the subordinate Chapters in this State, and establish an uniformity of working among them, have had the same under advisement, and beg leave to submit the following report: Your committee deem it of the utmost importance that an uniformity of working should be established in all the subordinate Chapters under the jurisdiction of this Grand Chapter. This can only be done by sending some competent person to visit the said Chapters, and instruct them to work in one and the same way. And your committee are further of opinion, that, from the present languid and inoperative state of some of the subordinate chapters, it is indispensably necessary that something should be done, or they must cease to exist. Your committee regret to say that they believe some of the Subordinate Chapters have not had a convocation or done any work since their charters were granted. Your committee, therefore, recommend the following resolutions for adoption:

Resolved, That the Grand Chapter deem it expedient to appoint a Grand Lecturer to visit the different subordinate Chapters, and establish one uniform mode of working in the same; that this Grand Chapter will pay the expenses incurred by the Grand Lecturer in travelling to and from the different subordinate Chapters he may be called on to visit, at the rate of \$5 for every thirty miles; and they will also allow him the

sum of \$5 for one day's sojourn at each Chapter he may visit.

Resolved, That the Grand Secretary be instructed to communicate with the officers of the subordinate Chapters, requesting them to state whether they will be willing to employ the Grand Lecturer should he visit them, and the sum they will be willing to pay him for his services; and that they communicate such information to the Grand Lecturer as soon as convenient.

The Grand Chapter proceeded to the election of a Grand Lecturer, and the M. E. Esek Arnold was duly elected.

Comp. Sawyer submitted the following preamble and resolutions, which were adopted:

Whereas, by the 16th article of the Constitution of this Grand Chapter, it is required that to call a convention for the purpose of altering the location thereof, two thirds of the subordinate Chapters shall coucur; and whereas the welfare of Masonry requires that the Grand Chapter should be located in some one town:

Be it therefore resolved. That the Grand Secretary address a circular to the several Chapters subordinate to this Grand Chapter. requesting them to announce to him on or before the 1st day of November next, whether they consent to, or desire a convention, to be held in Tarborough on the 23d day of June next, to make such alterations and amendments

to the Constitution of the Grand Chapter of North Carolina as they may

deem necessary.

Resolved, That the Grand Secretary advertise in the newspapers published in Raleigh, the time of holding said convention, as soon as he is informed that eight Chapters assent thereto.

Be it enacted by the General Assembly of the State of North Carolina, and it is hereby enacted by the authority of the same, That the officers and members which at present are, or hereafter may compose the Grand Royal Arch Chapter of North-Carolina, are hereby constituted and declared to be a body corporate and politic, by the name and style of the Grand Royal Arch Chapter of North-Carolina; and by that name shall have perpetual succession and a common seal, and may sue and be sued, plead and be impleaded, acquire and hold, alien and transfer property, and pass all such rules, regulations and by elaws as shall not be inconsistent with the constitution and laws of this State.

Read three times and ratified in General Assembly, this 10th day of January, 1829.



The above information is obtained from a statement in the "Free Press," a newspaper published in Tarboro' on June 25, 1830, and is all the information, that can be procured, relating to this convocation. The Proceedings of this convocation, it appears, were never published. The original Proceedings were at one time in the possession of the Grand Chapter, subsequent to its reorganization in 1847, but cannot now be found. It is probable that they were destroyed by fire in 1868.

This was the last convocation ever held by this Grand Chapter.
