The M. W. Grand Master submitted the following Communication, which was read, and, on motion of the Grand Secretary, it was disposed of in the usual manner :—

To the Most Worshipful Grand Lodge of North Carolina :

BRETHREN : The recurrence of the regular convocation of the Grand Lodge, after the termination of another year, is a special season for grateful remembrance and acknowledgment of the beneficence of God Almighty. That we have much to be thankful for, must be apparent to every unselfish heart. Let us then, before entering upon our labors,

return our gratitude to the Omnipotent Disposer of all good, for the abundant harvest that has rewarded the toil of the husbandman, for the health we have universally enjoyed, and for the prosperity and peace, with which our Order has been blessed.

That there are peculiarities in our Order, which expose it to the censure of the misanthrope and the sneers of the ignorant, cannot be denied: and, although, it has been assailed, and its patrons persecuted by the most violent and reckless enemies, within the last few years, it has revived and assumed a dignity, which has, to a great extent, protected it from the bitter shafts of the satirist, and the ill feeling of the censorious. The numerous illustrious names that have, from time immemorial, graced its annals, and the vast benefits it has conferred upon mankind, have given to it a rank, and placed it in a position so strong, that it is rare at present to have its claims questioned from any source worthy of notice.

It is particularly gratifying to me, to inform you of the happy and prosperous condition of the subordinate Lodges throughout the State. They are acquiring new value, and extending their benign influence to new participants every day. This year, hundreds have been gathered beneath our broad banner, and hundreds are still hastening to assist us in drying up the tears of the afflicted widow, in consoling and comforting the helpless orphan, in feeding and helping the poor who need succor.

I have had the pleasure of visiting in person, a number of the subordinate Lodges in the Eastern part of the State. I found them all working with brotherly love, union and affection, and engaged in works of charity and diffusive benevolence.

In conformity to the resolution of the last meeting of the Grand Lodge, I have remitted one hundred dollars to the R.-W. Grand Secretary of the M. W. Grand Lodge of California.

I empowered Brothers James H. Cherry and S. B. Smith, to receive the charter, jewels and other property of Davie Lodge, No. 39, Britton's Cross Roads, Bertie County.

Having been prevented by causes beyond my control, from visiting Unanimity Lodge, No. 54, at Edenton, (which has been so long dormant,) in accordance with the resolution of the Grand Lodge, I empowered Brothers H. B. Short, Robt. H. Smith and James H. Cherry, to take possession of the Charter, Jewels and furniture of said Lodge; but have heard nothing from them since their appointment in regard to the same.

Brother N. M. Roan kindly gave me the necessary information relative to Clinton Lodge, No. 107, Yanceyville, (Old Lodge,) which was destroyed by fire, in the year 1844. The Furniture, Jewels, Books, and Charter, were preserved, though somewhat damaged. The furniture, which was originally of little value, is now used in the New Lodge, at Yanceyville. The Books, with about \$60 solvent accounts unpaid, are still in that place. The Charter, I have requested to be forwarded to the Grand Secretary. The Jewels which were borrowed, have been returned.

I secured the services of our excellent Brother, Whitmel J. Hill, in acting as Agent of the Grand Lodge, in the settlement with Brother Thomas D. Laurence, who, in 1848, acted as Agent of the Grand Lodge, in the sale of the property &c., of Scotland Neck Lodge, No. 68. He remitted me one hundred and sixty-two dollars, and forty-two cents, which I forwarded to the Grand Secretary. He also remitted the Grand Secretary some notes, the property of the Grand Lodge, to which the Grand Secretary will refer in his report.

As I was informed that Franklin Lodge, No. 94, Currituck County, had been extinct for several years, I wrote Brother Joshua Tayloe, requesting information in regard to it,—upon which he forwarded me the Jewels of said Lodge; the Charter could not be found. I have placed the Jewels in the hands of the Grand Secretary.

In regard to King Solomon's Lodge, No. 56, Jackson, Northampton County, I have failed in getting any information upon which I could act.

Brother William T. Bain, the Grand Secretary, will in his report, inform the Grand Lodge, of the number of Dispensations granted during the present year.

I take great pleasure in bringing to your notice, the important aid rendered me by our excellent Brother, C. P. Mendenhall, Deputy Grand Master, who has visited many of the Lodges in the Western part of the State.

Our worthy Grand Lecturer, Brother L. L. Stevenson, has been laboring with his accustomed zeal and industry, in different parts of the State, to the benefit and advancement of our Order.

The Centennial Anniversary of Washington's entrance into the mysteries of Masonry, was celebrated throughout the State. The day passed off, we trust, to the interest and satisfaction of all. Our citizens of all denominations united to do homage to the memory of the illustrious dead: May that day be forever remembered by every Mason, and may we all strive to imitate the example of that good, great and pure Mason, and endeavor by virtue, union, love, to make our society a fit and perpetual monument to his memory and worth.

I have received a Circular Letter from M. W. B. B. French, Grand Master of the District of Columbia, with preamble and resolutions annexed, which were passed at a meeting of the Free and Accepted Masons of Virginia and District of Columbia, held at the Tomb of Washington, on the 4th of November last, requesting aid in establishing an association to be known as the Washington, Mount Vernon, Masonic, Orphans' Association. I commend this subject to your consideration, in the conviction, that its importance will insure your careful attention and prompt action.

During the year, the Masonic Fraternity of the United States has sustained an irreparable loss. Another of its profoundest and brightest intellects sleeps in death. Past Grand Master, Henry Clay, of Kentucky, has been called from his labors in this world, to the Celestial Lodge; where peace, purity and happiness, must reign forever.

I regret to have to inform you, that the appeal made by me, in behalf of the College, to the Masonic Fraternity, in this State, agreeably to the resolution of the Grand Lodge, did not have the effect desired and contemplated; therefore, I did not deem it essential, to constitute Agents in other States. We are indebted to Brother Samuel J. Person, for five dollars, which is the only amount I have received. The W. Masters of the subordinate Lodges will no doubt make known to the Grand Lodge, their success in its behalf. In reverting to this subject once more, I must say, that I am still under the profound conviction, that a Masonic College, organized in the best manner, and conducted on pure principles, must be of the very highest value to the Masonic Fraternity of the State. The establishment of such an Institution would be the greatest legacy, that we could transmit to our posterity, as it would open to the children of the poor, as well as the rich, every avenue to success, distinction and, above all, to usefulness, in the career of life. It would prove a lasting and proud monument to the wisdom and forethought of its founders, and would secure the gratitude of thousands yet unborn, for the blessings of education, and the opportunity of distinction and renown. We commend this College again to our Brethren, throughout the State, with the sincere hope, that they will take hold of it, with all the earnestness that its importance inspires, and will respond in such a manner, to the call in behalf of this great enterprise, as may encourage us, and do honor to the Fraternity.

Formal complaint having been made against the W. Master of Mt. Moriah Lodge, No. 82, by several members of said Lodge, I was constrained to suspend him, and request him to appear before the Grand Lodge, and answer the charges preferred.

I cannot avoid recurring in connection with this subject, to the necessity which exists of selecting Officers, that are *temperate, zealous, capable, and of good repute*. If intemperance is allowed to creep into our Lodges, and remain unnoticed, Masonry will become peculiarly polluted by it. All

excess is incompatible with our profession, and those principles which should be inculcated by us, and which should distinguish us from the world. Just in proportion to the elevated rank of an inconsistent Mason, so will be the mischief he creates. A private Mason, whose life is intemperate and corrupt, does an incalculable injury to the cause of Masonry : but an officer who does not live above vice and intemperance, is a curse to our Order, as he retards its advancement, and tramples its holy precepts under his feet. As moderation should beautify and adorn our Temple, the household of the Temple should utter the voice of condemnation, against all excess, for the indulgence of a depraved propensity, whether found in high or low places. The lessons which Masonry inculcates, and the principles which it establishes, are lessons and principles confirmed by the experience of centuries, and consecrated by the sanction of inspired patrons, and of the most eminent sages of ancient and modern times. We owe it, then, to the mighty and illustrious dead—to our great and illustrious preceptors, that we guard them against desecration, and keep them as things sacred—confided to our care, to be preserved with virtue, honor, and affection. Is it not a legacy, rich and valuable, and worthy to be handed down in all its original purity, to succeeding generations ? To you, especially, my *young* Brethren, will the future look for the preservation and fulfilment of that sacred trust, so soon to be committed to your charge. Soon, very soon, the places which we now occupy, will be imposed on you ; in a few fleeting years, our joys and afflictions will be terminated. Allow me, then, with the affection of a Brother, and with deep solicitude for your welfare, to impress upon your minds, the importance of self denial. It is not only of the utmost importance to you as Masons, but will be to you, as Christians, as citizens, and as patriots, and is of vital importance to the Masonic Order, and *unless we practice it, our claims to the character and privileges of Masons are invalid*. Do not understand me to mean, by self denial, that we are to undergo useless hardships, and deny ourselves the comforts

of this life, but to persist in opposition to our constitutional desires, appetites and wishes of corrupt nature. Let us, then, live temperately, orderly and morally, and as we have opportunity, let us do good unto *all men*, especially unto them, who are of the household of faith : and above all, let us “practice out of the Lodge, those duties which are taught in it ; and by amiable, discreet and virtuous conduct, to convince mankind of the goodness of the Institution ; so that when any one is said to be a member of it, the world may know that he is one to whom the burthened heart may pour out its sorrows : to whom distress may prefer its suit : whose hand is guided by justice, and his heart expanded by benevolence.”

In conclusion, Brethren, permit me to return you my heartfelt thanks for the confidence reposed in me, by calling me the second time, to preside over your deliberations. It excites my warmest gratitude : and regarding it in connection with the repeated manifestations of favor extended to me, by my Brethren, from the Atlantic to the Mountains, my mind is oppressed by a consciousness of obligations, which I am but too inadequate to discharge. I was fully conscious of my inability to equal your partial expectations, or satisfy my own wishes, when called to this chair, but I trust, I have not been, nor ever will be, backward in manifesting a proper zeal for the welfare, dignity and honor of our beloved Institution.

The Grand Secretary submitted his Report, which was read and adopted.

To the M. W. Grand Lodge of North Carolina :

In obedience with a standing Resolution, I now respectfully submit this Report, which embraces the several transactions connected with my department, since your last annual communication.

It was made my duty to notify Royal White Hart Lodge, No. 2, Halifax, to appear by representation, at this meeting

of your Body, and show cause why her Charter should not be taken away from her.

In the month of February last, I addressed a letter to Bros. C. N. Webb, and F. S. Marshall, who were formerly officers of that Lodge, requesting them to inform me whether it continues to exist, or has ceased to work ; but having received no answer to my communication, I am unable to give the Grand Lodge any information relative to its present position ; but from the fact of its failing to make returns since 1850, it may reasonably be supposed, it has ceased to work, and to perform the duties of a regular organized Lodge.

It was also made my duty to collect, and have bound, as many of the Proceedings of the Grand Lodge, for past years, as could be procured, to have framed certain Engravings, which were donations to the Grand Lodge, and to have Charters printed on parchment, for the use of the Grand Lodge.

These duties have been performed. The Proceedings, Engravings and Charters, are at hand for the inspection of the Grand Lodge.

During the year, I have received and paid over to Bro. Richard P. Taylor, the Treasurer of the Board of Trustees, the annexed sums, for the use and benefit of Saint John's College :—

Through Bro. Whitmel J. Hill, I have received a parcel of notes due the late Scotland Neck Lodge, to the amount of \$83,91, which are at the disposal of the Grand Lodge.

The Representatives in their seats.

The Committee on the Grand Secretary's Books and accounts, made the following Report ; which was adopted :

RALEIGH, December 6, 1852.

The Committee, to whom was referred the Books and accounts of the Grand Secretary, at the last annual communication, have investigated the same, and respectfully submit the following Report :—

First, we have stated an account herewith, filed and marked "A." which shews that the Grand Secretary received during the last Session of the Grand Lodge, (as reported by a Committee raised for that purpose,) the sum of \$903.00, and that he has since received from different sources, the sum

of \$372.42, making the sum of \$1.275.42, for which he has produced the receipts of the Grand Treasurer.

Your Committee, in the further discharge of their duty, have prepared a statement herewith, filed and marked "B." shewing the amount due from each subordinate Lodge to the Grand Lodge. The aggregate amount is \$1.490, in which amount is included, *sums* due from *three* subordinate Lodges, which your Committee believe have ceased to work, viz : Davie Lodge, No. 39, Britton's Cross Roads, Bertie County, \$85 ; Unanimity Lodge. No. 54, Edenton, \$110 ; King Solomon Lodge, No. 56, Jackson, Northampton County, \$100—making the sum of \$295, which is not reliable, and when deducted, leaves a reliable fund, now due the Grand Lodge, of \$1.195.00 only.

Your Committee would further remark, that the Grand Secretary's Books are kept in a plain, legible manner.

Bro. W. G. Hill, from the Committee on the Grand Master's Address, submitted the following Report, which was adopted :—

To the M. W. Grand Lodge of North Carolina :—

The Committee on Foreign Correspondence and Miscellaneous Subjects made their report, which was read; and, on motion, it was postponed until to-morrow morning, at 10 o'clock.

The Report on Foreign Correspondence was called up ; when it was referred back to the committee, with a request that they report, at the earliest moment, to this communication.

The annexed Report was submitted by Bro. W. G. Hill, and adopted :—

To the M. W. Grand Lodge of North Carolina :

The Committee appointed at the last communication of the Grand Lodge, to report a form for the Installation of the Grand Master, would most respectfully present the following : which necessarily contains an article of the constitution of the Grand Lodge. The remainder is taken from the Trestle-Board, by Bro. Charles W. Moore of Boston.

Address to the Grand Master at the Installation.

" I am desired, Most Worshipful, to install you into your high office as Grand Master of Masons. Do you promise, upon the honor of a Mason, that, in the office of Grand Master, you will, according to the best of your abilities, strictly comply with the laws and regulations of this Grand Lodge, and other ancient Masonic usages ?

Give me leave to invest you with the badge of your office. This will silently admonish you always to do justice to the cause of Masonry ;—to consult, as the exalted rank you now hold demands of you, its real interests.

It will instruct you to infuse into the many Lodges, of which you are now the head, the true spirit of the order. It will direct you to make wise regulations for the good government of the Fraternity ; to give due commendation

to the worthy members of it ; and to rebuke those who act contrary to its laws.

I next deliver to you the emblem of that power with which you are now invested. Always make use of it for the good of our benevolent institution.

To you are committed, also, those Sacred Writings in which are to be found the sublime parts of our Ancient Mystery. In them are, likewise, inculcated the social and moral duties, without which no man can be a Mason. You will direct your Lodges to read, study, and obey them.

Receive the tools of Operative Masonry, which are, to each of us, the most expressive symbols. These will assist you, Most Worshipful, to reduce all matter into proper form ; to bring to due subjection irregular passions ; and to circumscribe them by harmony, order, and duty.

And lastly, I present you the Book of Constitutions, in which are contained the rules and orders made for the good government of the Society : and the charges which show its nature, its wisdom, and its utility. With this book, Most Worshipful, you will direct your Lodges to make themselves well acquainted—a work, in all its parts, worthy the attention of men, the most enlightened and judicious.

You are now, Most Worshipful, at the head of an Order which is calculated to unite men by true friendship, to extend benevolence, and to promote virtue. And give me leave to say, that the honor with which you are now invested is not unworthy of a man of the highest rank, or most distinguished abilities. Permit me, also, to remind you, that your faithful attention to the duties of your office, and acceptable discharge of them, will render you of great benefit to one of the most liberal institutions upon earth."

May you do honor to your exalted station, and long enjoy the highest respect and best wishes of all the Fraternity.

As regards Wilson Lodge, the committee are sorry to say, they have reason to believe they have violated the above law, by admitting into their Lodge members whose residence is nearer other Lodges ; but the evidence before them being from hearsay, entirely, they do not deem it sufficient to warrant them in enforcing the penalty.

as the time will soon arrive for the election of officers in the subordinate Lodges, they are of opinion that Mount Moriah Lodge can then displace her Worshipful Master, and try him for the misconduct complained of; and that he stand suspended until their election takes place.

The Committee on Expulsions and Suspensions submitted their Report; which was adopted:—

The Committee on Expulsions and Suspensions beg leave to report, that they have examined the case of R. C. Cameron, expelled from Conoho Lodge, No. 131, and would recommend that the judgment of that lodge be confirmed.

They have also examined the case of Thomas S. Poore, expelled from Golden Fleece Lodge, No. 74, and would recommend that the judgment of that lodge be confirmed.

They have also examined the cases of E. R. Crabtree and Robert Smith, who were suspended by Tuscarora Lodge, No. 122, and recommend that the judgment of that lodge be confirmed.

They have also examined the cases of Bros. Anderson and McMillan, who were expelled from Phoenix Lodge, and recommend that the judgment of that lodge be confirmed.

They have also examined the proceedings in the case of Henry Burn, suspended from Wayne Lodge, No. 112, for three months, and approve of the action of said Lodge.

They have also examined the case of Bryan Jones, expelled from St. John's Lodge, No. 3, Newbern, and recommend that the judgment of that lodge be confirmed.

The case of Stephenson Page, expelled from Joseph Warren Lodge, No. 92, in the year 1848—which case was before a committee of your honorable body, and for want of the necessary facts that committee was unable to report—has come up before your committee, with all the facts; and, upon ex-

amination of the case, your committee are of opinion that the action of Joseph Warren Lodge in the case was illegal, there being no officer of the lodge present. Your committee would therefore recommend that Stephenson Page be restored.

The case of Thomas Norwood, expelled from Columbus Lodge, No. 102, has been examined by your committee; and they would recommend that the judgment of that lodge be confirmed.

The case of John Pitt, from Morning Star Lodge, No. 85, we are unable to investigate, from the absence of the proceedings in the case; and your committee beg that the papers be returned to Morning Star Lodge, with instructions that they send up the proceedings in the case to the next communication of this Grand Lodge.

The committee beg leave farther to report, that they have examined the petition of Wm. N. Shauck, and the proceedings of Hiram Lodge, from which he was expelled; which expulsion was confirmed by this Grand Body.

They are of opinion that all the proceedings in the case were regular, and the sentence just; but, if he has so reformed that the members of Hiram Lodge wish him re-instated, as set forth in the petition, your committee would recommend that this Grand Body give them the privilege so to do.

Resolved, That the Committee on Foreign Correspondence furnish the Grand Secretary with a copy of their Report at least one week before the meeting of each Annual Grand Communication.

Resolved, further, That the Grand Secretary furnish said committee with all matter, so soon as it comes to hand ; and that he have 400 copies of the Annual Report printed, for the use of the members and delegates.

The Committee on that part of the Grand Master's Communication relative to St. John's College, made the following Report ; which was adopted :—

The Committee to whom was referred that portion of the Most Worshipful Grand Master's Address relating to Saint John's College, have had the same under consideration, and ask leave to report:

In regard to the establishment of said College, we regret that there has not been more done, during the past year, for the advancement of the object of this Grand Lodge. However, we have no just cause of complaint in this interesting labor of love.

We, as members of the Grand Lodge of North Carolina, masonically feel the moral responsibilities of standing to, and abiding by, our oft-repeated declarations of the ability of the fraternity to establish a College, worthy of our venerable order in this State.

Whatever may be the fears and misapprehensions awakened up in the minds of some, we are inclined to think that their opinion does not arise so much from an indisposition on the part of the craft to do their duty, as from the want of light. When we look at the magnitude of this work, our hearts faint not. Doubtful minds have viewed it as a Herculean task ; but a continued, persevering effort must finally crown your labor with success. Do you not propose to execute what you have so long desired ? The craft will sustain your

action. Are not the hearts of the fraternity with you in this undertaking? Give them a continued opportunity to display their liberality. They will come up, year after year, until success shall have crowned your undertaking. We believe that, by a concentrated and constant action, this great enterprise can be accomplished. The streams of benevolence, directed by the sublime maxims of Masonry, we trust have not been dried up. Shall we, as Masons, live and die, leaving no traces of our existence to our successors? Not so—we have a nucleus now presented around which we can call up all our energies; and, every heart burning with celestial ardor, we are determined to rear the monument for intellectual and moral culture. We have decided unanimously, with promptitude and decision, to build up the contemplated institution. The Grand Lodge has herself fixed on the site—she has asked the State to grant her a charter—the Legislature has granted her request—and your Trustees have purchased the site for the buildings, and will proceed, at the earliest moment, to make contracts for the buildings necessary to carry out all your wishes in the establishment of said College. They will, as far as possible, avoid the fearful responsibility of extending contracts beyond the ability of the fraternity to discharge.

Under a proper system of management, your most brilliant hopes can be realized. Do not disappoint us—we have confidence. May the attributes of truth and justice harmonise and beautify all our works, by infusing the spirit of Masonry into the hearts of her children.

At the fetters that the phantoms of terror would throw around the timid and distrustful spirits, do'nt be alarmed, brethren. Every other order has its schools, except that of Free Masons. Shall this crying evil hang around us longer? Let every Mason say No—by a liberal contribution to Saint John's College.

Your committee would recommend the passage of the following resolutions :—

1. That the Board of Trustees of St. John's College be, and they are hereby, required to make an Annual Report of all their acts and doings to this Grand Lodge.

2. That the President and Treasurer of St. John's College be requested, and are hereby required, to attend the Annual Communications of this Grand Lodge.

Resolved, That this Grand Lodge request the Most Worshipful Grand Master to appoint two Grand Lecturers of this State, one of them to be located in the Western part of the State.

The Report of the Committee on Foreign Correspondence was again called up, and the same was adopted :—

To the M. W. Grand Lodge of North Carolina :

The Committee to whom were assigned the duty of examining the Correspondence of the Grand Lodges with this Most Worshipful Grand Lodge, during the year 1851, respectfully Report, that they have carefully read the large mass of documents furnished them by our worthy Grand Secretary ; and, while they have derived pleasure and instruction from the performance of this duty, still, from their inexperience in labors of this kind, and ignorance of Masonic usage and jurisprudence, they are painfully aware of their inability to meet the reasonable expectations of this Grand Lodge, by furnishing a Report showing the true condition of Masonry in our populous and widely extended country ; of pointing out examples worthy of imitation, and noting errors to be censured and avoided.

As the annals of history are most meagre in periods of peace and quiet, so, when the lodges are working orderly and harmoniously, the labors of a Committee of Foreign Correspondence are greatly abridged.

The correspondence of no former period shows a more flourishing condition of the craft. In every quarter, the sound of the gavel is heard, summoning zealous and well-instructed craftsmen, under the superintendence of proficient overseers, to labor in rebuilding the walls of our Zion, and in beautifying and adorning her holy places ; while thousands of good men and true stand at the outer gate, seeking admission into our ancient and honorable fraternity.

Save in our sister jurisdiction of New York, the peaceful "murmurings of Siloa's brook, which flows fast by the oracle of God," are undisturbed by the angry roar of the strifeful waters of Meribah. We regret that our brethren of the Empire State are still annoyed by the factious opposition of the "*soi disant*" Grand Lodge over which Isaac Phillips presides ; and we heartily concur in the opinion heretofore expressed by this Grand Lodge, declining intercourse with that illegal association ; and we feel that every true Mason should adopt the words of the Patriarch, "O my soul, come not thou into their secret ; unto their assembly, mine honor, be not thou united."

Our Masonic edifice spans a Continent, and the base of its massive pillars is washed by the waves of two mighty oceans. There is a Grand Lodge in every State in the Union, and we are in fraternal correspondence with them all.

We have read with pleasure the proceedings of the Grand Lodge of CALIFORNIA ; and are rejoiced to see that, on the distant outposts of civilization, where the restraints of society are almost unknown, Masonry, in accordance with her Heavenly mission, assembles her children and inculcates her lessons of peace and brotherly love ; and that our brethren who have passed the "Golden Gate," are actively engaged in giving aid and comfort to the destitute and friendless ; drying the tears of the orphan, causing the sorrowful heart of the widow to rejoice, and holding the chalice of consolation to the fevered lips of misfortune.

God speed our true-hearted brethren !—we hail them with pride. May the glorious light of Heaven beautify their days, and the gentle dews of Hermon refresh their nights.

There are 13 working Lodges in her jurisdiction ; but we regret the absence of the returns of the number of members. We know not their number ; but, with the zealous Joab, we exclaim, May the Lord our God add to them, how many soever they be, an hundred fold !

Some of the Reports of Foreign Correspondence speak of the existence of several Lodges in OREGON, working under charters from various Grand Lodges.

IOWA and WISCONSIN have each about thirty prosperous Lodges.

At the meeting of the Grand Lodge of TEXAS, held at Henderson in January, 1851, there were sixty Lodges represented. We observe that a proposition to tax unaffiliated Masons was rejected. The Grand Lecturer, who seems to have labored with fervency and zeal in his extensive field of service, reports, that the number of Lodges is rapidly increasing, and that “ the Lodges of Texas work as well as any in the South, or any where else ;” that the subordinate Lodges do not neglect the education of the orphans of deceased brethren ; that interest hitherto unknown is now manifested by the craft, and they are zealously engaged in promoting the interests of the Fraternity, and seeking the true light ; and that the march of Masonry is “ onward and upward”—every threatening cloud dispersed, and the bright sunshine of prosperity shining upon the order.

Those who have been accustomed to regard Texas as a land where vice stalks abroad, unabashed, at noonday, will be surprised to learn that Matagorda Lodge, No. 7, expelled “ a large ugly man for drunkenness, and rowdying and brawling about the doggeries ;” and that the by-laws of many of her Lodges rank intoxication, profane swearing and gambling as gross unmasonic offences. It will not be the fault of

the Masons of Texas if her sons are not distinguished for purity of heart and rectitude of conduct.

The Report of the Committee of Foreign Correspondence is long and able ; and we quote from it the following extract from the Address of the Most Worshipful Grand Master of the Grand Lodge of Illinois, which seemed to us to be so proper and suitable that we adopt it, and present it for your consideration ; as the evil complained of is one which has engaged the serious attention of numbers of our Lodges :—

“ I most respectfully invite your attention to the subject of Masonic Demits. It is the prevalent usage of Lodges to grant a demit to any brother desiring one, who is clear of charges and clear of the books, even though the brother demitting has no intention to remove from the jurisdiction of the Lodge, or to become attached thereby to another Lodge. This usage is eminently wrong, in my opinion, and detrimental to the prosperity and good of the fraternity. This practice greatly encourages and augments the number of non-affiliated Masons—a race of Masons perfectly inexplicable to me, and who occupy a most unnatural and unprofitable position in the order. From its being known, as it frequently is, that these non-affiliated brethren were formerly *attached* members, their present position conveys to the non-initiated world the erroneous idea, that they discovered in the institution principles repulsive to their feelings, and usages and customs incompatible with their opinions of right and propriety. And yet this cannot be the case,—‘ Masonry to be known is to be admired ;’ and can never be otherwise than popular and pleasing to the enlightened and the good.

“ I hold the opinion, that no honest and good Mason, at heart, will desire to live non-affiliated, unless impelled so to do by some extraordinary and imperative cause beyond his control—a cause which, in the course of human events, does not often exist. Many demits are asked for and obtained, during moments of temporary excitement, most frequently produced by imaginary wrongs ; and which, if allowed to subside by the wear of a little time, would be forgotten and forgiven.

“When demits are thus impulsively obtained, a false pride too frequently prevents a re-affiliation. There are men, no doubt, who join our order with the positive hope and expectation of finding the ‘PHILOSOPHER’S STONE.’ They expect to become invested with supernatural knowledge, or with necromantic power. Nothing short of becoming wizards, or of being continually excited by a complicated machinery or mummerly equal to the false, but bewitchingly mystical, worship of olden times, when oracles and gods were almost as numerous as the stars of our present firmament, could satisfy the rapacious marvelousness of such beings; and, upon not being thus gratified, they demit.

“Benevolence should indicate the duty of keeping such men within the protection of our embrace. They unquestionably need some guardian to guide and direct their steps, and to restrain their desires within due and reasonable bounds.

“Some, no doubt, request and obtain demits, impelled by motives of parsimony and penuriousness alone, to avoid the payment of the small dues exacted by the Lodges. It is natural that such should withdraw. No *soulless* man can be a Mason.

“Others demit from feelings of absolute *inertia*, and nothing else;—they are too lazy to do their duty. Scarcely a Lodge within this jurisdiction can be found, which has not, within its immediate vicinage, a number of these backsliders and unfruitful half-brothers—a band who hang upon the skirts of the army, deriving, in times of danger, its positive protection—and this, too, without adding an atom to its strength, or a beam to its glory.

“I most earnestly commend the careful consideration of this subject to your wisdom and decision. Some plan should unquestionably be adopted to stay this evil, and, if possible, to remedy the inconvenience and wrong inflicted upon the order. Difficulties will present themselves in the accomplishment of this task; but I think they will be only such as may be easily overcome, or properly provided for. In your

deliberations upon this subject, your justice will doubtless suggest the propriety of making provision for superannuated and diseased masons, and such as live too remote from Lodges to be able to attend."

We are happy in being able to state, that harmony is again restored in our sister State of LOUISIANA. Notwithstanding she has been dragged as a malefactor to the Courts of Law, at one time, and at another tempted to decorate her temple with gaudy tinsel, flashed before her eyes by the Samaritans of the thirty-third degree of the Scottish Rite,—still, we hope that she will bear in mind that "Masonry is Masonry, and nothing else;" and that she will strictly observe the ancient land marks.

The pamphlet containing the proceeding of the Grand Lodge of FLORIDA is a valuable addition to our Masonic Library. The Lodges of that State are in a very flourishing condition; and the Report of the Committee of Foreign Correspondence is able and interesting, and affords gratifying assurance that, under the watchful care of brethren so well rooted and grounded in the faith, she will never materially deviate from the old ways.

The proceedings of the Grand Lodge of VIRGINIA show, that the controversy with the Grand Orient of France, respecting the establishment of a French Lodge in that State by the latter body, has been honorably and amicably adjusted, by the recall of the charter granted to the lodge complained of. We do not regret the occurrence, as it gave occasion to the display of a magnanimity which will be a useful example to point to in future time.

A similar difficulty exists between the Grand Lodges of New York and Hamburgh, respecting Pythagoras Lodge—which surrendered the charter under which she had been working, received from the Grand Lodge of New York, and applied for and received one from the Grand Lodge of Hamburgh. We admire the moderate course of the Grand Lodge of New York, and the firm stand which she took in the case;

and hope that the Grand Lodge of Hamburg will reconsider the matter, and be no longer found trespassing on a sister jurisdiction.

The Most Worshipful Grand Master of the Grand Lodge of CONNECTICUT, in his Address, holds the following language respecting the *Admission of New Members* :—

“ We cannot be too often nor too forcibly reminded of our solemn duty in the all-important matter of admitting new members into our time honored institution. The qualifications of a candidate for the honors of Masonry should be of a positive nature. It is insufficient that nothing of a vicious character is known respecting a candidate ; the question should be, Is he truly a virtuous man—one who fears God and works righteousness ? Nor should an individual, whose moral character is defective, be admitted, under the hope that he may thereby be made better. If we would that the Masonic temple should endure, able to bear the buffetings of the storm, and the shock of the tempest, we must take heed that the materials which are to compose it be not only hewn and squared, but likewise sound to the very heart’s core.

“ Let the honors of Masonry be conferred only on those thus carefully selected, and our institution will be as enduring as the everlasting hills. How impressive and emphatic the language of the good old charge :—“ A Mason is obliged, by his tenure, to obey the moral law ; and, if he rightly understands the Art, he will never be a stupid Atheist, nor an irreligious Libertine.”

We fully concur in the above remarks, and would earnestly impress upon every Mason in North Carolina the importance of jealously scanning and scrutinizing the character of every applicant, being fully convinced that a prudent use of the black ball is of vital importance to the honor and prosperity of our beloved institution.

The Committee on Foreign Correspondence of KENTUCKY remark as follows, respecting *Physical Disqualification of Candidates* :—

“ This subject has, of late, excited much attention, and some warm discussion in some of the Grand Lodges. Those who contended for the right to disregard the ancient law, which declares we shall receive “ no man who is not upright in body, not deformed or dismembered at the time of making, but of hale and entire limbs as a man ought to be,” contended that this regulation was originally instituted to prevent the Lodges from taking in those who were not able of body to perform manual labor, and to guard against receiving those who might become a burden to the society ; and that, inasmuch as Masonry is now speculative only, a different rule will answer the ends of the institution, it being only necessary that the candidate shall be able to make a reasonable living, and be capable of learning the art of Masonry.

“ Your committee are not prepared to say what were the motives or ends intended to be accomplished by those who may have originally instituted this law ; any more than they are able to say why God required of old that none should enter the priesthood who were not without spot or blemish. We only know that we find this law laid down as one of the ancient landmarks, and we know of no vested power authorising its removal. If it is competent for a Grand Lodge to remove this, and make a new rule, then has the Grand Lodge the same power to remove any other ; and it were idle to censure the Grand Lodge of England for striking out the word “ born,” and inserting the word “ man ;” so that liberated slaves might be received.

“ But suppose it were in the power of Grand Lodges to remove this ancient landmark, to what extent might it be modified in favor of the unfortunate candidate, without doing manifest injury to the institution ?

“ The Grand Lodge of Kentucky set a precedent, by making the Hon John Pope, who had lost an arm, near to the shoulder ; and the innovation has been improved upon, from time to time, until, recently, a Lodge in Mississippi made a blind man a Mason. If a man can be made a Mason, who has but one leg or foot, cannot one be made who has no leg

or foot? If a man can be made with but one hand, then can another be made who has no hand; for, as we understand Masonry, each hand and each foot has an office to perform in Masonry; and we cannot say what would be the kind of Masonry that could be taught without either or all these members. If a man can be made without sight, so can a man be made without hearing; in short, each and all the senses may be dispensed with—and yet, we would ask, what becomes of our ritual, if either of the senses is wanting? Your committee feel the force of an appeal to our sympathies in behalf of those who, by nature are deformed, or who, in the glorious battle-field, are maimed for life; and the laws of our institution point them out as claiming our warmest sympathies; but an ancient landmark may not be removed to fit any and every case that misfortune may give rise to. The laws of our country may deprive a man of property for which he has paid full value, honestly supposing the title acquired thereby was good—and it presents a case calling for our sympathies—and yet, it would not be wise or just to repeal that law; because all laws should seek to promote the greatest amount of good to the greatest number. 'There are, doubtless, many negroes in the Southern Islands, as well as elsewhere, who, though not born free, are now freemen of much merit and respectability; but this does not give the power to any man or set of men to make innovations into the body of Masonry.'

“The law requiring a man to be free-born, in order to be a Mason, must forever stand, or any and all ancient landmarks may be removed; and this must be equally true in reference to maimed men. The Grand Lodge of North Carolina says that a rule upon this subject is plain and simple. ‘If,’ say they, ‘an applicant is so far dismembered as to render him incapable of performing Lodge duties, of doing speculative Masonic labor, he, of course, could not be received.’ Well, we suppose the Grand Lodge of Kentucky thought the same; and that this could be done with one hand; and the lodge in Mississippi thought it could be done without sight,

But to return—the ancient landmark is staring us in the face : dare we remove it ?”

Your Committee are pleased to see our sister of Kentucky so frankly acknowledging her fault, and so nobly proclaiming the true doctrine.

We quote the following from the Report of the Committee on Foreign Correspondence of the Grand Lodge of Kentucky :—

“ Our attention has been called to the existence of a practice which has prevailed, to some extent, in the United States—that of receiving and acting upon the petitions for initiation, &c. of transient persons, not considered within the jurisdiction of either the Subordinate Lodge or the Grand Lodge under which it works. Most of the Grand Lodges, whose proceedings have been examined by us, are opposed to the exercise of that power : and, when we reflect on the importance to the craft, that the character of all applicants for initiation should be fully known ; that it has, universally, been considered so essential ; and on the facility with which men pass, from one part of our populous and large country, to another ; and the means of imposition which are so often practised,—your committee think that the lodge to whom such application is made owe it to themselves, to the craft in the State whence the applicant comes, as well as to the order generally, to abstain from entertaining, for a moment, such applications. Those who favor it assign as a reason, that a person travelling, or about to leave the United States, finding that a connection with the order may be of great service to him, applies to a lodge, wherever he may happen to be ; and, if this right is not exercised, a worthy member may be lost, and he may be put to some inconvenience, trouble, &c. in his travels. This whole argument is based on the assumption, that Masonry is intended to pander to the self-interest of man. Nothing is more foreign to its designs. The candidate is expressly required to say, at the outset, that his application is not made from selfish considerations,

or "mercenary motives;" but that it is because he has, "for a long time, entertained a *favorable* opinion of the order." Now, we would suggest that, if he had entertained this opinion for such a "*long time*," why had he not made his application at the place of his residence, where his character might undergo a full investigation, and the purity of his motives be judged of? Brethren who claim for their lodges the right, should reflect that, while they may be promoting their own interest by receiving the fees for such initiations, and run no risk themselves of injury in receiving an unworthy person who is transient, they are throwing out a member on the confidence of the Masonic world at large, without, in the nature of things, that knowledge of his character which our standards require;—and, if the person should prove unworthy, although that unworthiness should be proved many thousand miles from them, and they not be directly injured by it, yet Masonry at large receives a wound, and the cause, at the particular point where this unworthiness may be manifested, will receive an irreparable injury.

"The only way in which this Grand Lodge provides for the exercise of any such right, is under the 46th article of her constitution, which provides that "*Lodges under the jurisdiction of this Grand Lodge, situated on the borders of this Commonwealth, are authorised to receive members from other States, residing in their neighborhood: provided the Lodges so receiving them are the nearest to their places of residence.*" And the next section provides, that "*No candidate for initiation can be received in any Lodge out of the county where he resides, (if there is a regular Lodge in his county,) unless the candidate resides nearer the said Lodge, or obtains the unanimous recommendation of the Lodge within his county.*"

These provisions show, clearly, that this Grand Lodge adheres strictly to the old landmarks, which required a full examination into the character of an applicant; which, your

committee are satisfied, can only be done in the "*neighborhood*" in which he resides.

The subject of permitting candidates who have been duly ballotted for and received the first degree, to pass or be raised without having a new balloting for every degree, or of requiring, as some Grand Lodges do, a simple majority after the first balloting, has been brought to our notice by the proceedings of some lodges and the comments of others.-- We cannot better express to those who desire the action of this Grand Lodge, its sentiments on that subject, and subjects akin to it, than to extract the following from our constitutional rules :

" Art. 39. No petition for initiation, when once presented, can be withdrawn, but with the unanimous consent of the lodge to which it may have been presented.

" Art. 41. After a candidate is rejected by one lodge, he cannot knowingly be received by another, without the unanimous consent of the lodge which rejected him.

" Art. 42. To vote to advance a brother to any degree of Masonry should be as unanimous as the vote which admits him into the Lodge as a member.

" Art. 45. The general rule which governs the order in the admission of members is, that such admission is to be sanctioned by entire unanimity ; and so sacred and fundamental does the Grand Lodge conceive this rule to be, that it is competent for a minority, or any member of the lodge, prior to the performance of the final ceremony of initiation, to prevent the admission of the candidate."

A practice which has heretofore prevailed in Kentucky, of publishing the names of rejected candidates, is very severely commented upon by some of the Grand Lodges ; and we notice the practice has been abandoned by most of the Grand Lodges. Your committee, in view of all the guards against imposition, which are in the hands of the order, and which, in the hands of judicious committees of inquiry, are fully ad-

equate to prevent imposition ; in view of the fact that the Grand Lodge, in numerous instances every year, at the solicitation of its members, suppresses the publication of names of individuals who have been rejected ; and in view of the fact that such publications are calculated to injure many good and worthy men who have sought connection with the order, but which they have been refused by a single individual, and for causes known only to him, and which the order have no right to make him divulge ; we cannot but recommend a discontinuance of the practice, and have reported a resolution to effect that object. A man by seeking a connexion with our order, pays us the highest compliment ; and to publish and expose our rejection of him, is like the course pursued by weak and foolish coquettes, who parade and expose the names of their rejected lovers. Such conduct in the weaker sex (as they are commonly called,) always meets with condemnation in them, and should never be copied by honorable men.

1. Resolved, That this Grand Lodge recognises the authority of the different Grand Lodges in the United States, over the jurisdiction claimed by them, and do not recognise the authority of any other body whatever claiming jurisdiction which interferes or conflicts with their's.

2. Resolved, That this Grand Lodge does not consider that "the supreme council of sovereign grand inspectors general of the 33d degree of the Scottish rite," can lawfully constitute lodges of Symbolic Masonry in the State of Louisiana, within the jurisdiction of the Grand Lodge of Louisiana.

3. Resolved, That the fact that they are constituted as Lodges of the Scottish rite will make no difference.

4. Resolved, That lodges so constituted are not entitled to be recognised as legally constituted, and the members of such lodges, and those initiated therein, are not lawful brothers, nor entitled to visit and communicate with the Grand Lodge and its constituent lodges.

5. Resolved, That the practice of publishing the names of rejected applicants for Masonic honors, be discontinued by this Grand Lodge.

6. Resolved, 'That an expulsion from an Encampment does not affect the standing of the individual in any Blue Lodge to which he may belong.

7. Resolved, 'That the constitution of this Grand Lodge be so amended that it shall read : "Whenever this Grand Lodge shall reverse or abrogate a decision of a subordinate lodge, 'expelling' a brother, and shall restore him to the benefits and privileges of Masonry, he shall not thereby be restored to membership within the body from which he was 'expelled,' without its unanimous consent."

EDUCATION.

The Grand Lodges of Tennessee, Kentucky, Missouri and Alabama have Colleges under their care, in which provision is made for the education of the orphan and indigent children of our order. The grand Lodge of New York have in contemplation a most noble and stupendous enterprise.— They propose to erect an Asylum for the indigent Masons, their widows and orphans ; to endow it liberally and adequately ; furnish it so that it may be a comfortable home for the aged and helpless, the widow and the orphan. A school of the first order is to be attached, and the children are to be instructed in agriculture and useful trades. The plan presented to the Grand Lodge strikes us as feasible, and we look with anxious solicitude to the time when the cap-stone shall be laid, amid the acclamations of thousands of our brethren who seem eager to enter upon the work.

TEXT BOOK.

Many of the Grand Lodges have recommended and adopted the new Chart, by Brother Moore, of Boston ; and as the Grand Royal Arch Chapter of this State has lately adopted it, we recommend that this Most Worshipful Grand Lodge do the same.

We observe that it is the custom of several of the Grand Lodges to have an Address and Masonic procession at their

Annual Meetings : and we respectfully recommend that we imitate their example.

Several interesting questions of Masonic jurisprudence are discussed by the different Committees of Foreign Correspondence, besides those already noticed ; but many of them have been already considered by this Grand Lodge ; and the rest, for the most part, are more curious than useful ; and a particular discussion of them is deemed unnecessary.

In concluding this rapid sketch of the state of Masonry, your committee recommend the purchase of Anderson's Book of the Constitutions, and the Ahiman Rezon ; and that the pamphlets containing the Proceedings of the several Grand Lodges, together with a number of Addresses sent to our Grand Secretary, be bound in volumes of a convenient size, for the use of this Grand Lodge.
