


This Indenture made this Sixth day of January in the Year of our Lord Eighteen hundred and Sixteen between Ebenezer Frost of the County of Rowan & State of North Carolina of the one part and Samuel Frost of the County of Rowan and State of North Carolina of the other part Witnesseth that for And in consideration of the Sum of one hundred and Fiftyfive pounds Currant Money of the State of <sup>N.C.</sup> to the said Ebenezer Frost in hand paid by the said Samuel Frost before the en sealing And Delivering of these presents the Receipt is hereby acknowledged himself Fully Satisfied & paid hath by these presents granted Bargained & Sold unto him the s<sup>d</sup>. Samuel Frost or his Heirs Executors administrators or Assigns forever all that peice and parcel of Land lying & being in the County of Rowan on the waters of Dutchmans Creek & Bear Creek one track of Land containing one hundred & Fiftyfive Acres beginning at Apostoak on John Killers line and runs South with s<sup>d</sup>. line Twentyfive Chains to a pine James Frosts Corner on Rosy Hunters line thence West with s<sup>d</sup>. James Frosts line Sixtytoo Chains to a Ash s<sup>d</sup>. J. Frosts Corner on Hugh Wilsons line; thence North with s<sup>d</sup>. Wilsons line Thirteen Chains and fifteenlinks to a Whiteoak s<sup>d</sup>. Wilsons Corner on Moses Locks line thence East too Chains thence North twelve Chains to a postoak on s<sup>d</sup>. Locks line thence East to the begining Containing by estimation One hundred & Fiftyfive Acres of land be the same more or less together with all and singular the premises and appertinances unto the s<sup>d</sup>. peice and parcel of land in any wise Belonging thereunto with all the rents issues & profits of the same and all the estate Right titles Claims Interests & Demands whatsoever of the s<sup>d</sup>. Ebenezer Frost as aforesaid of or unto the said Land tenements Hereditaments and premises whatsoever hereby granted or mentioned to be granted or any of them or any part Or parcel of them to have and to hold the s<sup>d</sup>. tenements Hereditaments & premises hereby granted with the Appertinances to the s<sup>d</sup>. Samuel Frost his heirs & assigns forever and to the only proper use and behoof Of the s<sup>d</sup>. Samuel Frost his heirs & assigns for ever & the s<sup>d</sup>. Ebenezer Frost for himself his heirs Executors or administrators doth hereby promise Covenant & agree that the s<sup>d</sup>. Ebenezer Frost for himself His heirs executors or administrators shall and will at any time warrant and forever defend the said Land and premises unto the said Samuel Frost his heirs or assigns against all lawful Claimes or Demands whatsoever whereby the above mentioned land & premises might or May be affected or injured contrary to the true intente and meaning of these presents in Witness whereof the s<sup>d</sup>. Ebenezer Frost hath hereunto set his hand and affixed his seal the Day and year first above written
