Home and Garden Tours — A New Service

On January 17, 1982, the Society's Board adopted guidelines for Home and Garden Tours which will be offered to the public at any time. Upon a minimum of a two week notice, we will setup a tour of four homes. These tours must have a minimum of 25 individuals. The cost per individual taking the tour is as follows:

25 to 50 people \$7.00 per person 50 to 100 people \$6.00 per person 100 and over \$5.00 per person

In each case the society will receive one dollar for each individual on each tour. The rest of the imcome received from each tour will be divided equally between the four homes on a particular tour. This money will help the homeowner defray the cost of opening his/her home. If there is a request to see any of the gardens in Oakwood, an additional charge of 50 cent per person per garden will be added to the amount charged each individual on a tour, and this will go to the owner of the garden on a particular tour. Tours will not be offered during the month of December as they might conflict with our annual Christmas Tour. Already there are request for two tours within the next several months which will include 250 to 300 people.

There have been a number of inquiries over the past few months about Oakwood Tours. These have come from groups who will be visiting our city or who are coming to Raleigh for a meeting, convention, or some other special reason. Two organizations which have asked many times about such tours are the North Carolina Visitor's Center and the Raleigh Chamber of Commerce. Both groups have been informed about our tours which are now available and both have been very excited about them.

All requests for such tours should be directed to Ames Christopher (834-3392).

Also, if you are interested in being added to the list of homes and gardens which are available for future tours, PLEASE let Ames know. Tours will be scheduled on a rotating basis as to which homes and gardens are scheduled or tour. If there is a special request to see a particular homes(s), we will contact that particular homeowner and ask if they can open on a particular date. However, we will not quarantee that we can honor a special request.

Community Watch

The Community Watch Program has been adopted by Oakwood neighbors — but we must keep in mind that it is only as good as we make it. The Community Watch Program will be the feature of the March Society meeting and a lot of information will be available at that time.

In a recent Brentwood bank robbery, the suspects were caught within hours because members of that neighborhood were on the lookout for suspicious behavior. One neighbor noticed the car parked on a neighborhood street and became suspicious and called 911. While a police car was on the way to check out that report, another neighbor became suspicious of persons observed leaving the bank and followed them in his car and later reported the location of the suspect car to the police.

Brentwood obviously takes Community W seriously. So should Oakwood.



Recently a number of Oakwood residents attended a meeting concerning the City's Comprehensive Plan at the Municipal Building. Among those interested were Barbara Wishy, Alice Garland-Swink, Ann Bryan, Tom Briggs, Steve Evans, Rodney Swink and myself.

Alice and Barbara have been appointed to represent us on one of the committees which is involved in the review process of the Comprehensive Plan which is underway at this time. This plan is very important and can affect the lives of us all—particularly those of us who are "pioneering" in the inner-city. If you have questions or comments, please call Alice or Barbara or anyone who attended this meeting.

During the year we get many calls from people who want to find out about homes which are for sale or which might be for sale in the near future. We try to assist them in any way possible. We always hate to see anybody leave the neighborhood — but, if you must move away, we would like to know that your home will be for sale. We may already know of someone who will be interested in buying a home just like yours. We would immediately put you in contact with that person. If you would like this assistance, please call Barbara Wishy or myself.

Oakwood has seen a number of fires in recent months, one of which resulted in the death of a neighbor. Betsy Hinnant, 410 Oakwood Avenue, lost her kitchen the day of the Christmas Tour and I lost an apartment a few weeks afterward. While all of us have nothing but praise to offer to Fire Station No. 3 and all who came to our rescue, it is a rude awakening when you find out the restrictions which can be imposed when you try to rebuild. These include restrictions concerning non-conforming density (number of individuals living in a house due to lot size), building code requirements and lot set back requirements. Many of the homes in Oakwood do not meet the standard lot line requirements since they were built when none existed.

It can also be quite a shock to find out building replacement costs — particularly if you haven't had to do any lately. Replacing clothing, appliances, and "collectibles" is not only costly but just getting estimates for the insurance company is time consuming. A reminder to everyone of the neighbors to check on their insurance coverage. If you have have your police for a number of years, you many need to have your property and contents reassessed.

We would also like to remind you that the City's Fire Department will come out and inspect your fireplaces free — call and have this done. It might avoid a tragic loss.

Speaking of emergencies — there is a new number to call when you need police, fire and emergency services — simply dial 911. Help is instantly on the way. I urge you to take note of any and all of these "reminders" if you have not had reason to do so recently.

The most visible achievement for 1981 of the Goals Committee was the organization of and implementation of a coalition of city neighborhoods.



Presently, potential topics include: the concerns of young families living in Oakwood (play areas, schools, and how to keep your bicycle); more responsible pet care (how to politely tell your favorite neighbor that you have their dog or vice versa); the possibility of a semi-structured system for the care of our older and less mobile neighbors; issues important to sustaining neighborhood cohesion without being too demanding of everyone's valuable time.

We welcome suggestions for additional topics and welcome neighbors to express an interest in presenting their concern at our meetings.



The Death of Our Oldest Neighbor

Oakwood's Senior Citizen

Mrs. William Marshall Allen.

Suzanne Dabney Allen — Born in Vicksburg, Mississippi, December 17, 1877.

Married William Marshall Allen, a chemist for the N. C. Department of Agriculture, December 30, 1914 in Vicksburg.

The couple moved to Raleigh in January, 1915 to the Elms Apartments on Hillsborough Street.

In 1921 they purchased property on Jones Street which already had a small house on the land site. The house was enlarged and the couple moved into their new residence in 1924.

Mrs. Allen spent many years in traveling and boasts today that she has been in every state in the Union. The age of 83 found Mrs. Allen and her sisterin-law bound for Japan, where they remained for three months.

Mrs. Allen attributes her longetivity to her programs of interest and physical exercise.

Until 1969, she was an active member in the Johnsonian Book Club.

She believed in keeping fit by walking several miles each day. It is not unusual to see her with her sister-in-law each evening walking from her home on Jones Street to N. C. State College. Working in her garden was another favorite pastime.

She was known for her garden of Iris, three hundred in variety for which she won many prizes, including gold pieces.

Her thoughts on life today quote Mrs. Allen, "it is complicated."
