Bros. M'Iver, Cox and Boylan were appointed a committee to contract for the engraving of a suitable plate for printing certificates of membership, or diplomas, for this Grand Lodge; also to contract for the printing of such certificates or diplomas, and to superintend the same; and, Resolved, that said committee be and are hereby authorised to draw upon the G. Treasurer for whatever sum may be necessary to effect this object.

The committee, appointed to examine the proceedings of Charity Lodge, reported that the same were regular and satisfactory, and recommended that a Charter be granted

said Lodge.
