Ordered, That a charter iffue, constituting a Lodge in Martin county, in the town of Hamilton, by the name of Young Eagle, No. 49, directed to Jesse Jones,

Master, Jeremiah Slade, Senior Warden, and Wm. Pierce, Junior Warden.

For reasons shewn to this Grand Lodge, it is ordered that the arrears due from Old Cone Lodge, No. 9, in the town of Salisbury, amounting to the sum of thirty-eight pounds, which accrued previous to the year 1800, be remitted on the books of the Grand Treasurer.

Ordered, That the Grand Treasurer be authorized to settle the accounts of Mount Moria Lodge, No. 27, and pass to them such credits as he may deem proper.

Ordered, That Brothers Gen. John Steele, William Duffy and Robert Cochran, be appointed a committee to examine the Treafurer's Books, and report, &c.

Ordered, That brothers Gen. Benjamin Smith, Gen. Durant Hatch, Gen. Montfort Stokes, Jeremiah Slade, Doctor Calvin Jones, and Samuel Lowrie, be appointed to examine the communications made to us from other Grand Lodges in North America.

The committee to whom was referred the examination of the state of the Treatury, made the following report:

That they find by receipts up to the first day of December, 1805, to be in the hands of the Grand Treaturer, the sum of £.434 16 5 1-2: four hundred and thirty four pounds, fixteen shillings and five pence half penny. That the necessary disbursements

amount to £70 8 9: feventy pounds, eight famings and nine pence. Which latter fum taken from the former, leaves in the hands of the Grand I reasurer the fum of 364 £. 7 8 1-2: three hundred and fixty four pounds feven shillings and eight pence half penny.

Ordered, That Gen. Durant Hatch and Francis X. Martin, be appointed a committee to enquire into the case of Mr. —— Ives, formerly a member of St. John Lodge, No. 3, Newbern, and make a report thereof to the next grand annual communication.

The Grand Lodge being informed by the most worshipful the honorable John Lewis Taylor, past Grand Master, now one of the representatives of St. John's Lodge, No. 3, Newbern, that the worshipful Francis Lothrop, the Master of said Lodge, died on the day of October last past: therefore

Resolved unanimously, That this Grand Lodge hear with great concern, that the fraternity have been deprived of a worthy brother in the person of said Francis Lothrop; who, for several years past, has been an useful and zealous member of the Grand Lodge: That the Grand Secretary do record this event in the books of the Grand Lodge, and apprise the several Lodges of it, and announce the great grief which they feel on the occasion.
