The Junior League represents a serious endeavor on the part of young women to become active and constructive factors in the communities in which they live, to be intelligent citizens, and to assist in promoting human welfare. In addition to providing the member with channels of work and training for volunteer service, the Junior League helps her to realize two vital concepts: (1) that she is not an onlooker, but is herself a part of the community; (2) that the community, in turn, is not an isolated unit but part of the nation and of the world.

It was in 1901, at the beginning of a new era for American women, that the first Junior League was organized in New York. At that time Mary Harriman (Mrs. Charles Carey Rumsey) and Nathalie Henderson (Mrs. Joseph Swan) realized what might be achieved if a group of young women were encouraged to take a more active part in some form of active service to their own neighborhoods through the settlement houses and other organizations in existence at the time.

Soon organizations similar to that in New York were formed in various other of the large cities—Boston, Brooklyn, Portland, Ore., Baltimore, Philadelphia, and Chicago. In the spring of 1912 six of the seven Leagues then in existence held their first national conference in New York City. In 1921 the Association of the Junior Leagues of America, Inc., was founded by the thirty Leagues then in existence. Mrs. Willard Straight (Mrs. Leonard K. Elmhirst) was elected President and a Board of Directors was appointed and instructed to draw up a constitution.

After 1921 the Association grew rapidly until, in 1923, there were sixty-three Leagues. In order to establish a closer contact between the Leagues and the Association, the country was divided into six territories and in each a League member was appointed Regional Director to act as liaison officer between the Leagues of the Region and the Association and to serve on the latter's Board of Directors. Now there are fourteen Regions, in each of which the Leagues elect every second year a member to serve as their Regional Director.

At the time the Association was first formed most League activity was in the realm of social work; but the Board of Directors, realizing the opportunities which would eventually offer themselves to Junior Leagues, set down in the constitution the social, economic, educational, cultural and civic fields as those in which Junior Leagues should interest their members.

Gradually the Leagues realized that a benevolent "doing for others" was not enough, that they must form a partnership with professional community workers to effect the improvement of conditions. To do this required knowledge. As evidence of this the first course for provisional members was established in 1921 and such a course, which includes an examination of the various forces at work in the community, has been a prerequisite for active membership since 1927. Originally League projects were

large enterprises—convalescent homes, day nurseries, curative workshops and the like. It was discovered, however, that to support these undertakings a disproportionate amount of time and energy often was going into moneyraising to the exclusion of the educational process of volunteer service. Today where Leagues have projects the recommended type is one in which the demonstration element is present, the choice being based on the needs of the individual community in the light of the interest and money-raising capabilities of the League.

The League's realization of the need for expert guidance in its welfare activities soon led to the establishment of a trained social work staff at the Association's offices. Members of this staff were available for visits to Leagues to study the local situation and give advice. Similar service was then made available for Children's Theatre, Arts, Ways and Means, and Publicity. The Association also publishes the Junior League Magazine, issued semi-monthly to each Junior League member.

HISTORY OF WINSTON-SALEM JUNIOR LEAGUE

The Junior League of Winston-Salem had its beginning as the result of a meeting called by the late Mrs. J. Edward Johnson (former widow of Richard J. Reynolds, founder of the R. J. Reynolds Tobacco Co.) on January 13, 1923. About 40 young women met at her house at Reynolda. They were advised that they should devote time and energy to social service.

Mrs. Bess Gray Plumly called the group together a few weeks later, and the late Miss Marian Blair suggested that the group apply for membership in the Association of Junior Leagues of America.

In March, 1923, the Winston-Salem Junior League became the 46th in the Association and the first in North Carolina. The late Mrs. Lucy Hanes Chatham was the first president.

During the first five years the League was active in many projects such as opening a gift shop, sponsoring a pre-natal clinic, opening a Hospital for Incurables, operating a beauty parlor and forming a Children's Play Committee.

The next ten years show that the League was continually expanding into new fields. The Newssheet was begun and a placement system was put into effect. The League also continued operation of the Hospital for Incurables, opened a Rag Market (later the Thrift Shop) and helped organize the Civic Music Association. After the Hospital for Incurables was closed on June 1, 1937, the League assisted in the organization of the Mental Hygiene Society of Winston-Salem. The League also financed a Child Guidance Clinic which opened on November 1, 1937.

The next several years the League continued to sponsor and finance the Child Guidance Clinic. New projects included the Hall of History, presentation by the Junior Programs, Inc., and

the bringing to town of four New York Dramas of the Contemporary Theatre Series. The League also joined with other interested community groups in forming the Children's Theatre Board.

In 1941 the League's program of planned expenditure of surplus was begun with \$3,000 donated to the Red Cross War Fund, \$1,000 given to the Library Fund of the Winston-Salem Teachers College, \$5,000 given to the Family Service Agency for the establishment of a Child Placing Agency and \$4,500 to the Community Council for the development of the Radio Plan.

In 1942 the Child Guidance Clinic was closed and in 1943 the gift shop was sold.

During the war years the League members devoted the major part of their volunteer service to war-related activities. Support of the Radio Council continued as well as a donation of \$1,000 to the Wachovia Historical Society. A survey by Miss Virginia Lee Comer, AJLA Arts Consultant, showed a need for development and expression of the creative arts in our community. In 1945 the beauty parlor was sold. In 1945 the major portion of the League's surplus was donated to the community. The 400 shares of Reynolds B stock was divided as follows: 50 shares to the City-County Hospital, 50 shares to the War Memorial Building Fund, 120 shares to the Mental Hygiene Society and 180 shares to the City Library. The Junior League Hospital Building was deeded to the Winston-Salem Foundation.

The League entered the cultural field during these years by opening an Arts and Crafts workshop with Mrs. Chester Marsh as director. The League continued its financial support of the Radio Council and put aside \$7,200 for the employment of a Community Arts Coordinator when the Arts Council proved its readiness to handle the money. The League also contributed \$500 to the Piedmont Festival and sponsored a concert of the newly formed Winston-Salem Civic Orchestra.

In 1947 the city withdrew its support of the Arts and Crafts program and the League assumed the responsibility for the administration, financing and promotion of the workshop.

Support continued to the Symphony and the Piedmont Festival and in 1950 the League released the gift of \$7,000 which it had held in trust for the Arts Council. In March of 1952, \$3,000 was granted to the workshop and in 1951, the Arts Council established an Arts Center and moved in a building owned by the Winston-Salem Foundation. In March the League's financial contribution to the Arts Center was completed through coordination of fund raising for the Arts groups under the Arts Council.

In 1952 the League had as its project the Children's Activities Program at the new City-County Library. The League voted the Library \$1,500 for the first year and limited the League's sponsorship to three years. The League also continued support of the Arts Council with a donation of \$5,000.

Two art exhibits were sponsored by the League in 1953 and recreational therapy was done in the Children's Wing of the Baptist Hospital. The next year showed the closing of the Thrift Shop and the beginning of our annual Rummage Sale.

In 1955 our three-year activity program for children was completed at the Public Library. The Recreational Therapy program at the Baptist Hospital was enlarged and the League continued to bring outstanding art exhibits to the Library. A new project was begun—providing the salary for a primary education teacher for the handicapped at the Children's Center.

During the next year the League strengthened existing projects and added to those services. A program for handicapped adults was begun and the therapy program at the hospital enlarged.

The Adult Handicapped program grew rapidly and the Hospital Therapy program was continued. The Cultural Arts Committee arranged a bus trip to Raleigh to tour the State Art Museum and \$150 was offered as a purchase prize to the Gallery of Fine Arts in the name of the Junior League. A successful Rummage Sale was held as well as 5 marvelous productions of the play Sleeping Beauty.

In 1957 the League again contributed \$5,000 to the Children's Center providing the school with a kindergarten teacher. An art exhibit drew 3,700 people and the Rummage Sale was a great success. Night meetings were begun for professional members and those unable to attend the morning meeting. Two brochures were printed—one dealing with Admissions policies and the other describing the community activities of the Winston-Salem Junior League.

The League continued to strengthen existing projects in 1958 by donating \$2,000 a year for the next two years to provide an aide at the Children's Center, by buying a metal awning for the Pediatric Ward at the Baptist Hospital and by giving \$1,155 to the Arts Council.

In 1959-60 the League accepted a new project by voting to pledge \$26,000 over a three-year period for the restoration of Old Salem's Timothy Vogler Home, in which the League would establish Headquarters. The following year Regional Conference was held in Winston-Salem for the first time, Timothy Vogler was completed and \$15,000 was paid toward the indebtedness to Old Salem. In 1961-62 the League produced its first Follies which netted \$16,000 and the obligation to Old Salem was paid. In 1962-63 the League voted approval of two projects: one, \$10,000 for remodeling the kitchen at Amos Cottage; and two, a \$6,000 challenge gift for two years to the consolidated school system for an art supervisor. Sixteen oil paintings were done for the Pediatrics Floor at Baptist Hospital. Upon the completion of Forsyth Memorial Hospital in 1964, similar paintings were presented to this Pediatrics Floor.

In 1963-64 a visit from the AJLA consultant, Mrs. Nancy Vars, and many hours of study by the Project Finding Committee resulted in the approval of a Nature-Science Center for a three year project with \$26,000 in financial support over the three year period and three members of the Board of Trustees. The Fortieth Anniversary was celebrated by the publication of an unusual and attractive new brochure, a dinner dance for the membership and a luncheon in honor of the charter members.

1964-65. The new Art Supervisor arrived and was assisted

in his program by the Community Arts Committee whose efforts culminated in a delightful May Day Exhibit of scholastic art on Salem Square. Work began at the Nature-Science Center, which officially opened Spring, 1965. The Winston-Salem Civic Ballet was granted \$700.00 for a Christmas production. A painting by a League artist was presented to the Department of Public Welfare for the children's waiting room. In April, at the recommendation of the Project Research Committee, the League voted to accept the offer of the Red Cross to assume full financial and volunteer responsibility of our long standing project in the Children's Play Room of the Baptist Hospital. The elections of Dewitt Cordell as Regional Director and Anne Strickland to the Regional Nominating Committee, are proof of our capable, competent leaders.

1965-66. One of the major innovations in the Winston-Salem Junior League was the complete revision of the Bylaws. New Admissions blanks were written and all Placement records were transferred to newly drafted cards. A bulk mail permit imprint was obtained, and a public address system was purchased for use by the Puppet Committee, who diligently adapted an authentic Salem story to their repertoire for the Bicentennial Celebration. Friends, who assisted the League during the year, were honored by the purchase of an Art Kit for the community to be housed at the Gallery of Fine Arts. Other offerings in the cultural arts field were the gift of Darrell Coon's "Georgia Spring Barn" to Mineral Springs Junior High School and a clothes line art show on Salem Square. The League produced "Tyll" for 4300 children and netted \$15,237.00 on the Rummage Sale. \$2,000 worth of tickets were acquired to the Bicentennial drama to give to families who might not be able to attend the drama otherwise. Initial plans were made to bring three performances of the Metropolitan Opera to Winston-Salem in 1967. The League voted \$700 to promote the Christmas Ballet "Nutcracker" to be presented in December, 1967 by the School of the Arts and Civic Ballet. Continued support of the Nature-Science Center was expressed in the vote of \$45,000 to be paid over a five year period.

1966-1967. Among the many activities of the Winston-Salem Junior League was the presentation of the Nutcracker Ballet in conjunction with the North Carolina School of the Arts and the Winston-Salem Civic Ballet. It was such a success that \$700 was voted to promote it again next year. The Metropolitan Opera Company brought three operas to Winston-Salem in March. The total profit from that was \$17,102.96 which was added to the Community Trust Account. The Rummage Sale was held in Memorial Coliseum and netted \$10,209.00. Puppetry was expanded and two separate groups performed for approximately 3,800 children. Children's Theatre presented "Man in the Moon," which was enjoyed by 5,000 children. A painting was given to the School of the Arts in honor of those in the community who assisted with the League programs this year. The Purchase Prize was awarded to three graphics which were placed in Southwest Junior High School, and the Clothesline Art Exhibit was held again at Salem Square. Certificates were presented to those who participated. The League assisted Reynolda House, Inc., which sponsored the Salvador Dali-Art-in-Jewels Exhibit. The proceeds benefited the Nature-Science Center and Reynolda House, Inc.

The possibilities of a Volunteer Service Bureau were studied throughout the year by Project Research. In May, this culminated in a League vote of \$1,000 a year for three years for a Volunteer Service Bureau.

The Adult Handicapped Committee was dissolved in December, 1966 and the responsibility for the Poke-Easy Club was assumed by the City Recreation Department.

The League is pleased and proud that Dewitt Cordell was elected 2nd Vice-President of the Association.

1967-1968. One of the innovations which took place this year was the revision of the board structure. The size of the Board of Directors was reduced and rearranged in order of Standing Committees (long-range administrative) and Special Committees (projects and money-raising activities). The Board's manuals and committee files were reworked. The League membership approved the termination of the League production of an annual play for the Children's Theatre Board series. The eligibility requirements for serving on the Admissions Committee were changed to require a member to be active for at least three years. The Finance Committee approved the AJLA recommended changes in our budget format. Our headquarters at Timothy Vogler was completely renewed with paint inside and out and many new necessary items were added. The Volunteer Bureau and the Nature-Science Center, both League projects, are growing in scope daily. The Puppet Committee revamped their lighting and technical equipment. 5,000 school children viewed the performances of "Puss in Boots" in October. The Nutcracker Ballet was performed for 6,000 children and adults. The Palettes Committee completed twelve paintings and presented them to the Child Guidance Clinic at Reynolda in May. The Clothesline Art Show was again held on Salem Square and 2,000 certificates of merit were awarded to the participants. The Rummage Sale was held in the Memorial Coliseum and netted \$8,617.86. In honor of those in the community who assisted with the League programs this year, an antique Hepplewhite dining table was given to the John Vogler House. For the tenth year, a Purchase Prize was offered to the Winston-Salem Gallery of Contemporary Art for its February jury. A work of geometric sculpture, "Vecton V", by Donald Green of Fayetteville, N. C., was selected and will be presented to a new junior high school, Thomas Jefferson, when it opens this fall.

ANNUAL REPORTS OF BOARD, 1967-1968 WINSTON-SALEM JUNIOR LEAGUE

PRESIDENT - MRS. CLAY V. RING, JR.

The 45th year of the Winston-Salem Junior League is just now a matter of record. As I tried to put into words the 45th Annual Report it was indeed with mixed emotions . . . with awe at your capability and talent, and with deep and lasting gratitude for your support and friendship. It would be impossible to single out any individual or groups of individuals, because each of you, the Executive Committee, the Board members, and all committee members alike, as well as a truly loyal sustaining group, have made a lasting contribution to the League this year. Would that my words could exude the warmth that I feel as I say THANK YOU.

Yes, the 45th year is a matter of record, but the efforts of 1967-68 will not find their way to the League annals without having their impact on the future direction of the League. It has been a reflective year in many ways, a year of evaluation and appraisal — a most successful year, because each of you have made many astute and carefully thought-out decisions.

Among some of the innovations which have taken place this year is the revision of the board structure. In essence, we have just tidied up a bit, bringing the board in line with the bylaws, making the voting core of Standing Committees a bit smaller and less unwieldy, and placing our project committees in the category of "Special Committees", which is what they are anyway. We are thinking more of the Board as a place for experienced leadership since the League has become a business of more than minor proportions. But at the same time, as girls prove themselves interested and capable in their committee work, one-third new leadership yearly finds its way to the Board.

Additionally, Project Research, with the help of Advisory Planning, the Board, and sustaining advisors, took the giant step of terminating the play. Now the door is open for new ideas in the field of drama whenever and wherever Project Research may lead us. But after 40 years of play production, the League, with great nostalgia of course, decided that excellence was its aim, and that the Children's Theatre Board, a League off-spring, and professional theater, actually held the answers. The League is to be congratulated on its judgment in this area.

There was a tightening of the residency requirement for eligibility to the Admissions Committee. Like the Board, the Nominating and Admissions Committees are not essentially training grounds and should be made up of knowledgeable girls.

The word on societal trends which filtered down to us from AJLA to the President's Councils and on to the Boards is this: Admissions is an area where there are many opinions and procedures. But underlying all admissions there is a basic sameness, "selectivity." A candidate should possess certain standards of personality, education, and cultural background for the desired congeniality of the membership.

Last fall the League indicated an overwhelming desire to learn more about the role of the volunteer and the needs educationally in Forsyth County. Background material, resulting from an in-depth study of the Public Affairs Committee, along with many ideas and thoughts gleaned from those attending the group meetings is being assimilated for the League's use.

Another innovation has been a change in the format of the budget. Putting into vogue the last but largest bit of information she obtained from Finance Seminar two years ago, our treasurer finally took courage and the auditor in hand and came up with the newly revised budget. This, coupled with her expertly presented explanation of it all, has made Finance a clearly defined phrase in the Winston-Salem League.

Timothy Vogler has been completely renewed. Fresh paint inside and out, new coat racks, and many other necessary items, have added greatly to Headquarters. In addition, a current appraisal of all furnishings has been made.

A list of ages and birth dates has been carefully categorized, charted, and the procedure set up to facilitate the work of the Nominating Committee.

You have received a new and handsome brochure — a product of the talent of the Professional group, aided by the Public Relations Committee. These brochures, along with a note of thanks, have also gone to those people who befriended the League. The League's selection of an antique dining table for the John Vogler House also honored the friends of the League.

Especially worthwhile has been the re-working of the Board manuals and committee files. Each Board member has diligently tried to revise and revamp all of her committee's data in the light of the new AJLA handbook and to hand to the new Board only material which is pertinent.

Also, the Volunteer Bureau and the Nature-Science Center, both League projects and League "loves", are growing in scope daily, much to the credit of League effort. The Volunteer Bureau has become well established in the brief span of a year, and the Nature-Science Center is now looking ahead almost immediately to plans for growth and expansion, probably the most exciting progress yet for the Nature-Science Center. Our Palettes Committee has completed these delightful paintings on display tonight for the Child Guidance Clinic — which has been no small task. The Puppets have played to 11,000 enchanted children in the first three grades, and have ingeniously revamped their lighting and technical equipment. The Clothesline Art Show on Salem Square, under the direction of our Community Arts Committee, and in conjunction with our school system, awarded 2,000 certificates of merit. League volunteers gave workshops on the construction and manipulation of paper bag puppets to Special Education classes. The Nutcracker Ballet, traditional after only two years in Winston-Salem, was performed for 6,000 children and adults, and the promotion and ticket sales were under Junior League auspices. 5,000 school children enthusiastically viewed the performances of "Puss 'n Boots" in October as 66 League girls worked unstintingly to make the play a success. A most enjoyable social function for the membership was the

cocktail dance in January, and melding the membership further in our one money raising activity of the year was the Rummage Sale in March. Nine issues of the Newssheet kept the League well informed with special emphasis on In-League Committees as well as areas of special interest in the community. The Provisionals incorporated their editorial and artistic abilities into the festive December issue. The Education Committee had such outstanding programs as MacLean Mitchell, whose topic was current events. An unusual and interesting piece of statuary was given to the new Thomas Jefferson Junior High School. The added impetus of strength and numbers of the sustainers enabled the League to broaden its programs in many placement areas - the Docent Program at Reynolda House, the Rummage Sale, the work at Amos Cottage and the Docent Program at the Gallery of Fine Arts. Sustaining members opened their houses for the coffees as well as the Provisional Course, and sustainers gave their assistance in an advisory capacity to various committees, with Virginia Pleasants serving as Sustaining Advisor to the Board.

In recalling some of the events of 1967-68 it serves to remind us that we are an active and educable group of volunteers, bent on being well-informed, contributing members of the community.

We have shared our experience with other Leagues in Region XIII in the areas of revision of board manuals, yearbooks, bylaws, societal trends, Children's Theater, the arts, and Admissions.

We have broadened our horizons by sending delegates to conferences and workshops. Last spring the theme of Annual Conference in Montreal was "The New Forces Molding the Volunteer." At Regional Conference in Sea Island in November "Health and Welfare in the Community" was discussed. We put on our itinerary a puppet workshop in Canada and a Children's Theatre Conference in New York City. After Christmas we had delegates attend a seminar on Volunteer Bureaus in Newport News and recently an Education Workshop in Charlotte—all absolute gems for exchanges of ideas and sources of seeing new directions for the volunteer.

In essence the League has given of itself and has gained immeasurably through the learning experiences of this past year. And so I commend you for what the League has accomplished during 1967-68.

Rather than end this report with unanswered questions such as, what is the volunteer's role in the future, will we merely train our members if suitable projects do not present themselves, and will government programs usurp the initiative of the private sector? I would say to you that since the beginning of time there have been unmet needs, questions to be answered, and problems to be solved. There will continue to be challenging areas where the Junior League, because of its very nature, can and should make a contribution. And secondly, I would say to you that selectivity is our strength. All things are not for all people regardless of what the trend seems to be today. The Junior League, with its ability and training, can strive to bring ex-

cellence into situations, and to dispel gracefully mediocrity.

I think that in the last decade our nation has seen a retrogression of humanity and an atrophy of culture and decorum. The very tenets of competition and ambition upon which our country has thrived are at present being compromised, and frequently we find ourselves being apologetic for the so-called inequalities we possess. The Junior League has the par excellence that sets it apart and impowers it to combat this retrogression.

The Winston-Salem Junior League has never been an organization of the times but rather one that is far ahead of its time. We have always had the ability to discern between the "trends" of the times and the mores. For these reasons we have never made decisions in haste but rather with painstaking deliberation. We should continue in this safe and sure vein, always aware of the totality of things about us and yet set apart by our inequality.

Our selectivity will not isolate us from community involvement but instead will enable us to focus on the larger community picture in a more knowledgeable way. No longer will we be able to pioneer per se, but rather will our projects and efforts be carried out cooperatively with other groups in the community. But in my opinion, as we encounter almost a cult for the common man, we must not allow it to be degraded to the "commonness" of man. We can remain in the vanguard by having welltrained and well-informed League members affect the many facets of community life through both individual and League involvement. Necessarily we must have a working knowledge of the local community as well as the state and nation. Those who are able to create are rare while those unable to create are numerous. It is up to the Junior League to educate and to develop the greatest potential of its members and to use its combined strength to have an urgently meaningful effect on the community. The community respects the Junior League, and for that reason we should always be mindful that what we do connotes excellence. We should keep in mind that what the League does is not nearly as important as what the League is. As a League we should maintain our emphasis on selectivity — inequality if you must — and only thusly can the ingenuity and creativity of the Junior League have its impact.

I cannot relinquish the gavel to Sally without remembering that Debbie handed it to me. Her legacy has been invaluable this year. And now as I hand the League-in-Trust to Sally, I could not do so with more confidence, because she possesses the qualities that the Winston-Salem Junior League would require of its President — and as an added bonus she's SALLY!

BYLAWS

The Bylaws Committee studied and, when necessary, acted upon those questions referred by committee chairmen and the Board of Directors. - (1) To be eligible for election to the Admissions Committee, a member must have been active for at least one year, and a resident of Winston-Salem or its vicinity for at least five years.

Now reads:

To be eligible for election to the Admissions Committee, a member must have been active in the Winston-Salem League for at least three years, and a resident of Winston-Salem

or its vicinity for at least five years.

(b) Election of Committee

Formerly read:

(1) . . . Two weeks prior to the March meeting the Nominating Committee shall mail to all Active members a list of those members of the present Admissions Committee who are eligible for reelection . . . and a list divided into three age groups of all other Active members eligible for election. These age groups shall be as follows: 21 to 29, 29 to 35, 35 through 39.

Now reads:

These age groups shall be as follows: 21 to 31, 31 to 36, and 36 through 39.

BY-LAWS, ARTICLE VII — COMMITTEES

Section 2. Special Committees

Formerly read:

Special Committees (e.g., Community Trust Projects) shall be designated by the President with the approval of the Executive Committee, which shall determine the powers of the Committee (including the right to vote) and the terms of the Committee's appointment. The chairmen of these special committees may sit on the Board of Directors for the duration of their committee's function.

Now reads:

Special Committees shall be appointed by the President with the approval of the Executive Committee, which shall determine the powers of the committees and the terms of the committees' appointment. The chairmen of these special committees shall sit on the Board of Directors for the duration of their committees' function, but are not members of the Board.

COMMUNITY ARTS

For the tenth year, a Purchase Prize was offered to the Winston-Salem Gallery of Contemporary Art for its February jury. A work of geometric sculpture, "Vecton V", by Donald Green of Fayetteville, N. C., was selected and will be presented to a new junior high, Thomas Jefferson, when it opens in the fall. The sculpture will be on display at the Parkland Gallery during the summer. FINANCE

The Finance Committee, composed of seven members, met in March to prepare the proposed budget for 1968-69 and to approve the AJLA recommended changes in our budget format. FUNBOOK

NATURE-SCIENCE CENTER

The 1967-68 season at the Nature-Science Center has been one of progress in the development of the program and plans of the Center. The League can be proud of its sustained impetus in its project. In addition to the \$10,000 from the community trust account, the League this year has provided the Center with 25 volunteers, 5 board members, 3 officers and over 40 hours of service training to 19 provisionals. A regular monthly article in the Newssheet was aimed at keeping the membership informed of the Center's activities and progress.

The development of existing programs and the initiation of new ones has been the hallmark of the year's growth. Acceleration of the training program for planetarium operators has resulted in greatly increased availability of planetarium shows, and the addition of regularly scheduled volunteer receptionist-guides has facilitated group tours of the Center as has the publishing of a correlation sheet used by teachers, scout masters and other leaders of groups. An innovation of community-wide interest was the series of three film-illustrated-lectures by nationally known naturalists. Another new program is the series of preschool classes on seasonal adaptations of animals in fall, winter and spring. The hero of the event is Benjamin Bunny who has been fondled by 1,874 preschoolers with spring classes still to go.

The staff at the Center was augmented this fall with the addition of Mr. Ed Thompson, the new Curator of Exhibits. In January, the school system appointed a liaison to coordinate the schools' program with activities at the Center.

Financial participation in the Center in addition to the League includes City and County funds and a \$1,500 grant from the Devotion Foundation of Springfield, Illinois for mounted specimens by the renowned Carl Ackley. The membership drive has netted about \$10,000 thus far, the proceeds of which are applied to general operating expenses.

It is impossible to chronicle, even in brief synopsis, a year's activities at the Center without noting the possibilities for growth and expansion that lie ahead. Concrete plans for the future are now in progress that could make the year 1968-69 the most exciting yet for the Nature-Science Center.

PROJECT RESEARCH

This year the Project Research Committee was primarily concerned with looking into present and past projects and areas of interest for the future.

After much study and with careful consideration of all the findings of Advisory Planning, the Project Research Committee recommended that the League terminate its production of an annual play for the Children's Theatre Board series. Facts pertinent to this decision were mailed to all the members previous to the January meeting. A panel discussion was presented at two meetings to clarify the considerations of termination. The following motion was presented in January and approved by the membership in March:

"The Project Research Committee moves that the Junior League terminate its production of an annual play for the Children's Theatre Board series. Since the Children's Theatre Board budget for the 1968-69 season has already been approved by The Arts Council, under the assumption that the League would produce its play, we also move, that the League give Children's Theatre Board \$3,900, so that they may secure a professional company for this program of their series."

The League has had a long and pleasant association with the Children's Theatre Board and will continue to have a representative serve on their board. They have also indicated that League volunteers will be needed more than ever this next year.

Because of the long history of the League in children's theatre and a continuing interest in this field, Advisory Planning recommended that Project Research begin a study of possible drama areas in education. A committee was assigned to talk to people knowledgeable in the field of drama. It is hoped that future committees will pursue this study in depth.

At the February "coffees" Project Research asked the membership to indicate their interests for possible future projects. The members expressed an overwhelming interest in the field of education.

In April the committee recommended that a Junior League Palettes Committee be commissioned for the year 1968-69 to do appropriate paintings for the new Red Cross building, and that the sum of \$200 be allocated for this purpose. This motion was approved by the membership in May.

During the year the committee considered several requests from the community, none of which qualified completely for a Junior League project. We also visited the Volunteer Bureau to learn how the League could best continue their support of this project.

In conclusion, I wish to thank the members of this committee

and our President, Ann Ring, for their availability and wise counsel.

PUPPETRY

Our year began last May with a roar — Dragon's roar — at the Annual Meeting when "Jack" and "Dragon" did a skit to promote the clothes-line exhibit and our outdoor performances of both puppet shows at the Timothy Vogler House.

The new committee held its first meeting in May to make plans for the year. Our group of 21 puppeteers was divided into two troupes and a school workshop group. Ann Hensel was appointed to do the scheduling.

In July the co-chairmen attended the Puppeteers of America Festival in Waterloo, Ontario, Canada.

Both troupes met again in September for a workshop and the casting of both shows, "Jack and the Beanstalk" and "The Hungriest Dragon in Town."

During the fall the committee purchased a tape recorder and taped all the music for both plays. "The Carrousel Waltz" was adopted as theme music for all League puppet productions. Also, during the fall, a new lighting system was designed and built. The committee felt this a good year to upgrade its technical equipment since we did not have to bear the expense of mounting a new show this year.

In November, a production of "Jack and the Beanstalk" was presented for the Piedmont Craftsmen Fair.

Both troupes received invaluable help and direction from Mrs. Robert Kerr who has been a professional puppeteer.

"The Hungriest Dragon in Town" began its season in December and trouped to 20 schools from that time until March. Also during December this group presented its play for the Jaycees' Christmas Party for underprivileged children. "Jack" trouped to 21 schools throughout January, February and March. Correlation sheets were mailed to the schools before every performance.

Each group trouped one day a week for approximately eight weeks. Three different schools were reached each trouping day. Both troupes combined gave 42 performances to approximately eleven thousand children. This included public elementary schools, parochial schools, selected kindergartens, Day Care centers, and the Children's Center for the handicapped.

The hard work and active interest of the entire committee made this a most successful and enjoyable year.

RUMMAGE SALE

The Rummage Sale was held March 22nd and 23rd at the Memorial Coliseum. This was the second year the Sale was held at the Coliseum. The majority of girls who responded to questionnaires last year were in favor of having the Sale there again. We moved large furniture and appliances and hose downstairs which left our hallways virtually clear. An all out effort was made to entice husbands to work at the Sale. A "work list" of about thirty jobs was posted and all were filled. These men were invaluable in taking up money, assisting at cash registers and bagging. Our quota was raised to \$40.00 this year and was exceptional — both in quality and quantity. It was marked again by a system of set prices. Four prizes were offered for the most rummage, and these were won by Erline Parnell, Carolyn Carter, Ann Miller and Lou Johnson.

Our customers, Friday night, seemed to be fewer in number, but Coliseum officials thought we had almost as many as last year. Proceeds were up from last year's opening night. Saturday was very light in financial intake, giving us a gross of \$13,811.71. There are many reasons posed for the further decrease of income, but none appear to apply to set-up or rummage offered. Leftovers went to Goodwill and ESR.

We felt that the Sale was a huge success in that everyone seemed busy but happy. Our committee chairmen were so organized and efficient that this has been called one of the smoothest sales ever. Our chairmen were so good we often wondered if we were needed at all. A special thanks to last year's Chairman, Dottie Crone, who took on much more than her share of responsibility in helping us supervise the Sale. And, of course, our sincere gratitude to all of you who made the Sale possible.

BYLAWS

THE JUNIOR LEAGUE OF WINSTON-SALEM, INC.

Those portions of the Bylaws printed in capitals are incorporated from the Bylaws of A. J. L. A.

ARTICLE I - NAME

THE NAME OF THIS ORGANIZATION SHALL BE THE JUNIOR LEAGUE OF WINSTON-SALEM, INCORPORATED, hereinafter called the Junior League.

ARTICLE II — OBJECT AND POLICIES

Section 1. Object

THE OBJECT OF THE JUNIOR LEAGUE SHALL BE TO FOSTER INTEREST AMONG ITS MEMBERS IN THE SOCIAL, ECONOMIC, EDUCATIONAL, CULTURAL, AND CIVIC CONDITIONS OF THE COMMUNITY AND TO MAKE EFFICIENT THEIR VOLUNTEER SERVICE.

Section 2. Policies

THE POLICIES OF THE JUNIOR LEAGUE SHALL BE IN HARMONY WITH THE POLICIES OF THE ASSOCIATION OF THE JUNIOR LEAGUES OF AMERICA, INCORPORATED, hereinafter called the Association.

ARTICLE III — MEMBERSHIP

Section 1. Classes of Membership

ONLY WOMEN UNDER 40 YEARS OF AGE WHO SHALL COMPLY WITH THE REQUIREMENTS OF THE ASSOCIATION SHALL BE ADMITTED TO MEMBERSHIP BY THE JUNIOR LEAGUE. NO MEMBER SHALL AT ANY TIME BE A MEMBER OF MORE THAN ONE JUNIOR LEAGUE. THE CLASSES OF MEMBERSHIP SHALL BE AS FOLLOWS:

(a) Provisional

PROVISIONAL MEMBERS ARE THOSE WHO ARE ENGAGED IN COMPLYING WITH THE REQUIREMENTS FOR ADMISSION TO ACTIVE MEMBERSHIP, AND ARE NOT ELIGIBLE TO VOTE OR HOLD OFFICE. PROVISIONAL MEMBERS SHALL BE REQUIRED TO COMPLETE A PROVISIONAL COURSE WHICH SHALL MEET THE STANDARDS SET BY THE ASSOCIATION, AND SHALL PERFORM VOLUNTARY SERVICE FOR A PERIOD AND IN A MANNER SATISFACTORY TO THE PLACEMENT COMMITTEE within twelve months after their election to Provisional membership. An extension of time may be granted by the Board of Directors in the case of Provisionals who for unavoidable reasons are unable to complete the Course. Provisionals who have completed these requirements are admitted to active membership by a three-fourths vote of the Board of Directors. Those members failing to meet the Provisional requirements shall be dropped from membership upon a three-fourths vote of the Board of Directors and may not come up again for membership within two years.

(b) Active

ACTIVE MEMBERS ARE THOSE WHO HAVE COMPLETED THE REQUIREMENTS FOR PROVISIONAL MEMBERSHIP AND WHO, HAVING BEEN ADMITTED TO ACTIVE MEMBERSHIP, JUSTIFY SUCH MEMBERSHIP THROUGH SERVICE TO THEIR COMMUNITIES UNTIL THEIR 40th BIRTHDAY.

A JUNIOR LEAGUE MAY EXTEND THE ACTIVE MEMBERSHIP OF ANY MEMBER UNTIL THE END OF THAT LEAGUE'S ADMINISTRATIVE YEAR. ANY ACTIVE MEMBER WHO HOLDS A POSITION AS AN OFFICER, DIRECTOR OR MEMBER OF AN ELECTED COMMITTEE OF A JUNIOR LEAGUE OR A REGIONAL NOMINATING COMMITTEE IMMEDIATELY PRIOR TO HER 40th BIRTHDAY SHALL BE CONSIDERED AN ACTIVE MEMBER FOR ALL PURPOSES UNTIL THE COMPLETION OF SUCH TERM.

(c) Sustaining

SUSTAINING MEMBERS ARE THOSE WHO HAVE REACHED THE AGE LIMIT FOR ACTIVE MEMBERSHIP. THEY SHALL HAVE ALL PRIVILEGES OF MEMBERSHIP EXCEPT THAT THEY MAY NOT HOLD OFFICE OR VOTE.

Section 2. Admission to Membership

(a) Eligibility

A proposed member shall be from 19 through 32 years of age on or before her proposal on July 1. She shall have completed her schooling or be in her last year of school. She shall have been a resident of Winston-Salem or its vicinity for at least two years immediately prior to the time of her proposal. In the case of a proposed member who has lived in Winston-Salem or its vicinity at least ten years and has returned after residing elsewhere, the two-year residency requirement prior to proposal shall not apply. At the time of invitation, a proposed member must be residing in Winston-Salem or its vicinity, except in the case of a proposed member whose home is in Winston-Salem or its vicinity but who is away completing her last year of school. (Exceptions: See S.A.I.F. proposal — Section 2 (b).

(b) Use of Standard Admissions Information Form

- (1) For the purpose of recommending, the Admissions Committee may review and pass a candidate and, if unable to admit her because she no longer resides in the city at the time of invitation, it may by means of the Standard Admissions Information Form, call attention to the availability of this candidate to the Admissions Committee of the Junior League in whose city she may then be residing. She must have resided in another city no longer than one year immediately prior to her proposal.
- (2) The Admissions Committee may, at its discretion, waive the "length of residence" requirement for a candidate on whom the Committee has received a S.A.I.F. from another Junior League. The candidate must meet all other conditions of eligibility and must be proposed and considered by the Admissions Committee in accordance with the Bylaws of the Junior League of Winston-Salem.

(c) Proposal of Members

Each candidate shall be proposed by one member and seconded by two members on an application blank provided for the purpose. During a given year, any eligible Active or Sustaining member may: 1) propose one candidate and second one candidate, or 2) second two candidates. No candidate shall be proposed or seconded by a member of the Admissions Committee, nor of the Executive Committee, nor by her relative (mother, mother-in-law, sister, sister-in-law, aunt, niece, or first cousin). No candidate shall be considered whose name has been proposed and voted on four times. (See Standing Rules: ARTICLE III, Section 1.)

(d) Election To Membership

Eight affirmative votes of the Admissions Committee shall qualify a proposed candidate for membership. Before the

candidate accepts the invitation, she shall agree to fulfill the duties and obligations of membership. The names of those who accept shall be announced at the Annual Meeting. (See Standing Rules: ARTICLE III, Section 2.)

Section 3. Privileges of Membership

A MEMBER IN GOOD STANDING WHO IS SUBJECT TO CHANGE IN RESIDENCE MAY BE GRANTED upon application in writing to the Corresponding Secretary and upon approval by the Board of Directors ONE OF THE FOLLOWING PRIVILEGES:

(a) TRANSFER

PROVISIONAL, ACTIVE, AND SUSTAINING MEMBERS SHALL HAVE THE PRIVILEGE OF TRANSFERRING MEMBERSHIP FROM ONE JUNIOR LEAGUE TO ANOTHER, EXCEPT FOR THE PERIOD SUBSEQUENT TO MARCH 1 AND PRIOR TO APRIL 15, THE PRIVILEGE OF TRANSFER NEED NOT EXTEND TO A PERSON WHO HAS BEEN DROPPED OR EXPELLED FROM MEMBERSHIP BY THE JUNIOR LEAGUE TO WHICH TRANSFER IS DESIRED.

THE RECEIVING JUNIOR LEAGUE MUST ACCEPT AND ACKNOWLEDGE THE TRANSFER OF MEMBERSHIP WITHIN 90 DAYS OF RECEIPT OF THE TRANSFER CARD.

Upon acceptance into the Junior League of Winston-Salem, all Active Transfers shall attend the Provisional Community Course, unless they have previously completed the Provisional Course of the Junior League of Winston-Salem. All Provisional Transfers shall pay a transfer fee of \$15.00. All Active Transfers shall pay a transfer fee of \$10.00.

(b) INTER-LEAGUE

PROVISIONAL, ACTIVE AND SUSTAINING MFMBERS WHO WILL BE RESIDING TEMPORARILY IN THE AREA OF ANOTHER JUNIOR LEAGUE MAY BE GRANTED THE INTER-LEAGUE PRIVILEGE FOR A PERIOD NOT TO EXCEED ONE YEAR. THE PERIOD MAY BE EXTEND-ED BY THE SENDING JUNIOR LEAGUE FOR ONE ADDI-TIONAL YEAR.

A MEMBER GRANTED THE INTER-LEAGUE PRIVILEGE SHALL COMPLY WITH THE REQUIREMENTS OF THE RECEIVING JUNIOR LEAGUE AND SHALL BE ENTITLED TO ALL PRIVILEGES OF MEMBERSHIP EXCEPT THE RIGHT TO VOTE, HOLD OFFICE AND PROPOSE OR SFCOND CANDIDATES FOR MEMBERSHIP IN THE RECEIVING JUNIOR LEAGUE. SHE SHALL BE LISTED AS A MEMBER OF AND PAY DUES TO THE SENDING JUNIOR LEAGUE WHICH SHALL HAVE FINAL RESPONSIBILITY FOR HER IN ALL MATTERS.

All Inter-League members to the Junior League of Winston-Salem shall pay a fee of \$5.00 upon initial acceptance.

(c) Non-Resident

ACTIVE AND SUSTAINING MEMBERS WHO ARE LIVING AT A DISTANCE FROM THEIR JUNIOR LEAGUE AREA SHALL BE GRANTED THE NON-RESIDENT PRIVILEGE. NON-RESIDENT ACTIVE MEMBERS WHO LIVE IN AN AREA IN WHICH THERE IS A JUNIOR LEAGUE MAY RETAIN THE PRIVILEGE FOR A PERIOD NOT TO EXCEED TWO YEARS.

Non-resident members may not vote or hold office. (See Association Procedures) Association Procedures).

Section 4. Resignations, Removals, and Reinstatements

(a) Resignations

Any member of the Junior League who is not in arrears in dues or in the performance of Junior League duties may resign in good standing. Resignations shall be made in writing to the Corresponding Secretary of the Junior League at least two weeks before dues become payable; otherwise members shall be liable for dues for the coming year.

(b) Suspension and Removal

A member may be suspended or removed only by a three-fourths vote of the Board of Directors after fifteen days' notice to such member in writing, stating the cause for such action.

(c) REINSTATEMENTS

Any Active or Sustaining member who has resigned while in good standing may be reinstated by a three-fourths vote of the Board of Directors upon paying a reinstatement fee of \$25.00 plus \$5.00 per year for each year out of the Junior League. The total of all charges shall not exceed \$75.00.

Provisional members who have resigned in good standing may be reinstated within the Provisional age limit (through age 32) by a three-fourths vote of the Board of Directors upon paying a reinstatement fee of \$5.00 per year for each year out of the Junior League.

ARTICLE IV — DUES AND CHARGES

Section 1. Annual Dues

(a) Amount

Annual dues, which include Association dues, shall be \$20.00 for all classes of membership. Provisional members shall also pay an initiation fee of \$25.00.

(b) PAYMENT

Dues shall be payable on the first day of the fiscal year. (See Bylaws: ARTICLE IX, Section 1.) The Assistant Treasurer shall send notices to each member on April 1. Members whose dues and fines are not paid by May 1 will be notified by card by the Assistant Treasurer. Members whose dues and fines are not paid by May 15 will be sent a certified letter. Members whose dues and fines are not paid by June 1 will be dropped from membership by the Board of Directors. The only acceptable excuse for non-payment is financial disability, made in writing each year, and received by the Assistant Treasurer on or before June 1.

(c) Refunds

Refunds of dues will not be made to members resigning during the fiscal year.
Refunds will not be made to Provisionals failing to meet the requirements.

Section 2. Indebtedness to the Association

MEMBERS WHO ARE DELINQUENT IN PAYING ANY INDEBT-EDNESS TO THE ASSOCIATION SHALL BE CONSIDERED IN ARREARS IN THEIR DUES TO THE JUNIOR LEAGUE.

ARTICLE V — OFFICERS

Section 1. Personnel

The officers shall consist of a President, Vice President, Recording Secretary, Corresponding Secretary, Treasurer, and Assistant Treasurer.

Section 2. Nomination

The Nominating Committee shall present a slate of one candidate for each office to be filled. The slate shall be sent to each voting member of the Junior League at least three weeks before the election meeting.

Independent nominations with the consent of the nominee may be made in writing by five Active members. They shall be received by

the Recording Secretary at least two weeks prior to the election meeting and shall be mailed by her to each Active member at least one week prior to the election meeting.

Section 3. Election

Officers shall be elected at the March meeting of the Junior League for a term of one year, with the exception of the Treasurer, who shall be elected for a term of two years. They shall assume their duties immediately after the May meeting.

Section 4. Duties

The powers and duties of the officers shall be as follows:

(a) PRESIDENT

The President shall preside at meetings of the Junior League, Board of Directors, and Executive Committee; shall appoint the committee chairmen with the approval of the Executive Committee, and shall be a member ex-officio of all committees except the Nominating Committee and Admissions Committee. She shall, with the Treasurer, sign all contracts and obligations authorized by the Board of Directors, and shall perform the duties pertaining to the office. (See Standing Rules: ARTICLE V, Section 1.)

(b) VICE PRESIDENT

The Vice President shall assist the President and perform the duties of the President in her absence. She shall preside at meetings of the Junior League's Professional members.

(c) RECORDING SECRETARY

The Recording Secretary shall keep minutes of the meetings of the Junior League, the Board of Directors, and the Executive Committee. She shall maintain a file of essential records which shall be transferred to her successor at the close of her term of office. She shall, with the Corresponding Secretary, compile the annual reports and assist in editing the year book.

(d) Corresponding Secretary

The Corresponding Secretary shall conduct the general correspondence of the Junior League. She shall assist in compiling the annual reports and editing the year book. She shall keep a correct, classified list of the names and addresses of all members and shall handle all correspondence in regard to changes in membership.

(e) Treasurer

The Treasurer shall be custodian of the funds of the Junior League and shall receive all monies except those from activities which have their own treasurer or other person specifically appointed to handle finances. Such persons shall be under supervision of the Treasurer. She shall serve as Chairman of the Finance Committee. She shall make payments in accordance with the budget; expenses not provided for in the budget shall be incurred and paid only upon order of the Board of Directors. She shall keep full and accurate accounts and shall present financial statements at regular meetings of the Junior League and Board; she shall turn over to her successor all books and financial records. (See Standing Rules: ARTICLE V.)

(f) Assistant Treasurer

The Assistant Treasurer shall collect all dues and assessments, check attendance records, assist the Treasurer, and serve as Chairman of the Ways and Means Committee.

Section 5. Vacancies

Vacancies among the officers other than the President shall be filled by election by the Board of Directors upon recommendation of the Nominating Committee.

ARTICLE VI — BOARD OF DIRECTORS

Section 1. Personnel

The Board of Directors shall consist of the officers and the chairmen designated by the Executive Committee each year, Chairmen are appointed by the President with the approval of the Executive Committee.

Section 2. Term of Office

Officers are elected for a term of one year (See ARTICLE V, Section 3). Chairmen shall be appointed for a term of one year. No officer or chairman shall hold the same office for more than two terms in succession.

Section 3. Duties

The Board of Directors shall have general charge and control of the affairs, funds, and property of the Junior League. IT SHALL PRESENT TO THE MEMBERSHIP ALL PROPOSED MAJOR PROGRAM ACTIVITIES FOR RATIFICATION. THE REGIONAL DIRECTOR SHALL BE INVITED TO VISIT THE JUNIOR LEAGUE DURING HER TERM OF OFFICE. ACCEPTANCE OF SUCH INVITATION SHALL BE AT THE DISCRETION OF THE DIRECTOR. (See Standing Rules: ARTICLE VI.)

Section 4. Vacancies

Vacancies among the Board of Directors may be filled by the President with the approval of the Executive Committee. Persons so elected shall serve until the expiration of the original term of the office.

Section 5. Meetings

The Board of Directors shall hold regular monthly meetings from September through May. Special meetings may be called by the President and shall be called upon the written request of three members of the Board.

Section 6. Executive Committee

There shall be an Executive Committee, composed of the officers, which shall assist the President in making appointments and in creating other committees not otherwise provided for. It shall have all the powers of the Board of Directors between regularly scheduled Board meetings. The minutes of meetings of the Executive Committee shall be submitted to the Board for ratification at its next meeting.

Section 7. Quorum

Eight members of the Board of Directors and three members of the Executive Committee shall constitute a quorum, respectively.

ARTICLE VII — COMMITTEES

Section 1. Standing Committees

Standing committees are those whose activities are permanent in the program of the Junior League. With the exception of those required by the Association, they may be created or dissolved as the need indicates by the President, with the approval of the Board of Directors. These committees shall present plans for work to the Board of Directors for their approval.

(a) Admissions Committee THERE SHALL BE AN ADMISSIONS COMMITTEE, WHOSE FUNCTION SHALL BE TO CONSIDER THE QUALIFICATIONS OF ALL CANDIDATES PROPOSED TO MEMBERSHIP IN THE JUNIOR LEAGUE AND ELECT NEW MEMBERS.

(1) Personnel of Committee
The committee shall be composed of twelve members: a
chairman, who shall be appointed by the Executive Com-

mittee, and shall not be entitled to vote; two Sustaining members who shall be elected by the Junior League and shall not be entitled to vote; and nine voting members, who shall be elected by the Junior League as provided in the Standing Rules (See Standing Rules: ARTICLE VII, Section 1., and COMMITTEE POLICIES: Admissions.)

Vacancies on the Admissions Committee shall be filled by the alternates in the age categories concerned. No sponsor of a candidate shall be eligible to fill a vacancy on this committee.

(b) Advisory Planning Committee

There shall be an Advisory Planning Committee, whose function shall be to help the Board improve present Junior League administration and program and to plan for the future. The committee receives assignments from the Board of Directors and makes recommendations to the Board but does not, itself, take any action.

(c) Arrangements Committee

There shall be an Arrangements Committee, whose function shall be to plan, direct, and coordinate the social activities of the Junior League.

(d) Bylaws Committee

There shall be a Bylaws Committee, whose function shall be There shall be a Bylaws Committee, whose function shall be to study the Junior League's bylaws, policies, and standing rules in relation to (1) their conformance with AJLA bylaws and policies and (2) any contradictions or inconsistencies between them and current Junior League practices and to make any recommendations resulting from such study. Suggested areas of study may be referred to this committee by the Board of Directors.

(e) Community Arts Committee

There shall be a Community Arts Committee, whose function shall be to coordinate the Junior League's projects and activities in the cultural field, other than those under the direction of other committees, and to be alert to the cultural needs in the community.

(f) Education Committee

THERE SHALL BE AN EDUCATION COMMITTEE, WHOSE FUNCTION SHALL BE TO PLAN AND SUPERVISE THE EDUCATIONAL PROGRAM OF THE JUNIOR LEAGUE. The committee shall include committee representatives or those members responsible for any part of the education program.

(g) FINANCE COMMITTEE

THERE SHALL BE A FINANCE COMMITTEE, which shall THERE SHALL BE A FINANCE COMMITTEE, which shall function as the financial fact-finding committee to advise the Board on all matters relating to the financing of the Junior League's own administration and that of its community program. AMONG ITS DUTIES SHALL BE THE INITIAL PREPARATION OF THE ANNUAL BUDGET for presentation to the membership. The committee shall include the Treasurer as chairman, the Assistant Treasurer, the treasurer of any money-raising activity, either permanent or temporary, and a past Junior League Treasurer.

(h) Headquarters Committee

There shall be a Headquarters Committee, whose function shall be to handle Junior League-associated business, to schedule meetings to be held at Timothy Vogler House, to purchase supplies and equipment needed at Headquarters, and to assist in the maintenance.

(i) Newssheet Committee

There shall be a Newssheet Committee, whose function shall

be to prepare and issue a monthly publication, reporting and interpreting the activities and interests of the Junior League and the Association.

(j) Nominating Committee
THERE SHALL BE A NOMINATING COMMITTEE, WHOSE
FUNCTION SHALL BE TO PREPARE SLATES OF CANDIDATES FOR ELECTION TO THE VARIOUS ELECTIVE
OFFICES and committees OF THE JUNIOR LEAGUE, and to
present slates of delegates to Association conferences. (See
COMMITTEE POLICIES: Nominating.) THE COMMITTEE
SHALL ALSO COOPERATE WITH THE REGIONAL NOMINATING COMMITTEE AND WHENEVER POSSIBLE SUGGEST CANDIDATES FOR REGIONAL SLATES. The committee shall be composed of: the chairman to be appointed
by the Executive Committee; one member elected by the
Board; and four members elected by the Junior League, according to their active period in the Junior League of Winston-Salem immediately prior to nomination. No member shall
serve concurrently on the Nominating Committee and the
Admissions Committee. This committee shall be nominated
and elected as designated in the Standing Rules. (See Standing
Rules: ARTICLE VII, Section 2.)

The Placement Chairman shall serve ex-officio and shall attend meetings at the request of the Chairman.

(k) PLACEMENT COMMITTEE
THERE SHALL BE A PLACEMENT COMMITTEE, WHOSE
FUNCTION SHALL BE TO PLAN AND SUPERVISE THE
VOLUNTEER PROGRAM OF THE JUNIOR LEAGUE IN
ORDER TO TRAIN EACH MEMBER IN WAYS MOST VALUABLE TO HER DEVELOPMENT AS A VOLUNTEER. The
Placement Committee shall keep as nearly as possible uniform records concerning the activities of the members under
its supervision. The committee shall include a sufficient number of members for interviewing and follow-up of placements.

(1) PROJECT RESEARCH COMMITTEE

There shall be a Project Research Committee, whose function shall be to review current projects, to investigate possible projects, to study requests, and to make recommendations to the Board and to the membership.

Any recommended project shall be presented at the meeting prior to the one at which the vote is taken. In unusual circumstances, upon the approval of the Executive Committee, members shall receive a full report by mail at least two weeks prior to the meeting at which the vote is to be taken. (See Bylaws: ARTICLE VII, Section 1. (p).)

(m) Provisional Committee
THERE SHALL BE A PROVISIONAL COMMITTEE, WHOSE
FUNCTION SHALL BE TO PLAN AND DIRECT THE EDUCATION AND TRAINING OF PROVISIONAL MEMBERS
UNTIL SUCH TIME AS THEY ARE ADMITTED TO ACTIVE
MEMBERSHIP.

(n) Public Relations Committee
THERE SHALL BE A PUBLIC RELATIONS COMMITTEE,
whose function shall be to evaluate attitudes of members and
the community in relation to the Junior League; identify
the purpose and activities of the Junior League with the
public interest; and plan a program of action to earn understanding and acceptance of the Junior League by the membership and the public. This committee shall arrange for all newspaper, radio, and television promotion for the Junior League.

The Public Relations Committee shall include the Public Relations Chairman, and the Publicity Chairmen of Community Trust committees.

No member of the Junior League shall give out to the press

any news item or information concerning the League without the approval of the Public Relations Committee.

(o) TRANSFER COMMITTEE

There shall be a Transfer Committee, whose function shall be to welcome, introduce, and orient all Transfers. (See COMMITTEE POLICIES: Transfer.)

(p) Ways and Means Committee

There shall be a Ways and Means Committee, whose function shall be to study fund raising activities. This committee is activated when necessary by the Executive Commitee. Fund raising activities may be presented and voted upon at the same meeting, provided prior notice is given to the membership. The Assistant Treasurer shall be the Chairman of the Ways and Means Committee.

Section 2. Special Committees

Special Committees (e.g., Community Trust Projects) shall be appointed by the President with the approval of the Executive Committee which shall determine the powers of the committee (including the right to vote) and the terms of the committee's appointment. The chairmen of these special committees shall sit on the Board of Directors for the duration of their committee's function, but are not members of the Board.

ARTICLE VIII — MEETINGS OF THE JUNIOR LEAGUE

Section 1. Annual Meeting

The annual meeting of the Junior League shall be held in May for the purpose of receiving the annual reports and of installing officers for the ensuing year.

Section 2. Regular and Special Meetings

Regular meetings shall be held from September through May, the March meeting being designated for the election of officers. Other meetings shall be held at the discretion of the Board of Directors or upon written request of ten members of the Junior League.

Section 3. Attendance

All Active and Provisional members shall be required to attend all regularly scheduled and special membership meetings. (See Standing Rules: ARTICLE IV.)

Section 4. Quorum

A quorum of the Junior League shall consist of one-third of the voting members. A quorum must be present in order that business can be legally transacted.

ARTICLE IX — FISCAL POLICIES

Section 1. Fiscal Year

The fiscal year shall be from April 1 through March 31.

Section 2. Accounts and Audit

THE BOOKS AND ACCOUNTS OF EACH JUNIOR LEAGUE SHALL BE KEPT IN ACCORDANCE WITH SOUND ACCOUNTING PRACTICES AND SHALL BE AUDITED ANNUALLY BY A CERTIFIED PUBLIC ACCOUNTANT. EACH JUNIOR LEAGUE SHALL ESTABLISH AND MAINTAIN A COMMUNITY TRUST FUND WHICH SHALL BE SEPARATE AND DISTINCT FROM ITS ADMINISTRATIVE FUND. A COPY OF THE AUDITED FINANCIAL REPORT SHALL BE DISTRIBUTED TO EACH MEMBER OF THE JUNIOR LEAGUE ANNUALLY. All monies raised in the community are returned to the community through the Community Trust Fund.

Section 3. Bonding

The Treasurer shall be bonded, in the amount determined by the Board of Directors.

Section 4. Dissolution

In the event of the dissolution of the Junior League of Winston-Salem, Incorporated, its assets will be distributed to such charitable and educational organizations in the community which are tax exempt for Federal income tax purposes as the Board of Directors shall determine.

ARTICLE X — DELEGATES TO ASSOCIATION CONFERENCES

Section 1. Annual Meeting

The delegates and alternates to the Annual Meeting of the Association shall be Active members elected by the Junior League.

Section 2. Regional Meetings

The delegates and alternates to Regional Meetings shall be Active members selected by the Nominating Committee and approved by the Board of Directors.

Section 3. Special Meetings or Conferences

The delegates and alternates to special meetings or conferences shall be Active members appointed by the Board of Directors. (See FINANCIAL POLICIES: F.)

ARTICLE XI — AMENDMENTS AND PARLIAMENTARY AUTHORITY

Section 1. Amendments

(a) Bylaws

The Bylaws may be amended or rescinded by a two-thirds vote of the members present and voting at any meeting, provided there is a quorum present, and that the proposed amendment has been presented at the previous meeting or mailed to each voting member at least a week prior to the date of the meeting.

(b) STANDING RULES

The Standing Rules may be amended or rescinded by a two-thirds vote at any membership meeting or by a majority vote, if previous notice of the proposed action has been given.

(c) Policies

The Policies may be amended or rescinded by a majority vote of the Board of Directors.

Section 2. Parliamentary Authority

Roberts Rules of Order Revised shall be the parliamentary authority for all matters of procedure not specifically covered by the bylaws or by specific rules of procedure adopted by the Junior League.

STANDING RULES

THE JUNIOR LEAGUE OF WINSTON-SALEM, INC.

These rules are supplementary to the Bylaws and shall be used in conjunction with them.

ARTICLE I — NAME

ARTICLE II — OBJECT AND POLICIES

ARTICLE III — MEMBERSHIP

Section 1. Proposal of Members

- (a) The deadline for applications for those members to be taken in the following May shall be July 1. Only one blank for each candidate shall be accepted by the Admissions Committee.
- (b) Application blanks for proposal of members are available and shall be received by the Chairman of the Admissions Committee at any time during the year.
- (c) No member of this Junior League shall write or contact any member of the Admissions Committee in support of a candidate. (See Bylaws: ARTICLE III, Section 2. (c).)

Section 2. Election to Membership

- (a) The Chairman shall present the names of proposed candidates to the voting members of the Admissions Committee and each shall vote by secret ballot.
- (b) Invitations shall be mailed immediately to those elected.
- (c) Upon receiving an invitation to membership the candidate
 - has the following alternatives:
 (1) to accept the invitation and take the entire Provisional Course.
 - (2) to accept the invitation, take the basic orientation course and transfer to another Junior League as a Provisional. In order to transfer to another Junior League a candi-date must have completed her basic orientation course.
 - to accept the invitation, take the basic orientation course and resign in good standing if moving to a non-Junior League town. (See Bylaws: ARTICLE III, Section 4. (c).)
 - (4) to decline the invitation.
- (d) Upon the written request of the sponsors of a candidate who formerly declined the invitation to membership, the invitation may be re-issued (one time only) by the Board of Directors, provided the candidate still fulfills the eligibility requirements.

ARTICLE IV — DUES AND CHARGES

Section 1. Charges

There shall be a fine of one dollar to each Active member and Provisional member for non-attendance of regular meetings and special meetings, and a fine of two dollars for non-attendance of the annual meeting. Such fines shall be payable monthly. An additional 25-cents penalty for each month a fine is in arrears shall be added.

Absences from Meetings

Sickness, absence from the city, or an unusual emergency shall be the only acceptable excuses for an absence. A written explanation of absence shall be made to the Assistant Treasurer and received no later than one week following the meeting.

ARTICLE V — OFFICERS

Section 1. President and Treasurer

It shall be the responsibility of the President and the Treasurer to keep in communication with the auditor and the legal counsel regarding current practices concerning Junior League affairs.

Section 2. Treasurer

It shall be the responsibility of the Treasurer to see that IRS Form 990-A is filed each year by the auditor.

Section 3. Corresponding Secretary

It shall be the responsibility of the Corresponding Secretary, before granting any change in membership status, to consult with the Placement Chairman and the Assistant Treasurer.

ARTICLE VI — BOARD OF DIRECTORS

Section 1. Duties

- (a) It shall be the duty of the Board of Directors to act as final arbiter in interpreting the Bylaws and to enforce the Bylaws of the Junior League and the Association Policies binding on all Junior Leagues.
- (b) It shall be the duty of the Board of Directors to create, maintain, evaluate, and revise the Manual of Procedure by which it carries out the duties and powers delegated to it in the Bylaws and the Standing Rules.
- (c) It shall be the duty of the Board of Directors in drawing up the program, to give serious consideration to the interest and capacities of the members, and the number who can take an active part.
- (d) It shall be the duty of the Board of Directors to see that a contingency reserve be maintained in the Community Trust Fund.
- (e) It shall be the duty of the Board of Directors to retain an auditor, legal counsel, and other counsel as deemed necessary.
- (f) It shall be the duty of the Board of Directors to approve any committee request for unbudgeted funds. Any request of \$200.00 and over must be presented to the membership for approval.

Section 2. Contracts

- (a) It shall be the duty of the Board of Directors to approve any letter, agreement, or contract involving the expenditure of Junior League funds before said letter, agreement, or contract is signed or delivered.
- (b) The wording of any contract involving community commitments should be approved by the legal counsel retained by the Junior League.

ARTICLE VII — COMMITTEES

Section 1. Admissions Committee

(a) Eligibility To Serve On Committee

- (1) To be eligible for election to the Admissions Committee, a member must have been active in the Winston-Salem League for at least three years and a resident of Winston-Salem or its vicinity for at least five years. A voting member shall be eligible to serve for two consecutive years, and shall be ineligible to serve for the following year, except as Chairman. After her term, the Chairman shall be ineligible to serve for the following year.
- (2) One Sustaining member shall have been sustaining no longer than ten years, and one no less than ten years. Each shall have served on the Admissions Committee during her active membership.
- (3) No one who has a sister, sister-in-law, daughter, daughter-in-law, or niece proposed for membership shall serve on this committee.
- (4) No mother and daughter nor two or more sisters shall serve on the same Admissions Committee.
- (5) Neither the President nor the Vice President shall be eligible to serve on this committee.

(b) ELECTION OF COMMITTEE

- (1) Election of this committee shall be held at the April meeting. Two weeks prior to the March meeting the Nominating Committee shall mail to all Active members a list of those members of the present Admissions Committee who are eligible for re-election (See Standing Rules: ARTICLE VII, Section 2. (b) and a list divided into three age groups of all other Active members eligible for election. These age groups shall be as follows: 21 to 31, 31 to 36, 36 to 39. At the March meeting each Active member present may nominate, by secret ballot, four members from her own age group and five members from the present Admissions Committee.
- (2) At the April meeting the Nominating Committee shall present the final ballot of four nominees in each age group, five nominees from the present Admissions Committee, and three eligible Sustaining members in each category. Each Active member present shall vote for two nominees from each age group, for three nominees from the present Admissions Committee, and for one Sustaining member in each category.
- (3) In the event that close relatives are nominated to this committee, it shall be the duty of the Nominating Committee to determine which of them shall appear on the final ballot.
- (4) In case of a tie vote, in either nomination or election of this committee, it shall be the duty of the Nominating Committee to determine which members shall serve.

Section 2. Nominating Committee

- (a) The four members of this committee elected by the Junior League according to their active period in the Junior League of Winston-Salem immediately prior to nomination shall be from the following categories: one Active from three through six years; one Active from seven through nine years; and two Active over nine years.
- (b) Two weeks prior to the January meeting a roster of Junior League members eligible to serve on the Nominating Committee shall be mailed by the current Nominating Committee to all Active members. Names of those eligible to serve a second term on the Admissions Committee shall not appear on this ballot.
- (c) At the January meeting each member may nominate the number to be elected from each group.
- (d) The three candidates receiving the highest number of votes in the first two groups and the four candidates receiving the highest number of votes in the third group will appear on the final ballot for election in February.

ARTICLE VIII — MEETINGS OF THE JUNIOR LEAGUE

ARTICLE IX — FISCAL POLICIES

ARTICLE X — DELEGATES TO ASSOCIATION CONFERENCES

Section 1. Annual Meeting

The President shall attend the Annual Meeting as the voting delegate. In the event the President is unable to attend, the Vice President shall assume the duties of the voting delegate.

ARTICLE XI — AMENDMENTS AND PARLIAMENTARY AUTHORITY

POLICIES

THE JUNIOR LEAGUE OF WINSTON-SALEM, INC.

Policies are the additional procedures individual committees follow to assure continuity of intention and practice in an organization whose personnel and leadership changes frequently. They clarify the intent of both the Bylaws and the Standing Rules. They may be altered by the Board of Directors.

GENERAL MEMBERSHIP POLICIES

- A. No member of the Junior League shall give out to the press any news item or information concerning the Junior League without the approval of the Public Relations Committee.
- B. A Junior League membership list is for the use of the Junior League and cannot be used for promotion of any activity unrelated to the Junior League. It shall not be used for personal gain or made available for commercial or solicitation purposes. (Association Policy VI, B., binding on all Junior Leagues.)
- C. It is the responsibility of the membership to propose qualified candidates for admission.
- D. All members of the Junior League shall respect the sworn secrecy and the decisions of the Admissions Committee.
- E. Guests at Junior League meetings or social functions shall be limited to out-of-town guests of Junior League members or guests involved in a specific program and approved by the President and Education Chairman.

FINANCIAL POLICIES

- A. The Junior League of Winston-Salem, Incorporated, shall not act for others as a fund raising agent. The Junior League shall not make financial contributions from its Community Trust Fund to individuals, other organizations, or agencies except those projects with which the Junior League is aligned as a group or for which the Junior League plans to take major responsibility.
- B. A fund raising activity must be voted on annually.
- Requests for money or reimbursement shall be made in writing to the Treasurer.
- D. Each Chairman shall be sure that expenditures are justified. All the money in a committee budget does not have to be spent. Any money left in a committee budget at the end of a fiscal year reverts to the treasury.
- E. The cost of Junior League social functions shall not be paid from the treasury, but assumed by the individual member.
- F. All conference and the Association Annual Meeting expenses (registration fees, transportation, meals, lodging, etc.) shall be assumed by the Junior League.

COMMITTEE POLICIES

A. Admissions

1. A secretary shall be appointed by the Admissions Chairman from among the members of the Admissions Commit-

tee. She, with the Chairman, shall be responsible for keeping an accurate record of all names considered by the committee. These records shall be held in a permanent file which shall be kept confidential and handed from chairman to chairman for reference by the Admissions Committee.

- 2. Members of the Admissions Committee shall take an oath of secrecy, as follows: "I swear that, to the best of my ability, nothing which is said in these Admissions Committee meetings shall be divulged by me, either by statement or implication. I swear that to the best of my ability, my vote will be cast considering the best interest of the Junior League, disregarding my personal feelings."
- 3. The Admissions Committee shall hold at least eight meetings during the year.

B. CHILDREN'S THEATRE

The Children's Theatre Committee presents annually a play for the Children's Theatre Board. All classes of Junior League membership are eligible for the cast and crew.

C. HEADQUARTERS

The use of Timothy Vogler House is limited to the Junior League unless requested by the Board of Directors of Old Salem, Incorporated, and approved by the Board of Directors of the Junior League of Winston-Salem.

D. NEWSSHEET

All the material printed in the Newssheet shall remain the property of the Winston-Salem Junior League and shall be reprinted only with permission of the Executive Committee.

E. Nominating

It shall be the duty of the Nominating Committee to insure continuity of administration by retaining one or more members of the Executive Committee for two terms.

F. PLACEMENT

- 1. Placement volunteer work is not measured in terms of hours, but in terms of service in the Junior League and community throughout the year.
- 2. Each individual member has the right to choose from available and acceptable jobs those activities which best suit her own interests and talents.
- 3. Those members unable to meet their placement obligations shall give to the Placement Chairman a verbal or written explanation.
- 4. It shall be the obligation of all Active and Provisional members to assist with any Junior League money raising activities.

G. PROJECT RESEARCH

When the Junior League votes to assume a project, the members shall be responsible for providing any specified volunteer service through placement.

H. Provisional

A Junior League committee chairman or committee member must obtain permission from the Provisional Chairman before requesting a provisional to do any volunteer work or participate in regular Junior League work during her provisional year.

I. PUBLIC RELATIONS

A channel (e.g., suggestion box) should be offered to individual Junior League members through which suggestions and ideas may be sent to the Board.

J. RUMMAGE SALE

- 1. The quota shall be \$40.00 for all Active and Provisional members. (\$5.00 of this quota shall be in household goods.)
- 2. Junior League members, other than non-resident, Inter-League, and Sustaining, who do not complete their Rummage Sale quota, will be allowed to do so before the sale at the discretion of the Quota Chairman.
- 3. All Active and Provisional members are responsible for preparation of the sale and for working designated shifts during the sale.

K. Transfer

The Junior League orientation for transfers shall be the responsibility of the Transfer Committee. Transfers shall not be required to fulfill placement obligations while attending the Provisional Community Course.

ASSOCIATION POLICIES BINDING ON ALL LEAGUES

POLICY I — GENERAL

- A. The Association shall act in an advisory capacity to the Junior Leagues except as otherwise stated in the Bylaws, Policies, Standing Rules, and Procedures adopted pursuant thereto.
- B. The Association shall have the right to protect the Junior Leagues from action by one Junior League which may adversely affect the program, standing, or fund raising of other Junior Leagues.
- C. The Junior Leagues shall encourage their members to accept the responsibilities of good citizenship and to educate themselves in all legislative, political, and governmental movements which affect the life of their communities, their countries, and the world, and shall endeavor to stimulate their members to exercise their respective citizenship intelligently.

POLICY II — COOPERATION AND SPONSORSHIP

- A. The Association may participate in, cooperate with, or sponsor any organization, movement, or programs, which in the judgment of the Board of Directors, as represented by a three-quarter affirmative vote of the members of the board, will further the purpose of the Association. The board will inform any such organization that active participation by the individual Junior Leagues is optional. The Association shall not engage in legislative action.
- B. With respect to a conference, meeting, or institute of any state, national, or international organization, a Junior League may:
 - (a) sponsor or co-sponsor the conference, meeting, or institute
 - (b) cooperate with the sponsoring organization
 - (c) participate in the conference, meeting, or institute
 - (d) hold a meeting of Junior League members in connection with any such conference, meeting, or institute provided that the Junior League first obtains pertinent information from the Association Executive Director and clearance from its Regional Director.

POLICY III — ACTION

A Junior League may take action on a national, international, state, or local public question, provided that a study of the specific problems and the legislative or administrative measures involved has been made, and that the action taken by that Junior League is compatible with the stated purpose of the Association and its member Junior Leagues; does not adversely affect any other Junior League; is not contrary to the policies of the Association; and is subject to the following:

- 1. Action may be taken on a national or international public question provided the Junior League has first obtained approval from the Board of Directors of the Association as represented by a three-quarter affirmative vote of the members of the board.
- 2. Action may be taken on a state public question provided the Junior League consults its Regional Director and follows Association legislative procedures.
- 3. Action may be taken on a local public question at the discretion of the Junior League.
- 4. Action may not be taken in support of or in opposition to a candidate for public office.

POLICY IV — FINANCIAL

- A. The Association shall not act for others as a fund-raising agent.
- B. The Association shall not make financial contributions to individuals, other organizations, or agencies. Financial support may be rendered for direct services.

POLICY V — PUBLIC RELATIONS AND PUBLICITY

- A. The Association shall endeavor to protect the name "Junior League" from misuse and shall take all action which may be advisable to that end.
- B. All references to the Association should be based on facts in current material made available from the Association. This material can be secured from the Regional Directors or the Association office.
- C. Any use of the Junior League name in connection with publicity shall identify the Junior League or Junior Leagues involved.
- D. Any publicity of a Junior League designed to extend beyond its community area must be approved by the Association office.
- E. A Junior League member may publicly identify herself as such only when such identification is in connection with an affiliation or activity compatible with the stated purpose of the Association and its member Junior Leagues and the policies of the Association.

POLICY VI — COMMERCIAL ATTACHMENTS AND MONEY RAISING

- A. The Association shall not recommend the exclusive use of a specific commercial product nor the services of a specific commercial concern.
- B. A Junior League membership list is for the use of the Junior League only and cannot be used for promotion of any activity unrelated to the Junior League. It shall not be used for personal gain or made available for commercial or solicitation purposes.

- C. A Junior League may cooperate with commercial concerns, provided the attachment is consistent with the standards of quality and dignity expressed by the Junior Leagues and the Association, and does not recommend exclusive use of a specific product or concern.
 - 1. Sponsorship of a Junior League activity by reputable firms is permitted for local broadcast, telecast, or other media of communication.
 - 2. Sponsorship of a Junior League activity by reputable firms on a regional, national, or international basis is permitted provided such sponsorship has been approved by the Association office.
 - 3. Direct selling in a commercial portion of a radio or television program or in other media of communication, is permitted so long as it is in keeping with the quality of the presentation itself, features articles in good taste, and does not recommend the exclusive use of a product by the Association, any member Junior League, Junior League member, or person representing the Junior League. Samples of the commercial copy must be submitted for approval by the sponsoring Junior League to the Association office.
- D. A Junior League member may be identified as such in commercial endorsements, only in Junior League publications and/or in connection with Junior League money-raising activities. No Junior League member may be identified as such for personal gain.

POLICY VII — MINIMUM STANDARDS OF CHARTER, CONSTITUTION, OR BYLAWS

Each member Junior League shall incorporate in its charter, constitution, or bylaws, the following material:

- A. A statement of its name, which shall include the words "Junior League of (name of city, town, or community in which located)."
- B. A statement of its purposes, which shall include the statement of individual purposes stated in ARTICLE I, Section 1, of the bylaws of the Association.
- C. A statement that its policies shall be in harmony with the policies of the Association.
- D. Provisions complying with the requirements of ARTICLE II-B of the bylaws of the Association. (No other classes of membership shall be permitted; provided, however, that (a) individual Junior Leagues may have a limited number of Honorary members, and (b) Junior Leagues which as of April, 1947 had other classes, including Life members, may continue such classes for their present membership, but shall not admit any additional members thereto.)
- E. A requirement that all Provisional members shall complete a course which shall meet the standards set by the Association, and shall perform voluntary service for a period and in a manner satisfactory to the Placement Committee.
- F. A requirement that all Active members shall justify their membership through some form of community service satisfactory, in quality and extensiveness, to the Placement Committee. Community service is defined as including volunteer work for, and service on boards and committees of, any charitable or educational organization of high standing.
- G. A requirement for the following committees:
 - (1) An Admissions Committee, whose function shall be to consider the qualifications of all candidates proposed to mem-

- bership in the Junior League and elect new members or recommend candidates to the board for election.
- (2) An Education Committee, whose function shall be to plan and supervise the educational program of each Junior League.
- (3) A Finance Committee, among whose duties shall be the initial preparation of the annual budget of each Junior League.
- (4) A Nominating Committee, whose function shall be to prepare slates of candidates for election to the various elective offices of the Junior League. The committee shall also cooperate with the Regional Nominating Committee and whenever possible suggest candidates for regional slates.
- (5) A Placement Committee, whose function shall be to plan and supervise the volunteer program of the Junior League in order to train each member in ways most valuable to her development as a volunteer.
- (6) A Provisional Committee, whose function shall be to plan and direct the education and training of Provisional members until such time as they are admitted to Active membership.
- (7) A Public Relations Committee.
- H. The books and accounts of each Junior League shall be kept in accordance with sound accounting practices and shall be audited annually by a certified public accountant. Each Junior League shall establish and maintain a Community Trust Fund, which shall be separate and distinct from its Administrative Fund. A copy of the audited financial report shall be distributed to each member of the Junior League annually.
- I. A requirement that the board of each Junior League shall present to the membership all proposed major program activities for ratification.
- J. The Regional Director shall be invited to visit each Junior League in her region during her term of office. Acceptance of such invitation shall be at the discretion of the director.

POLICY VIII — OTHER MINIMUM STANDARDS

- A. The course for Provisional members of all Junior Leagues shall be based upon all topics covered in the Association's Basic Provisional Course Outline. Each Junior League shall send to the Association annually an outline of its Provisional Course as soon as reasonably possible after the completion of the course.
- B. The Placement Committee of each Junior League shall interview all Active members at regular intervals in order to plan and supervise their free choice of community service as defined in Policy VII-F, and shall keep as nearly as possible uniform records concerning their activities.
- C. No individual Junior League shall associate itself with, or endorse, any welfare or other similar project, program, or activity which does not meet accepted standards in its field, or show evidence of working toward such standards.
- D. All money raising, on the part of individual Junior Leagues, shall be consistent with standards of dignity and good taste and in keeping with the laws and customs of the community.
- E. At the end of the fiscal year, each Junior League shall send a copy of its audited annual financial report to the Association.
- F. Each Junior League shall maintain the same standards as required of Applying Groups under Article II-A, Section 2 of the Association bylaws.

ASSOCIATION PROCEDURES APPLYING TO ALL LEAGUES

ARRANGING INTER-LEAGUE MEMBERSHIPS:

Section 1.

Inter-League cards issued pursuant to Article II-B, Section 2, of the By-Laws, shall be for a term of one year. Extensions up to, but not more than two additional years, may be granted by the home League.

Section 2.

The League to which a member is temporarily accredited may charge such member for special privileges or for the actual cost of her membership.

Section 3.

- (a) A member desiring an Inter-League card shall notify the Secretary of the home League.
- (b) The Secretary and the Treasurer of the home League in consultation with the Placement Chairman shall determine whether said member is in good standing.
- (c) The Secretary of the home League shall issue an Inter-League card to the Secretary of the temporary League.
- (d) The Inter-League card becomes effective immediately upon receipt by the Secretary of the temporary League.
- (e) The Secretary of the temporary League shall notify the Secretary of the home League that the Inter-League card has been received.
- (f) The Secretary of the home League shall give to the member the name and address of the Secretary of the temporary League.
- (g) The member shall be responsible for contacting the Secretary of the temporary League.
- (h) The temporary League may charge such member for special privileges or for actual administrative cost of her membership.
- (i) When the period of inter-League privilege expires, the Secretary of the temporary League shall return the card to the Secretary of the home League.
- (j) If the member requests an extension of the inter-League privilege from her home League and the home League determines that an extension is justified, the Secretary of the home League reissues the card to the Secretary of the temporary League.
- (k) When the inter-League privilege terminates the Secretary of the home League shall cancel the card.
- (1) The Secretary of the home League shall notify the Association Headquarters of changes of address occurring as a result of the member's move to and from her temporary League area.

ARRANGING TRANSFER OF MEMBERS:

Section 1.

The Secretary of the League from which a transfer is made shall be responsible for filling in the information regarding the member's record called for by the transfer card supplied by the Association. She shall also certify that the transferring member is in good standing and shall then forward the transfer card to the Secretary of the League to which the transfer is made.

Section 2.

Transfers shall meet the conditions of acceptance provided in the Association By-Laws, Article II-B, Section 3, and shall be accepted by the Board of Directors or Executive Committee of any League, unless the member has no right to transfer under the provisions of the same Article. Transfers shall be accepted in order of application, except that applications of members under forty may be given precedence over those of Sustaining members. Transfers shall become effective upon acceptance. Within 15 days thereafter the Secretary of the League to which the transfer has been made shall notify, on transfer cards supplied by the Association, the Membership Records and Circulation Department at Association headquarters and the member's former League.

Section 3.

A member transferring from one League to another shall become subject to the jurisdiction of the League to which she transfers on the date on which such transfer is accepted. A League receiving a transferring member may charge such transferring member the actual administrative costs incurred by such League in connection with her transfer.

Section 4.

A member of a Junior League, who is also a member of an Applying Group which is taken into the Association, upon the acceptance of the new League into the Association, must either request a transfer from her home League or submit her resignation to the new League no later than March 10 of the Association fiscal year in which the new League is accepted.

NON-RESIDENT MEMBERSHIPS

A non-resident Active member who moves to another Junior League area before the expiration of the privilege may request a new non-resident privilege from her home Junior League.

A.J.L.A. GUEST ROOM INFORMATION

Junior League Section

The Junior League Guest Room Section of The Waldorf-Astoria is located on the 19th and 20th floors of the hotel's West (Park Avenue) side, and consists of 32 rooms.

For the convenience of our members, a lounge is maintained on the 20th floor. A waitress is in attendance from 2:00 until 9:00 p.m., to serve tea and beverages.

Cots and cribs may be put into guests' rooms upon request. A cot is \$5.00 plus 5 per cent city tax per night, but there is no charge for a crib.

Sitters for children may be secured through the AJLA Desk.

Cars may be stored at a nearby garage for \$3.75 per night, including pick-up and delivery.

Accommodations

16 rooms—double occupancy—twin beds and private bath. Rates \$21.00, \$22.00, and \$24.00 daily plus 5 per cent city tax.

16 rooms—single occupancy—2 with private baths. Rates: \$8.00, \$9.00, and \$10.00 daily plus 5 per cent city tax; with private bath: \$12.00 daily plus 5 per cent city tax.

There will be no charge for children.

Reservations

In writing for information or to make a reservation, always address Guest Room Hostess, Association of the Junior Leagues of America, Inc., The Waldorf-Astoria, New York 22, New York.

Reservations cannot be accepted more than three months in advance. In case of cancellation, an immediate wire is requested.

Cancellations made less than 24 hours in advance will be billed at full rate. This not only protects the Association against loss, but prevents the turning away of members who otherwise could be accommodated.

Reservations received by wire are answered by Western Union collect. Please indicate the name of your League when making reservations.

Since there are so few rooms in the Junior League section, it is only possible to assign the best accommodations when the exact dates of arrival and departure are known in advance. It is often impossible to retain rooms longer than the time specified in the reservation, due to the fact that they are reserved for the very date they are to be vacated.

Registration

8:00 a.m. to 9:00 p.m. — Upon arrival, please take the West elevators and go directly to the guest room desk in the AJLA office on the 19th floor to register.

Length of Stay

Because of the great demand for accommodations, it has been found necessary to limit the length of stay to one month each six months.

AJLA Departure Time 12 noon

Those retaining their rooms after departure hour will be charged for another day. Due to heavy bookings, we are unable to promise that accommodations always will be assigned immediately upon arrival.

Eligible Guests (other than League members)

Members of immediate families (husbands, children, parents, brothers and sisters) may be accommodated for a period not exceeding two weeks when the League rooms are not otherwise occupied. If accompanied by a League member the period is extended to one month.

Written authorization from a League member is REQUIRED for reservations of members of her family. Members are requested to write AJLA for the necessary form to be filled out in advance of making family reservations. No form is necessary, however, if the member accompanies her family.

Guests other than League members (or their immediate families) may be accommodated only when accompanied by a League member. League members need not request a form in advance when accompanying non-members. The daughters of Junior League members may be accompanied by friends when sponsored in accordance with established procedures.

MEMBERS SHALL BE RESPONSIBLE FOR ANY UNPAID INDEBTEDNESS INCURRED BY GUESTS INTRODUCED BY THEM. Members of individual Leagues, who are delinquent in paying any indebtedness to the Association, shall be considered in arrears in their dues to their own League. (By-laws, Article II-B, Section 4.)

CHECKS WILL NOT BE CASHED FOR MEMBERS UNLESS THEY ARE STAYING IN THE HOTEL AS JUNIOR LEAGUE GUESTS. Members of individual Leagues, who are delinquent in paying any indebtedness to the Association, shall be considered in arrears in their dues to their own League. (By-laws, Article II-B, Section 4.)
