HISTORY OF THE ASSOCIATION OF JUNIOR LEAGUES OF AMERICA

The Junior League represents a serious endeavor on the part of young women to become active and constructive factors in the communities in which they live, to be intelligent citizens, and to assist in promoting human welfare. In addition to providing the member with channels of work and training for volunteer service, the Junior League helps her to realize two vital concepts: (1) that she is not an onlooker, but is herself a part of the community; (2) that the community, in turn, is not an isolated unit but part of the nation and of the world.

It was in 1901, at the beginning of a new era for American women, that the first Junior League was organized in New York. At that time Mary Harriman (Mrs. Charles Carey Rumsey) and Nathalie Henderson (Mrs. Joseph Swan) realized what might be achieved if a group of young women were encouraged to take a more active part in some form of active service to their own neighborhoods through the settlement houses and other organizations in existence at the time.

Soon organizations similar to that in New York were formed in various other of the large cities—Boston, Brooklyn, Portland, Ore., Baltimore, Philadelphia, and Chicago. In the spring of 1912 six of the seven Leagues then in existence held their first national conference in New York City. In 1921 the Association of the Junior Leagues of America, Inc., was founded by the thirty Leagues then in existence. Mrs. Willard Straight (Mrs. Leonard K. Elmhirst) was elected President and a Board of Directors was appointed and instructed to draw up a constitution.

After 1921 the Association grew rapidly until, in 1923, there were sixty-three Leagues. In order to establish a closer contact between the Leagues and the Association, the country was divided into six territories and in each a League member was appointed Regional Director to act as liaison officer between the Leagues of the Region and the Association and to serve on the latter's Board of Directors. Now there are fourteen Regions, in each of which the Leagues elect every second year a member to serve as their Regional Director.

At the time the Association was first formed most League activity was in the realm of social work; but the Board of Directors, realizing the opportunities which would eventually offer themselves to Junior Leagues, set down in the constitution the social, economic, educational, cultural and civic fields as those in which Junior Leagues should interest their members.

Gradually the Leagues realized that a benevolent "doing for others" was not enough, that they must form a partnership with professional community workers to effect the improvement of conditions. To do this required knowledge. As evidence of this the first course for provisional members was established in 1921 and such a course, which includes an examination of the various forces at work in the community, has been a prerequisite for

active membership since 1927. Originally League projects were large enterprises—convalescent homes, day nurseries, curative workshops and the like. It was discovered, however, that to support these undertakings a disproportionate amount of time and energy often was going into moneyraising to the exclusion of the educational process of volunteer service. Today where Leagues have projects the recommended type is one in which the demonstration element is present, the choice being based on the needs of the individual community in the light of the interest and money-raising capabilities of the League.

The League's realization of the need for expert guidance in its welfare activities soon led to the establishment of a trained social work staff at the Association's offices. Members of this staff were available for visits to Leagues to study the local situation and give advice. Similar service was then made available for Children's Theatre, Arts, Ways and Means, and Publicity. The Association also publishes the Junior League Magazine. issued semi-monthly to each Junior League member.

HISTORY OF WINSTON-SALEM JUNIOR LEAGUE

The Junior League of Winston-Salem had its beginning as the result of a meeting called by the late Mrs. J. Edward Johnson (former widow of Richard J. Reynolds, founder of the R. J. Reynolds Tobacco Co.) on January 13, 1923. About 40 young women met at her house at Reynolda. They were advised that they should devote time and energy to social service.

Mrs. Bess Gray Plumly called the group together a few weeks later, and the late Miss Marian Blair suggested that the group apply for membership in the Association of Junior Leagues of America.

In March, 1923, the Winston-Salem Junior League became the 46th in the Association and the first in North Carolina. The late Mrs. Lucy Hanes Chatham was the first president.

During the first five years the League was active in many projects such as opening a gift shop, sponsoring a pre-natal clinic, opening a Hospital for Incurables, operating a beauty parlor and forming a Children's Play Committee.

The next ten years show that the League was continually expanding into new fields. The Newssheet was begun and a placement system was put into effect. The League also continued operation of the Hospital for Incurables, opened a Rag Market (later the Thrift Shop) and helped organize the Civic Music Association. After the Hospital for Incurables was closed on June 1, 1937, the League assisted in the organization of the Mental Hygiene Society of Winston-Salem. The League also financed a Child Guidance Clinic which opened on November 1, 1937.

The next several years the League continued to sponsor and finance the Child Guidance Clinic. New projects included the

Hall of History, presentation by the Junior Programs, Inc., and the bringing to town of four New York Dramas of the Contemporary Theatre Series. The League also joined with other interested community groups in forming the Children's Theatre Board.

In 1941 the League's program of planned expenditure of surplus was begun with \$3,000 donated to the Red Cross War Fund, \$1,000 given to the Library Fund of the Winston-Salem Teachers College, \$5,000 given to the Family Service Agency for the establishment of a Child Placing Agency and \$4,500 to the Community Council for the development of the Radio Plan.

In 1942 the Child Guidance Clinic was closed and in 1943 the gift shop was sold.

During the war years the League members devoted the major part of their volunteer service to war-related activities. Support of the Radio Council continued as well as a donation of \$1,000 to the Wachovia Historical Society. A survey by Miss Virginia Lee Comer, AJLA Arts Consultant, showed a need for development and expression of the creative arts in our community. In 1945 the beauty parlor was sold. In 1945 the major portion of the League's surplus was donated to the community. The 400 shares of Reynolds B stock was divided as follows: 50 shares to the City-County Hospital, 50 shares to the War Memorial Building Fund, 120 shares to the Mental Hygiene Society and 180 shares to the City Library. The Junior League Hospital Building was deeded to the Winston-Salem Foundation.

The League entered the cultural field during these years by opening an Arts and Crafts workshop with Mrs. Chester Marsh as director. The League continued its financial support of the Radio Council and put aside \$7,200 for the employment of a Community Arts Coordinator when the Arts Council proved its readiness to handle the money. The League also contributed \$500 to the Piedmont Festival and sponsored a concert of the newly formed Winston-Salem Civic Orchestra.

In 1947 the city withdrew its support of the Arts and Crafts program and the League assumed the responsibility for the administration, financing and promotion of the workshop.

Support continued to the Symphony and the Piedmont Festival and in 1950 the League released the gift of \$7,000 which it had held in trust for the Arts Council. In March of 1952, \$3,000 was granted to the workshop and in 1951, the Arts Council established an Arts center and moved in a building owned by the Winston-Salem Foundation. In March the League's financial contribution to the Arts Center was completed through coordination of fund raising for the Arts groups under the Arts Council.

In 1952 the League had as its project the Children's Activities Program at the new City-County Library. The League voted the Library \$1,500 for the first year and limited the League's sponsorship to three years. The League also continued support of the Arts Council with a donation of \$5,000.

Two art exhibits were sponsored by the League in 1953 and recreational therapy was done in the Children's Wing of the

Baptist Hospital. The next year showed the closing of the Thrift Shop and the beginning of our annual Rummage Sale.

In 1955 our three-year activity program for children was completed at the Public Library. The Recreational Therapy program at the Baptist Hospital was enlarged and the League continued to bring outstanding art exhibits to the Library. A new project was begun—providing the salary for a primary education teacher for the handicapped at the Children's Center.

During the next year the League strengthened existing projects and added to those services. A program for handicapped adults was begun and the therapy program at the hospital enlarged.

The Adult Handicapped program grew rapidly and the Hospital Therapy program was continued. The Cultural Arts Committee arranged a bus trip to Raleigh to tour the State Art Museum and \$150 was offered as a purchase prize to the Gallery of Fine Arts in the name of the Junior League. A successful Rummage Sale was held as well as 5 marvelous productions of the play Sleeping Beauty.

In 1957 the League again contributed \$5,000 to the Children's Center providing the school with a kindergarten teacher. An art exhibit drew 3,700 people and the Rummage Sale was a great success. Night meetings were begun for professional members and those unable to attend the morning meeting. Two brochures were printed—one dealing with Admissions policies and the other describing the community activities of the Winston-Salem Junior League.

The League continued to strengthen existing projects in 1958 by donating \$2,000 a year for the next two years to provide an aide at the Children's Center, by buying a metal awning for the Pediatric Ward at the Baptist Hospital and by giving \$1,155 to the Arts Council.

In 1959-60 the League accepted a new project by voting to pledge \$26,000 over a three-year period for the restoration of the Timothy Vogler Home in Old Salem. A vote to establish head-quarters in the restored house and a vote for a substantial dues and initiation fee raise were important outgrowths of the visit of Mrs. Robert Dingman, Financial Consultant of AJLA. The League participated in the celebration of Winston-Salem, the All America City, by sponsoring an essay contest in the city schools.

In 1960-61 Regional Meeting was held in Winston-Salem for the first time. Delegates and observers from the twelve Leagues in Region XIII attended. The restoration of the Timothy Vogler House was completed, and \$15,000 was paid on the \$26,000 pledge to Old Salem. A new Admissions system was put into effect through extensive By-Laws changes.

In 1961-62 the League produced its first Follies, netting nearly \$16,000 and paid off its obligation to Old Salem. A puppet group was formed by the professional members.

In 1962-63 the League voted approval of two new projects: one, \$10,000 for remodeling the kitchen at the Amos Cottage; and two, a \$6,000 challenge gift for two years to the consolidated

school system for an art supervisor. The League calendar year was adjusted through extensive By-Law changes recommended by the newly formed Advisory Planning Committee. A revolutionary Children's Theatre workshop, under the direction of George Latshaw, AJLA consultant, was sponsored. Sixteen oil paintings were done for the Pediatric Floor at Baptist Hospital.

In 1963-64, the school system was unable to fill the position of Art Supervisor and did not take our challenge gift. Continued interest by and from the League resulted in a renewal of the \$6,000 offer for 1964-65 and a new vote of approval to make the same \$6,000 offer for 1965-66. An Art Supervisor was hired so the project will be carried through. A visit from the AJLA Art Consultant, Mrs. Nancy Vars, and many hours of study by the Project Finding Committee resulted in the approval of a Nature Science Center for a three year project with \$26,000 in financial support over the three year period and three members on the Board of Trustees. Fourteen oil paintings by League artists were presented to Forsyth Memorial Hospital for the Pediatrics Floor and a daytime group was added to the Puppet Committee. The Fortieth Anniversary was celebrated by the publication of an unusual and attractive new brochure, a dinner dance for the membership and a luncheon in honor of the charter members.

1964-1965. The new Art Supervisor arrived and was assisted in his program by the Community Arts Committee whose efforts culminated in a delightful May Day Exhibit of scholastic art on Salem Square. Work began at the Nature Science Center, which officially opened Spring, 1965. The Winston-Salem Civic Ballet was granted \$700.00 for a Christmas production. A painting by a League artist was presented to the Department of Public Welfare for the children's waiting room. In April, at the recommendation of the Project Research Committee, the League voted to accept the offer of the Red Cross to assume full financial and volunteer responsibility of our long standing project in the Children's Play Room of the Baptist Hospital. The elections of DeWitt Cordell as Regional Director and Anne Strickland to the Regional Nominating Committee, are proof of our capable, competent leaders.

ANNUAL REPORTS OF BOARD, 1964—1965 WINSTON-SALEM JUNIOR LEAGUE

PRESIDENT - MRS. CHARLES VANCE, JR.

Our world today seems to be thoroughly infiltrated, surrounded, and preoccupied with numbers. Everyone is figure-conscious, zip-code oriented, credit-card numbered, and telephone-trained away from the alphabet and into a digit system unparallelled in history!

Therefore, it seems only natural to present to you, in my annual report tonight, a few statistics I have compiled during these last few days.

In the course of this Junior League year, we have been guided by twenty-four major committees and thirty-six subcommittees. You attended 124 meetings of major committees alone, and thirty-five rehearsals for the play and puppetry productions. Four thousand seven hundred twenty-five copies of the Newssheet were printed and mailed.

If each active spoke on the telephone about League work just one time a week, and you and I know this is a ridiculously low estimate, that would total 8,736 calls!

I have kept an average of my own calls for the past two or three weeks, and if I give the most conservative estimate possible, I suggest to you that, even allowing for the summer lull, I, personally, have had 1,175 telephone conversations about the League this year!

Now — was it worth it, or was it all just "busy work"?

The real measure of any Junior League's year is largely the measure of the growth of its members through training and service to the given community.

Taking service first, we have spent \$17,372.46 on the Community Service Program. This, in itself had an impact, of course. But its impact was increased ten-fold, backed up by the hours of planning and work you willingly gave — some in administrative capacity — but most of you, working without publicity. You are the team responsible for the Junior League's program.

At the Nature Science Center, Debbie Sartin led her group of volunteers through the organization of committees and their activation into efficient working units. I applaud the way they all utilized their skills to transform the bare rooms and silent corridors of the Reynolda Barn into a center of bustling activity and education.

Mr. Antony Swider, the new Art Supervisor, arrived in town, by coincidence, the very day we presented the check for the challenge gift to the school system. Claire Christopher and the Community Arts Committee stood ready to assist his program in any way, and their efforts culminated in the delightful May Day Exhibit — when a display of scholastic art brought a hint of Paris or New Orleans to Salem Square.

I have seen first-hand the effect of our Adult Handicapped program, led this year by Frances Vogler. She and her committee brought relaxation and pleasure to many who participate in the monthly recreational programs. We are grateful, indeed, to these "Pearl Mestas"!

"Fox-In-A-Fix", the Children's Theatre production, became an educational and artistic success, as it gave some 3,823 children a glimpse of oriental theatre. Bouquets to Chairman Pam Burress, cast and crew, for this display of talent and ingenuity.

Anne Rigby and Marian Townsend headed the two puppetry troups with spirit and originality. As a result, 1,150 children were entertained in hospitals, the Children's Center, Children's Home, Library, and Kindergartens.

If you have inspected one of the children's activity books made by Gale Gramley's Fun Book Committee, you know how clever these girls have been! And what joy the books must have brought to their recipients! They were distributed through the three hospitals, Children's Center, Amos Cottage, Visiting Nurse Service, and Welfare Department.

Our long standing project in the Children's Playroom of the Baptist Hospital was capably directed by Mary Glenn. This year, Red Cross Grey Ladies joined forces with League members, to provide volunteers. This proved successful, and in April, at the recommendation of the Project Research Committee, you voted to accept the offer of the Red Cross to assume full financial and volunteer responsibility for the playroom. This was a major step, and I am confident that the Red Cross will carry on the work with enthusiam.

The Project Research Committee, chaired by Marty Hancock, carried on in-depth studies of several project ideas. They worked thoughtfully and conscientiously, and their meetings led to our grant of \$700.00 to the Civic Ballet for a Christmas production, and a painting for the Children's Waiting Room at the Department of Public Welfare.

The image of this Junior League in the eyes of community agencies is only as outstanding as the record of our volunteers. With Mary Louise Whitaker's efficient and interested leadership, the Placement Committee arranged to fill volunteer requests for twenty-one agencies and League work.

If we are to spend money to enrich life in this community, we must have a good income. Jean Spach, enthusiastic Chairman of our Rummage Sale Committee, guided our efforts to replenish the Community Trust Fund, and, with her committee, and your cooperation, revised the procedure and schedule to the extent that each volunteer hour was worth \$7.50. You heard tonight the wonderful results of this year's sale!

Now — with all this going on in the community, those involved in League administration were just that — involved — for the administrative committees are the necessary "back stage crew" for our program!

As Chairman of Advisory Planning, Anne Strickland demonstrated her leadership ability by directing studies of problems

relayed by the board. Innovations were recommended, when indicated.

The By-Laws Committee, under Vaughn Owen, put the recommendations into By-Law form for your approval, and as a result we have rescheduled elections for Admissions and Nominating Committees, with the latter enlarged by one member.

Aurelia Eller and the Education Committee brought the "outside world" to us, through eight stellar programs.

And Drane McCall's Public Relations Committee interpreted the Junior League to the "outside world" through splendid publicity. The two committees combined forces to arrange the November group coffees.

The Newssheet Committee provided a line of communication between the Board and membership. With Ann Ring as Editor, they presented newsworthy articles from the League and the community, and nine appealing, informative issues reflected challenge and conviction.

At the same time, Martha Field kept the Association Magazine informed with tidings, and news of projects! She was rewarded with a rare occurrence, when we did have an article in the Spring edition.

Down at Timothy Vogler, Betsy Miller and her Headquarters Committee worked constantly to keep up with the Secretarial work of this far reaching organization, and the decorating committee of Sustainers added to our Headquarters charm and efficiency with new furniture and new office equipment. While on the subject of Headquarters — I want to say "thank you" to the person who handled my correspondence and other paper work — Tibby Wetherall; for without Tibby, my letters would have been one long succession of carbon smudges and typographical errors!

Getting back to numbers, Suzanne Simpson and the Hospitality Committee must have become mathematical experts in the course of entertaining us with two luncheons, refreshments at night meetings, and the Peppermint Ball. They have juggled reservation totals, prices of rain hats and houses, a skimpy budget, and 360 candy canes!

Another form of warm hospitality and enthusiastic welcome was provided through the year by Mary Lu Whaling, and the Transfer Committee.

If we are to continue with such a vast program, we must look to the future. We must continue to seek and to train eligible Provisional members. To this end, the Provisional Committee, under the spirited leadership of Jane Masich, planned a comprehensive training course, and presented eleven new Actives to you in April.

You have seen tonight the promising results of the work of the 1964-1965 Admissions Committee. Margaret Leckie has guided their deliberations with competence and concern for League standards.

The future is also very much in the hands of the Nominating Committee — which, with Emmy Lou Long as Chair-

man, was successful on regional and local levels! The election of Dewitt Cordell as Regional Director and Anne Strickland to the Regional Nominating Committee, and the fine slate of new officers, are proof of their interest and ability to recognize capable competent leaders!

The Telephone Committee serves the League as a vital communications media, and I thank Lila Spencer and her committee for their limitless patience, as they made approximately 1,997 calls.

E. Sue Shore has been busily living up to her title. Ever since she accepted the appointment as Sustaining Advisor, she has sustained and advised me with her good, wise approach and her foresight.

I cannot define the work of the members of the Executive Committee in terms of hours or meetings or events. That would constitute a full report in itself. I can define it with such descriptive terms as efficient, inspired, dedicated. I want to declare that Pat, Algine, Bunky, Adrian and Mary Jo have served you and me with vision to see beyond routine duties, with perspective, and a sense of humor. They have been my closest advisors, and working with the larger consulting group, the Board of Directors, have given me encouragement and expert advice! I am happy for this opportunity to commend each one personally.

Surely all this array of activity amounts to much more than a list of numbers or a few phrases on a page. Rather, it constitutes another page in our history of dedication to purpose.

The obvious tangibles are the services to the Community in dollars and cents. The intangibles are the subtle, enriching influence of your work, and, above all, the certainty that you have all taken some giant steps toward that elusive something we often refer to as maximum potential. This is something which can never submit to statistics, because it is too great a force, and much needed in our time.

Emerson put it quite simply: "A sufficient measure of civilization is the influence of good women."

In closing, I want to thank you for giving me the opportunity to serve as your President, and for 365 days brimful and overflowing with challenge, excitement, and best of all, your friendship.

I congratulate you on electing splendid officers for this coming year. Your new President is endowed with a deep understanding of the potential of this organization, and under her leadership, the Junior League will surely thrive. I am delighted to present the gavel to Debbie Sartin, at this time.

C. as a day observer and, at the request of the President, two Public Solicitations Committee meetings and the Salvation Army annual meeting. Concerning the November coffees the Vice President assisted with preparation of the agenda and the compilation of the results and served as a moderator. At the direction of the Executive Committee the Vice President served on the following League committees: Advisory Planning, Education, Finance, Placement and Public Relations.

It has been a great pleasure to work with the professional group and to serve the League in the capacity of Vice President.

Article III-Membership

- B. Use of Standard Admissions Information Form
 - 1. For the purpose of recommending, the Admissions Committee may review and pass a candidate and, if unable to admit her because she no longer resides in the city at the the time of invitation, it may by means of the Standard Admissions Information Form, call attention to the availability of this candidate to the Admissions Committee of the League in whose city she may then be residing. She must have resided in another city no longer than one year immediately prior to her proposal.
 - 2. The Admissions Committee may, at its discretion, waive the "length of residence" requirement for a candidate on whom the committee has received a S.A.I.F. from another Junior League. The candidate must meet all other conditions of eligibility and must be proposed and considered by the Admissions Committee in accordance with the By-Laws of the Junior League of Winston-Salem.

Change to C. Proposal of Members

Which read:

Application for membership shall be received by the Chairman of the Admissions Committee at any time during the year.

Now reads:

Proposal for membership shall be received by the Chairman of the Admissions Committee at any time during the year.

Third paragraph read:

Any eligible active or sustaining member may propose one candidate and second one candidate during a given year, but no member shall write to the committee in behalf of a candidate. No member of the League shall contact any member of the Admissions Committee in behalf of a candidate.

Now reads:

Any eligible active or sustaining member may propose one candidate and second one candidate or second two candidates during a given year, but no member shall write to the committee in behalf of a candidate. No member of the League shall contact any member of the Admissions Committee in behalf of a candidate.

Was C:

Now D. Election to Membership

Which read:

If a candidate is unable to take the basic provisional course or to transfer to another League, she must decline the invitation to membership. In this event, the invitation shall be reissued a second time only upon the request of the candidate's sponsors to the Board of Directors. In the event that a candidate wishes to transfer to another League as a provisional, she must have completed her basic indoctrination course.

Now reads:

If a candidate is unable to take the entire provisional course or to transfer to another League, she must decline the invitation to membership. In this event, the invitation shall be reissued a second time only upon the request of the candidate's sponsors to the Admissions Committee. In the event that a candidate wishes to transfer to another League as a provisional, she must have completed her basic orientation course.

Section 4. Resignations, Dropped Members, Re-instatements C. Re-instatements

Add:

Provisional members shall be eligible for re-instatement through age 32.

Article IV — Officers

Section 5 Executive Committee

Which read:

There shall be an Executive Committee, composed of the officers, which shall assist the President in making appointments. It shall have all the powers of the Board of Directors during the months in which there are no regularly scheduled Board meetings. The minutes of the meetings of the Executive Committee shall be submitted to the Board for ratification at its next meeting.

There shall be an Executive Committee, composed of the officers, which shall assist the President in making appointments. It shall have all the powers of the Board of Directors between regularly scheduled Board meetings. The minutes of the meetings of the Executive Committee shall be submitted to the Board for ratification at its next meeting.

Article VI — Committees

A. Admissions Committee

Which read:

There shall be an Admissions Committee whose function shall be to pass upon all applications for membership to the League (or) to make recommendations to the Board with respect to applications for membership. The committee shall be elected at the time and in the manner herein provided, and shall serve for one year.

Now reads:

There shall be an Admissions Committee whose function shall be to pass upon all proposals for membership to the League (or) to make recommendations to the Board with respect to proposals for membership: The committee shall be elected at the time and in the manner herein provided, and shall serve for one year.

(a) Personnel of Committee Which read:

The committee shall be composed of eleven members: a chairman, who shall be appointed by the Executive Committee, and shall not be entitled to vote; a sustaining member who shall be elected by the League, and shall NOT be entitled to vote; and nine voting members who shall be elected by the League as provided in this Article.

Now reads:

The committee shall be composed of twelve members; a chairman, who shall be appointed by the Executive Committee, and shall not be entitled to vote: two sustaining members who shall be elected by the League and shall NOT be entitled to vote; and nine voting members, who shall be elected by the League as provided in this Article.

(b) Eligibility to Serve on Committee Which read:

The sustaining member shall have been sustaining no longer than ten years and shall have served on the Admissions Committee during her active membership.

Now reads:

One sustaining member shall have been sustaining no longer than ten years and one no less than ten years. Each shall have served on the Admissions Committee during her active membership.

(c) Election of Committee Which read:

Election of this committee shall be held at the March meeting. Two weeks prior to the February meeting the Nominating Committee shall mail to all active members a list divided into three age groups of all active members eligible for election and the names of those present members of the Admissions Committee who are eligible for re-election. These age groups shall be as follows: 21 to 29, 29 to 35, and 35 through 39. At the February meeting, each active member present may nominate, by secret ballot, four members from her own age group and five members from the present Admissions Committee. Consent of a nominee shall be obtained by the Nominating Committee before her name is placed on the ballot. At the March meeting, the Nominating Committee shall present a list of the four nominees receiving the highest number of votes from the present Admissions Committee, and three nominees from the sus-

taining members. Each active member present shall vote for two nominees from each age group, for three nominees from the present Admissions Committee and for one sustaining member.

Now reads:

Election of this committee shall be held at the April meeting. Two weeks prior to the March meeting the Nominating Committee shall mail to all active members a list divided into three age groups of all active members eligible for election and the names of those present members of the Admissions Committee who are eligible for re-election. These age groups shall be as follows: 21 to 29, 29 to 35, and 35 through 39. At the March meeting each active member present may nominate, by secret ballot, four members from her own age group, five members from the present Admissions Committee, and three sustaining members in each category.

D. Nominating Committee Which read:

There shall be a Nominating Committee whose function shall be to prepare slates of candidates for election to the various elective offices of the League. The Nominating Committee shall be composed of five members: one, the chairman, to be appointed by the Executive Committee; one elected by the Board; and three elected by the League, according to their active period in the Winston-Salem League; one active from one through four years, one active from five through nine years, and one active over nine years. Two weeks prior to the February meeting a roster of League members eligible to serve on the Nominating Committee shall be mailed by the current Nominating Committee to all active members. At the February meeting each member may nominate from this list one person in each group. The three candidates receiving the highest number of votes in each group will appear on the final ballot. One candidate from each group will be elected at the March meeting. The Placement Chairman shall serve ex-officio.

Now reads:

There shall be a Nominating Committee whose function shall be to prepare slates of candidates for election to the various elective offices of the League. The Nominating Committee shall be composed of seven members: one, the chairman to be appointed by the Executive Committee; one elected by the Board; and five elected by the League, according to their active period in the Winston-Salem League; one active from one through four years, one active from five through nine years, and two active over nine years. Two weeks prior to the January meeting a roster of League members eligible to serve on the Nominating Committee shall be mailed by the current Nominating Committee to all active members. At the January meeting each member may nominate the number to be elected from each group. The three candidates receiving the highest number of votes in the first two groups and the four candidates receiving the highest number of votes in the third group will appear on the final ballot for election in February. The Placement Chairman shall serve ex-officio.

COMMUNITY ARTS

A purchase prize was offered to the Winston-Salem Gallery of Fine Arts for their fall jury. The Junior League purchase prize was awarded to Miss Patricia Minser of Wilmington, North Carolina for her oil painting "Swimmer at the Inlet." This painting was presented to Philo Junior High School.

Members of the committee attended the North Carolina Art Society meeting in Raleigh to see the demonstration of the new art kit which was then ready for distribution in communities and schools throughout the state.

A sum of \$25.00 was designated for an oil painting to be painted by a League volunteer and to be presented to the Forsyth County Department of Welfare. The painting will be placed in the children's waiting room of the new welfare building.

The Community Arts Committee participated in two art exhibits with the Winston-Salem Forsyth County School System under the direction of the art supervisor, Anthony Swider. In January the committee assisted in preparation for the Scholastic Art Exhibit. In the spring the committee planned for the May outdoor exhibit in Salem Square in which twenty-six junior and senior high schools participated. As well as advanced planning with Mr. Swider the committee worked with the art teachers in hanging the exhibit and served as guides and hostesses during the show. The League provided financial assistance to Mr. Swider for art supplies and for the exhibit brochure.

The Community Arts Committee was willing, cooperative and faithful this year as we worked with Mr. Swider in his first year as art supervisor for the Winston-Salem schools.

EDUCATION COMMITTEE

If any theme could be attached as a label for our educational emphasis this year, it would have to be a broad, general one, for the programs have encompassed many fields. We could say that our perspective has been sharpened and our understanding deepened, as we concentrated on League concerns through November coffees, on community activities as we listened to Doug Carter and the Welfare Panel, and on world affairs explained by Dr. Warren Lerner and Tom Wicker. Yet we also gained insight into the world of our children through the experience of Miss Litwinchuk and we understand ourselves more completely after a session with Dr. Clark Vincent. So if anything could be attached to this year's education as a theme, it perhaps might be "A study of ourselves, our League, our community, and our world for greater understanding."

In September, Miss Alice Litwinchuk, principal of Salem Academy, spoke as an educator as she took a look at young people. She repeated her talk to the professionals that night.

A panel of men in the welfare field was moderated by

Norwood Robinson in October. Speaking on "Work versus Social Retirement", Mr. John McDowell of the Forsyth County Welfare Department, Mr. Grover Teeter of the Employment Securities Commission, and Mr. Winfred Tyndall of the Associated Family and Child Service Agencies gave us a look at the Welfare program through their agencies. Our own Sally Lacy, who works with the Child Adoption program in the County Welfare Department, and Elizabeth Fenwick, who is with the Domestic Relations Court, gave a resume at the night meeting to the other professionals.

Seven coffees were held for the actives and provisionals in an informal setting in the homes of members in November, and generated active discussion and good ideas. The Education Committee acted as discussion leaders and the Public Relations Committee were the recorders. Through the interest of the sustaining advisor to the Education Committee, six coffees were held for approximately 150 sustainers the same week. These, too, generated good response and active discussion, and were led by members of the Education Committee. Before the coffees, a workshop was held for the members of the Education Committee to train them as discussion leaders. After the coffees, the committee met to evaluate and to summarize the discussions. This summary was reported to the membership at the next League meeting.

The program at the December luncheon meeting, to which all groups of members are invited, featured Douglas Carter, director of Special Services of the City-County Schools and administrator of the Governor's School. He spoke on the Governor's School, and presented one of his students, who demonstrated at the piano and in a delightful speech the talents and observations of the students attending the school.

January brought Dr. Clark Vincent, Professor of Sociology at Bowman Gray School of Medicine. The Education Committee felt so strongly that this type of study program would prove interesting and stimulating to the membership, that we asked for and were granted an additional grant of \$100.00 for Dr. Vincent's honorarium. His topic was "Self-Identity For the Modern Woman", and brought forth more discussion and comments from the members than did any other program of the year. Dr. Vincent repeated his talk to the professionals in the evening. Several interested League members enlisted other friends and their husbands and had a further study session with Dr. Vincent on a later evening.

Dr. Warren Lerner, Assistant Professor of History at Duke University, came to us in February and helped us examine the power struggle within the Kremlin in Russia and what it will mean to the Communist world, indirectly affecting Communist relations with us. A report of his talk was given to the professionals.

Our night meeting with the husbands as guests was held in March. Tom Wicker was the featured speaker. As chief of the Washington Bureau of the New York Times, he was extremely qualified to present up-to-date observations of Washington, the Johnson administration, and especially the Viet-Nam crisis.

The Hospitality Committee held a reception in honor of our guests following the meeting at the Community Center.

Our program year closed with a report at the April Luncheon meeting by Myron Vourax, director of the Nature-Science Center, on progress to date and plans for the future.

In addition to the programs at the League meetings and the November coffees, the Education Committee also assisted in Board Orientation with a presentation of a film strip on Parliamentary Procedure, and repeated the study to the provisionals at one of their meetings.

The committee members this year were a strong group who carried out every phase of the year's work with excellence — and it has been a busy year! Each took charge of one of the programs, made the plans, and introduced the speaker. Tibby Wetherall was our star reporter for the Newssheet and did a marvelous job of educating the membership about the speaker or program of the month. I, as chairman, am exceedingly grateful for the hard work and creative leadership that each member of the committee contributed.

HOSPITAL THERAPY

In the spring of 1964 the Advisory Planning Committee recommended that the Red Cross Gray Ladies be included in the League's Hospital Therapy program. The Chairman of the Red Cross volunteers was contacted. It was agreed that League volunteers would staff the playroom on Tuesdays and Thursdays, and the Gray Ladies would work on Mondays, Wednesdays, and Fridays. Eight League volunteers and three substitutes were recruited. In late August an arts and crafts workshop was held for both League and Red Cross playroom volunteers.

The new provisionals and teen-age volunteers were shown the playroom facilities in June. The Hospital Therapy program and policies were explained to them. Fourteen teen-age girls staffed the playroom throughout the summer.

Because of a request from the nurses the Hospital Therapy Committee presented a play pen and several infants' toys to the Pediatric Floor in addition to furnishing the supplies usually needed in the playroom. In April the membership of the Junior League approved the recommendation of the Project Research Committee to accept the offer made by the Red Cross to assume complete financial and volunteer responsibility of the playroom. The League is fortunate to have an organization such as the Red Cross with its competent volunteer program to take over the duties of this project. Since the Hospital Therapy program has proved valuable to the children, parents, and hospital staff throughout the twelve years it has been sponsored by the Junior League, this year's committee hopes that many League members will continue to work at the hospital under the supervision of the Red Cross.

My thanks to the committee members who helped maintain the playroom and to all the volunteers who made the mornings of the little patients more pleasant by bringing them the diversion of creative activities.

NATURE-SCIENCE CENTER

Assisting with the growth of the Nature-Science Center from September, when our director, Myron Vourax, arrived to view an empty building, to late December, when enough exhibits were completed for an informal viewing by the Center's sponsors, into April, as school tours and workshops began, has been a most rewarding experience for the Nature-Science Center Committee.

NEWSSHEET

During the year 1964-1965 nine issues of the Newssheet were published, copies being sent to the membership, AJLA, the Regional Director, Presidents, and Editors of Region XIII, the advertisers, and at various times firms and individuals in the community.

PROJECT FINDING

The Project Research Committee began the year in June with orientation, the change of name for the committee, and the study and evaluation of requests that had come to the committee.

PROVISIONAL

Following individual interviews in May, the provisionals were launched into a most active year with the basic orientation course, June tenth and eleventh. PUBLIC RELATIONS

PUPPETRY

The year for the Puppet Committee began with the attendance by its two chairmen at the convention of the Puppeteers of America Festival at Miami, Florida. Anne Rigby and Bess Brown, daytime chairmen, spent a week at this working, learning convention. They attended daily workshops and performances conducted by some of the country's leading puppet groups and discussions with other Junior League delegates, under the leadership of Jean Wiksell, AJLA Puppetry Consultant. This was an exciting experience and will prove increasingly helpful as our work grows. In September Bess Brown moved to Birmingham, and Marian Townsend took over the daytime group.

Both groups spent the fall working on their new productions. The daytime group selected "The Colorbook Dragon," an AJLA script, for their play. In February they began taking it to kindergartens and the children's story hour programs at both

the main and East Winston branches of the library. Performances were also given at the Children's Home and the Children's Center. Their committee consisted of eight members who made puppets, scenery, and props, and acted. New for the first year were correlations, written by the daytime group, and used to help the teachers prepare the children for the performances they were to see. It is felt that these were a real help.

The night time group selected a pantomime presentation of four poems, read by a narrator. These were: "The Duel," by Eugene Field; "The Elf and The Dormouse," by Oliver Herford; "Eletelephony," by Laura E. Richards; and "Max and Meritz," by Wilhelm Busch. These were presented at the children's wards of the Baptist Hospital and the new Forsyth Memorial Hospital. A performance was also given at the May Frolics of Summit School. All puppet performances are presented free of charge.

At the request of teachers in the English Department at Winston-Salem State College, Anne Rigby and Mary Green met with a class in Children's Literature and told about our puppet work. This was accompanied by a showing of our puppets and discussion with the students. A highlight of every performance continues to be the after-show greeting of child and puppet. We feel that we have found a real need for such live performances, as demonstrated by the reception we always receive. This is a type of entertainment which the children do not have access to anywhere else. We hope increasingly to work to enlarge our efforts and our audience, insofar as is possible.

By-Laws of the Junior League of Winston-Salem

ARTICLE I - NAME

The name of this organization shall be the Junior League of Winston-Salem, Incorporated.

ARTICLE II — OBJECT AND POLICIES

Object: The object of this League shall be to foster interest among its members in the social, economic, educational, cultural and civic conditions of the community, and to make efficient their volunteer service.

Policies: The policies of the League shall be in harmony with the policies of the Association of Junior Leagues of America, Incorporated.

Dissolution: In the event of Dissolution of the Corporation, after the payment of all debts, any remaining assets of the Corporation shall be distributed, transferred and paid over to such charity or charities that may qualify for tax exemption under the then existing income tax laws relating to tax exemption as charitable or educational corporations.

ARTICLE III — MEMBERSHIP

Section 1. Classes of Membership

Only women under forty years of age who shall comply with the requirements of the Association shall be admitted to membership by the League. No member shall at any time be a member of more than one League. The classes of membership shall be as follows:

A. Provisional Membership

Provisional members are those who are engaged in complying with the requirements for admission to Active Membership and are not eligible to vote or hold office. Provisional members shall be required to complete a provisional member's course, which shall meet the standards set by the Association and a period of volunteer service satisfactory to the Placement Committee within twelve months after their election to provisional membership. An extension of time may be granted by the Board of Directors in the case of provisionals who for unavoidable reasons are unable to complete the course. Provisionals who have completed these requirements are admitted to active membership by a three-fourths vote of the Board of Directors. Those members failing to meet the provisional requirements shall be dropped from membership by a three-fourths vote of the Board of Directors and may not come up again for membership within two years.

B. Active Membership

Active members are those who have completed the requirements for provisional members and who, having been admitted to active membership, justify such membership through service to their communities. An active member shall enjoy all rights, privileges and obligations of membership until the end of the League Year (which need not be the League's fiscal year) in which she reaches her 40th birthday, provided, however, that any active member who holds a position as an officer or director of a League or the Association immediately prior to her 40th birthday, shall be considered an active member for all purposes until the completion of such term as officer or director. They shall perform voluntary service for a period and in a manner satifactory to the Placement Committee.

C. Sustaining Membership

Sustaining members are those who have reached the age limit for active membership. They shall have all privileges of membership except that they may not hold office or vote.

Section 2. Admission to Membership

A. Eligibility

A proposed member shall be from 19 through 32 years of age on or before her proposal on July 1. She shall have completed her schooling or be in her last year of school. She shall have been a resident of Winston-Salem or its vicinity for at least two years immediately prior to the time of her proposal. In the case of a proposed member who has lived in Winston-Salem or its vicinity at least ten years and has returned after residing elsewhere, the two-year residency requirement prior to proposal shall not apply. At the time of invitation, a proposed member must be residing in Winston-Salem or its vicinity, except in the case of a proposed member whose home is in Winston-Salem or its vicinity but who is away completing her last year of school.

B. Use of Standard Admissions Information Form

- 1. For the purpose of recommending, the Admissions Committee may review and pass a candidate and, if unable to admit her because she no longer resides in the city at the time of invitation, it may by means of the Standard Admissions Information Form, call attention to the availability of this candidate to the Admissions Committee of the League in whose city she may then be residing. She must have resided in another city no longer than one year immediately prior to her proposal.
- 2. The Admissions Committee may, at its discretion, waive the "length of residence" requirement for a candidate on whom the Committee has received a S.A.I.F. from another Junior League. The candidate must meet all other conditions of eligibility and must be proposed and considered by the Admissions Committee in accordance with the By-Laws of the Junior League of Winston-Salem.

C. Proposal of Members

Each candidate shall be proposed by one member and seconded by two members on an application blank provided for the purpose. No candidate shall be proposed or seconded by a member of the Admissions Committee nor of the Executive Committee, nor by her relative (mother, mother-in-law, sister, sister-in-law, aunt, niece, or first cousin). No candidate shall be considered whose name has been proposed and voted on four times.

Proposal for membership shall be received by the Chairman of the Admissions Committee at any time during the year. The deadline for applications for those members to be taken in the following May shall be July 1. Only one blank for each candidate shall be accepted by the Admissions Committee.

Any eligible active or sustaining member may propose one candidate and second one candidate or second two candidates during a given year, but no member shall write to the committee in behalf of a candidate. No member of the League shall contact any member of the Admissions Committee in behalf of a candidate.

D. Election to Membership

The Chairman shall present the names of proposed candidates to the voting members of the Admissions Committee, and each shall vote by secret ballot. Eight affirmative votes of the Admissions Committee shall qualify a proposed candidate for membership. Invitations shall be mailed immediately to those elected. Before the candidate accepts

the invitation, she shall agree to fulfill the duties and obligations of membership. The names of those who accept shall be announced at the Annual meeting.

If a candidate is unable to take the entire provisional course or to transfer to another League, she must decline the invitation to membership. In this event, the invitation shall be re-issued a second time only upon the request of the candidate's sponsors to the Admissions Committee. In the event that a candidate wishes to transfer to another League as a provisional, she must have completed her basic orientation course.

Section 3. Privileges of Membership

Applications for change to another class of membership shall be made in writing to the Corresponding Secretary and will be acted upon by the Board of Directors at any time during the year.

A. Transfer of Members

Provisional, active, sustaining and non-resident members in good standing shall have the right of transferring membership from one League to another except for the period subsequent to March 1 and prior to April 15, when there shall be a transfer moratorium. Members who are in a League special classification may not transfer in such special classification but may transfer only when in a classification recognized by the Association. The right of transfer granted in this section need not extend to a person who has been dropped or expelled from membership by the League to which transfer is desired. Provisional members shall take any additional training required by Leagues to which they transfer. A League may require all active members who are applying for transfer to take an orientation course before their transfers are accepted. A League shall not be required to accept transfers which exceed twenty-five per cent of all admissions to membership in any one year. If it is necessary for transfers to be put on a waiting list, they shall be accepted in the order in which they apply.

B. Inter-League Membership

A member of any League who is subject to frequent change in residence may have an inter-League card issued to the Secretary of the League in which she will be temporarily residing by the League of which she is a member (hereinafter called the home League). Such card shall accredit her temporarily to the League in city where she is then residing (hereinafter called the temporary League). She shall have all privileges of membership in the temporary League except the right to vote or to hold office; or to propose or second candidates for membership in the temporary League; she shall comply with the requirements of and be subject to the rules of the temporary League. An inter-League member shall continue to be listed as a member of, and shall pay her regular dues to the home League, and the home League shall have final responsibility for her in all matters. Inter-League cards shall be for a term of one year. Extensions up to, but not more than two additional years, may be granted by the home League. A League to which a member is temporarily accredited may charge such member for special club privileges or for the actual cost of her membership.

C. Non-Resident Membership

Non-resident membership shall be open to active or sustaining members in good standing, living outside the County of Forsyth, North Carolina, nine months a year.

They may not vote or hold office. Active members who become non-resident in a League town, may retain it for two years only, unless home League grants an extension.

Section 4. Resignations, Dropped Members, Re-instatements

A. Resignations

Any member of the League who is not in arrears in dues or in the performance of League duties may resign. Resignations shall be made in writing to the Corresponding Secretary of the League at least two weeks before dues become payable; otherwise, members shall be liable for dues for the coming year.

B. Dropped Members

Members may be dropped from the League for cause by a three-fourths vote of the Board of Directors.

C. Re-instatements

Members who have resigned while in good standing may be re-instated by a three-fourths vote of the Board of Directors, upon paying a sum determined by the Board of Directors. Provisional members shall be eligible for re-instatement through age 32.

ARTICLE IV - OFFICERS

Section 1. Personnel

The officers of this League shall consist of a President, Vice President, Recording Secretary, Corresponding Secretary, Treasurer, and Assistant Treasurer.

Section 2. Nomination

The Nominating Committee shall present a slate of one candidate for each office to be filled. The slate shall be sent to each voting member of the League at least two weeks before the election meeting.

Independent nominations may be made in writing by five active members of the League, provided the nominee has given her consent.

It shall be the duty of the Nominating Committee to insure continuity of administration by retaining one or more members of the Executive Committee for two terms.

Section 3. Elections

Officers shall be elected at the March meeting of the League for a term of one year with the exception of the Treasurer, who shall be elected for a term of two years. They shall assume their duties immediately after the May meeting.

Section 4. Duties

The powers and duties of the officers shall be as follows:

A. President

The President shall preside at meetings of the League, Board of Directors and Executive Committee: shall appoint the Admissions Chairman and personnel of Committees not otherwise provided for with the approval of the Executive Committee, and shall be a member ex-officio of all committees except the Nominating Committee and Admissions Committee. She shall, with the Treasurer, sign all contracts, and obligations authorized by the Board of Directors, and shall perform the duties pertaining to the office.

B. Vice President

The Vice-President shall assist the President and perform the duties of the President in her absence.

C. Recording Secretary

The Recording Secretary shall keep minutes of the meetings of the League, the Board of Directors, and the Executive Committee. She shall maintain a file of essential records which shall be transferred to her successor at the close of her term of office. She shall, with the Corresponding Secretary, compile the annual reports and edit the year book,

and she shall inform all independent nominees of their nominations.

D. Corresponding Secretary

The Corresponding Secretary shall conduct the general correspondence of the League. She shall assist the Recording Secretary in compiling the annual reports and editing the year book. She shall keep a correct, classified list of the names and addresses of all members and shall handle all correspondence in regard to changes in membership.

E. Treasurer

The Treasurer shall be custodian of the funds of the League and shall receive all monies except for those activities which have their own treasurer or other person specifically appointed to handle finances. Such persons shall be under supervision of the Treasurer. She shall serve as Chairman of the Finance Committee. She shall make payments in accordance with the budget; expenses not provided for in the budget shall be incurred and paid only upon order of the Board of Directors. She shall keep full and accurate accounts and shall present financial statements at regular meetings of the League and Board; she shall turn over to her successor all books and financial records and shall take a listed receipt therefor.

F. Assistant Treasurer

The Assistant Treasurer shall collect all dues and assessments, check attendance records, and assist the Treasurer when necessary.

Section 5. Executive Committee

There shall be an Executive Committee, composed of the officers, which shall assist the President in making appointments. It shall have all the powers of the Board of Directors between regularly scheduled Board meetings. The Minutes of the meetings of the Executive Committee shall be submitted to the Board for ratification at its next meeting.

ARTICLE V — BOARD OF DIRECTORS

Section 1. Personnel

The Board of Directors shall consist of the officers and the chairmen designated by the Executive Committee each year. Chairmen are appointed by the President with the approval of the Executive Committee.

Section 2. Term of Office

Officers are elected for a term of one year; chairman appointed for a term of one year. No officer or chairman shall hold the same office for more than two terms in succession.

Section 3. Duties and Powers

The Board of Directors shall have general charge and control of the affairs, funds and property of the League. It shall be the final arbiter in matters of interpretation of these By-Laws. It shall present to the membership all proposed major program activities for ratification.

Section 4. Vacancies

Vacancies among the officers other than the President shall be filled by election by the Board of Directors upon recommendation of the Nominating Committee. Vacancies among the chairmen shall be filled by the President with the approval of the Executive Committee until the expiration of the term of office.

Section 5. Meetings

The Board of Directors shall hold regular monthly meetings from September through June. Special meetings may be called by the President and must be called upon the written request of three members of the Board.

Section 6. Quorums

Eight members of the Board of Directors and three members of the Executive Committee shall constitute a quorum respectively.

ARTICLE VI - COMMITTEES

There shall be the following Committees who shall present plans for work to the Board of Directors. No work shall be undertaken without the Board's approval.

A. Admissions Committee

There shall be an Admissions Committee whose function shall be to pass upon all proposals for membership to the League (or) to make recommendations to the Board with respect to proposals for membership. The committee shall be elected at the time and in the manner herein provided, and shall serve for one year.

(a) Personnel of Committee

The committee shall be composed of twelve members: a chairman, who shall be appointed by the Executive Committee, and shall not be entitled to vote; two sustaining members who shall be elected by the League and shall not be entitled to vote; and nine voting members, who shall be elected by the League as provided in this Article.

(b) Eligibility to Serve on Committee

To be eligible for election to the Admissions Committee, a member must have been active for at least one year, and a resident of Winston-Salem or its vicinity for at least five years. A voting member shall be eligible to serve for two consecutive years, and shall be ineligible to serve for the following year, except as chairman.

The chairman may have been a voting member of the Admissions Committee for two consecutive years prior to her chairmanship but after her term as chairman shall be ineligible to serve for the following year.

One sustaining member shall have been sustaining no longer than ten years and one no less than ten years. Each shall have served on the Admissions Committee during her active membership.

No one who has a sister, sister-in-law, daughter, daughter-in-law, niece, proposed for membership shall serve on this committee.

No mother and daughter nor two or more sisters shall serve on the same Admissions Committee.

Neither the President nor the Vice-President shall be eligible to serve on this committee.

(c) Election of Committee

Election of this committee shall be held at the April meeting. Two weeks prior to the March meeting the Nominating Committee shall mail to all active members a list divided into three age groups of all active members eligible for election and the names of those present members of the Admissions Committee who are eligible for re-election. These age groups shall be as follows: 21 to 29, 29 to 35, 35 through 39. At the March meeting each active member present may nominate, by secret ballot, four members from her own age group, five members from the present Admissions Committee, and three sustaining members in each category.

Each active member present shall vote for 2 nominees from each age group, for 3 nominees from the present Admissions Committee, and for 1 sustaining member.

In the event that close relatives are elected to this committee, it shall be the duty of the Nominating Committee to determine which of them shall serve.

In case of a tie vote, in either nomination or election of this committee, it shall be the duty of the Nominating Committee to determine which members shall serve.

The names of the Admissions Committee members shall be announced by the President.

(d) Vacancies on Committee

Vacancies on the Admissions Committee shall be filled by the Nominating Committee from among the nominees in the categories in which the vacancies occur. No sponsor of a candidate shall be eligible to fill a vacancy on this committee.

(e) Duties of Committee

It shall be the duty of the Admissions Committee to consider all proposed candidates by acquainting themselves concerning each individual's desirability and qualifications for membership in the League.

A secretary shall be elected by the Admissions Committee from among its members. She, with the Chairman, shall be responsible for keeping an accurate record of all names considered by the committee. These records shall be kept in a permanent file which shall be kept confidential and handed from chairman to chairman for reference by the Admissions Committee.

Members of the Admissions Committee shall take an oath of secrecy, as follows: "I swear that, to the best of my ability, nothing which is said in these Admissions Committee meetings shall be divulged by me, either by statement or implication. I swear that to the best of my ability, my vote will be cast considering the best interest of the Junior League, disregarding my personal feelings."

The Admissions Committee shall hold at least eight meetings during the year.

B. Placement Committee

There shall be a placement committee whose function shall be to interview all active members at regular intervals for the purpose of offering them a free choice of available placements in the community service program conducted by the League. The Placement Committee shall keep as nearly as possible uniform records concerning the activities of the members under its supervision. The Placement of the members under its supervision. The Placement Committee shall include the Placement Chairman, and a vice-chairman, the interviewer, and such other members as they shall designate.

C. Education Committee

There shall be an Education Committee whose function shall be the planning and supervision of the total education program of the League. The Education Committee shall include the chairman and a member of each committee responsible for any part of the Education Program; these committees being designated by the Executive Committee each year.

D. Nominating Committee

There shall be a Nominating Committee whose function shall be to prepare slates of candidates for election to the committee shall be composed of seven members; one, the chairman to be appointed by the Executive Committee; one elected by the Board; and five elected by the League, according to their active period in the Winston-Salem League; one active from one through four years, one active from five through nine years, and two active over nine years.

Two weeks prior to the January meeting a roster of League members eligible to serve on the Nominating Committee shall be mailed by the current Nominating Committee to all active members. At the January meeting each member may nominate the number to be elected from each group. The three candidates receiving the highest number of votes in the first two groups and the 4 candidates receiving the highest number of votes in the third group will appear on the final ballot for election in February. The Placement Chairman shall serve ex-officio.

E. Public Relations Committee

There shall be a Public Relations Committee whose function shall be to arrange for all newspaper, radio and television publicity for the League. It shall attempt to build good public relations by interpreting all League activities to the public so that community understanding, interest and support will result. The Public Relations Committee shall include the Public Relations Chairman, and a member of each committee responsible for each phase of the League program. No member of the League shall give out to the press any news item or information concerning the League without the approval of the Public Relations Committee.

F. Newssheet Committee

The Newssheet Committee shall consist of the Newssheet Editor, as chairman, and such assistants as she may require. The duties of the Newssheet Committee are to edit and publish the Newssheet.

G. Finance Committee

There shall be a Finance Committee which shall function as the financial fact-finding committee to advise the Board on all matters relating to the financing of the League's own administration and that of its community program.

Among its duties shall be the preparation of the budget for presentation to the Board each year. The committee shall include the Treasurer as chairman, the Assistant Treasurer, the treasurer of any money-raising activity, either permanent or temporary, and a past League Treasurer.

H. Magazine Committee

There shall be a Magazine Committee or chairman whose function shall be to discover and report all developments in League activities which might be good material for the Junior League Magazine as well as to follow up suggestions and requests from the Junior League Magazine as a program aid in its own League.

I. Provisional Committee

There shall be a Provisional Committee whose function shall be to plan and direct the education and training of provisional members until such time as they are admitted to active membership.

J. Advisory Planning Committee

There shall be an Advisory Planning Committee whose function shall be to help the Board improve present League administration and program and plan for the future. The committee makes recommendations to the Board but does not, itself, take any action.

K. Project Research Committee

There shall be a Project Research Committee whose function shall be to investigate possible projects, study requests, and to recommend the most suitable ones to the Board and to the membership for consideration.

L. Special Committees

Special committees shall be appointed by the President with the approval of the Executive Committee which shall designate their powers and the term of the committee's appointment.

ARTICLE VII - MEETINGS OF THE LEAGUE

Section 1-Annual Meeting

The annual meeting of the League shall be held in May for the purpose of receiving the annual reports and of installing officers for the ensuing year.

Section 2-Regular and Special Meetings

Regular meetings shall be held from September through May, the March meeting being designated for the election of officers. Other meetings shall be held at the discretion of the Board of Directors or upon written request of ten members of the League.

Section 3. Quorum

A quorum of the League shall consist of one-third of the voting members.

ARTICLE VIII — FINANCIAL ARRANGEMENTS

Section 1. Fiscal Year, Audit and Bonding

The fiscal year shall be from April 1 through March 31.

The books of account of this League shall be audited at least annually by a certified public accountant, and a copy of the complete audit shall be distributed to each member. Books shall be kept in accordance with sound accounting practices. The community funds and administrative funds shall be carried in separate accounts. All money in the community fund shall be distributed solely for the benefit of the community.

The Treasurer shall be bonded in the amount determined by the Board of Directors,

Section 2. Membership Dues and Fines

All classes of membership shall pay annual dues of not more than \$20.00, which shall include the Association dues of \$7.00, part of which covers the subscription to the Junior League Magazine. Provisional members shall pay an initiation fee of \$25.00.

There shall be a fine of one dollar to each active member and provisional member for non-attendance of regular meetings and special meetings, and a fine of two dollars for non-attendance of the Annual meeting. Sickness, absence from the city, or an unusual emergency shall be the only acceptable excuses for an absence. It shall be made in the form of a letter to the Assistant Treasurer, written the week of the meeting. Such fines shall be payable monthly. An additional 25-cent penalty for each month a fine is in arrears shall be added.

Junior League members, other than non-resident, inter-League, and sustaining, who do not complete their Rummage Sale quota, will be allowed to do so before the sale at the discretion of the Quota Chairman.

A. Payment

Dues shall be payable on the first day of the fiscal year. The Assistant Treasurer shall send notices to each member on April 1. Members whose dues and fines are not paid by May 1 will be notified by card by the Assistant Treasurer. Members whose dues and fines are not paid by May 15 will be sent a certified letter. Members whose dues and fines are not paid by June 1 will be dropped by the Board of Directors. The only acceptable excuse for non-payment is financial disability, made in writing each year, and received by the Assistant Treasurer on or before June 1.

B. Refunds

Refunds of dues will not be made to members resigning during the fiscal year.

Refunds will not be made to Provisionals failing to meet the requirements.

C. A. J. L. A. Indebtedness

Members delinquent in paying this indebtedness to the Association shall be considered in arrears in their dues to this League.

Section 3. Association Dues

The Treasurer of the League shall pay yearly per capita dues for all classes of membership to the Treasurer of the Association.

Section 4. Letters, Agreements and Contracts

Before any letter, agreement, or contract involving the expenditure of Junior League funds shall be signed and delivered, it shall be approved by the Board of Directors. If it involves more than \$500.00, it shall also be approved by the Junior League attorney.

ARTICLE IX — DELEGATES TO ASSOCIATION CONFERENCES

Delegates to the Annual Meeting of the Association shall be active members elected by the League.

Delegates to special meetings or conferences shall be active members appointed by the Board of Directors.

The full expenses of delegates to conferences and the Annual Meeting of the Association shall be paid by the League.

ARTICLE X — AMENDMENTS AND RULES OF ORDER

The By-Laws may be amended by a two-thirds vote of the members present and voting at any meeting of the League, provided the proposed amendment has been mailed to each voting member at least two weeks prior to the date of the meeting; or provided the proposed amendment shall have been presented over the signature of five active members at least one meeting prior to that at which action is taken, and due notice of such meeting or action is given the membership.

Roberts Rules of Order (Revised) shall be the parliamentary authority for all matters of procedure not specifically covered by the By-Laws or by specific rules of procedure adopted by the League.

STANDING RULES

- 1. It shall be the duty of the Board to enforce the By-Laws of the League and the Association Policies binding on all Leagues.
- 2. It shall be the duty of the Board to create, maintain, evaluate, and revise the Mannual of Procedure by which it carries out the duties and powers delegated to it in the By-Laws.
- 3. It shall be the duty of the Board (before the beginning of the working year) to present to the League a suggested program for ratification.
- 4. It shall be the duty of the Board, in drawing up the program, to give serious consideration to the interest and capacities of the members, and the number who can take an active part.
- 5. It shall be the duty of the Board to see that a contingency reserve be maintained in the community fund.
- 6. Any committee requests for unbudgeted funds shall be approved by the Board and any request of \$200 and over shall be presented to the Board and membership for approval.

ASSOCIATION POLICIES BINDING ON ALL LEAGUES

AS REVISED APRIL, 1952

POLICY I - GENERAL

- A. The Association shall act in an advisory capacity to the Leagues except as otherwise stated in the By-Laws or in the policies and standing rules adopted pursuant thereto.
- B. The Association shall have the right to protect the Leagues from action by one League which may adversely affect the program, standing or fund-raising of other Leagues.
- C. The Junior League shall encourage their members to accept the responsibilities of good citizenship and to educate themselves in all legislative, political and governmental movements which affect the life of their communities, their countries and the world, and shall endeavor to stimulate their members to exercise their respective citizenships intelligently.

POLICY II - COOPERATION AND SPONSORSHIP

- A. The Association may participate in, cooperate with or sponsor any organization, movement or program, which in the judgement of the Board of Directors, as represented by a three-quarters affirmative vote of the members of the Board, will further the purpose of the Association. The Board will inform any such organization that active participation by the individual Leagues is optional. The association shall not engage in legislative action.
- B. With respect to a conference, meeting or institute of any state, national or international organization, A JUNIOR LEAGUE may:
 - (a) sponsor or co-sponsor the conference, meeting, or institute
 - (b) Cooperate with the sponsoring organization
 - (c) participate in the conference, meeting, or institute
 - (d) hold a meeting of Junior League members in connection with any such conference, meeting, or institute

provided that, the Junior League first obtains pertinent information from the Association Administrator and clearance from its Regional Director.

POLICY III - ACTION

- A. Junior League may take action on a national, international, state or local public question, provided that a study of the specific problems and the legislative or administrative measures involved has been made, and that the action taken by that League is compatible with the stated purpose of the Association and its member Leagues; does not adversely affect any other League; is not contrary to the policies of the Association; and is subject to the following:
 - 1. Action may be taken on a national or international public question provided the League has first obtained approval from the Board of Directors of the Association, as represented by a three-quarters affirmative vote of the Board of Directors.
 - 2. Action may be taken on a state public question provided the League consults its Regional Director and follows Association legislative procedures.
 - 3. Action may be taken on a local public question at the discretion of the League.
 - 4. Action may not be taken in support of or in opposition to a candidate for public office.

POLICY IV - FINANCIAL

- A. The Association shall not act for others as a fund-raising agent.
- B. The Association shall not make financial contributions to individuals, other organizations or agencies. Financial support may be rendered for direct services.

POLICY V — PUBLIC RELATIONS AND PUBLICITY

- A. The Association shall endeavor to protect the name "Junior League" from missuse, and shall take all action which may be advisable to that end.
- B. All references to the Association should be based on facts by current material made available from the Association. This material can be secured from the Regional Directors or the Association office.
- C. Any use of the Junior League name in connection with publicity shall identify the League or Leagues involved.
- D. Any publicity of a Junior League designed to extend beyond its community area must be approved by the Association office.
- E. A Junior League member may publicly identify herself as such only when such identification is in connection with an affiliation or activity compatible with the stated purpose of the Association and its member Leagues and the policies of the Association.

POLICY VI — COMMERCIAL ATTACHMENTS AND MONEY-RAISING

- A. The Association shall not recommend the exclusive use of a specific commercial product nor the services of a specific commercial concern.
- B. A Junior League membership list is for the use of the Junior League only and cannot be used for promotion of any activity unrelated to the Junior League. It shall not be used for personal gain or made available for commercial or solicitation purposes.
- C. A Junior League may cooperate with commercial concerns, provided the attachment is consistent with the standards of quality and dignity expressed by the Junior Leagues and the Association, and does not recommend exclusive use of a specific product or concern.
 - 1. Sponsorship of a Junior League activity by reputable firms is permitted for local broadcast, telecast or other media of communication.
 - 2. Sponsorship of a Junior League activity by reputable firms on a regional, national or international basis is permitted provided such sponsorship has been approved by the Association office.
 - 3. Direct selling in a commercial portion of a radio or television program, or in other media of communication, is permitted so long as it is in keeping with the quality of the presentation itself, feature articles in good taste, and does not recommend the exclusive use of a product by the Association, any member League, League member, or person representing the Junior League, Samples of the commercial copy must be submitted for approval by the sponsoring League to the Association office.
- D. A Junior League member may be identified as such in commercial endorsements, only in League publications and/or in connection with League money-raising activities. No Junior League member may be identified as such for personal gain.

Policies VII and VIII embody the "Minimum Standards" which all Leagues require of themselves and each other. Their observance and enforcement are the responsibility of each individual League and its officers. Visiting Board and Staff members are obligated to point out apparent deviations from these standards, but the responsibility for constant self-evaluation rests with the League, not with the Association. These policies should be printed with each League's By-Laws. These are policies as revised April 1952.

POLICY VII — MINIMUM STANDARDS

Each member League shall incorporate in its charter, constitution, or By-Laws, the following material:

- A. A statement of its name, which shall be limited to the words "Junior League of (name of city, town or community in which located)."
- B. A statement of its purposes, which shall include the statement of individual purposes stated in Article I, Section 1 of the By-Laws of the Association.
- C. A statement that its policies shall be in harmony with the Policies of the Association.
- D. Provisions complying with the requirements of Article II of the By-Laws of the Association. (No other classes of membership shall be permitted; provided, however, that (a) individual Leagues may have a limited number of honorary members, and (b) Leagues which as of April, 1947 had classes, including life members, may continue such classes for their present membership, but shall not admit any additional members thereto).
- E. A requirement that all provisional members shall complete a course which shall meet the standards set by the Association, and shall perform voluntary service for a period and in a manner satisfactory to the Placement Committee.
- F. A requirement that all active members shall justify their membership through some form of community service satisfactory, in quality and extensiveness, to the Placement Committee (the term community service being defined as including volunteer work for, and service on Boards and Committees of any philanthropic or humanitarian community organization of high standing in the educational, civic, cultural or social welfare field).
- G. A requirement for the following committees:
 - 1. An Admissions Committee, whose function shall be to consider the qualifications of all candidates proposed to membership in the League and elect new members or recommend candidates to the Board for election.
 - 2. An Education Committee, whose function it shall be to plan and supervise the educational program of each League.
 - 3. A Finance Committee, among whose duties shall be the initial preparation of the annual budget of each League.
 - 4. A Nominating Committee, whose function it shall be to prepare slates of candidates for election to the various elective offices of the League. The committee shall also cooperate with the Regional Nominating Committee and whenever possible suggest candidates for regional slates.
 - 5. A Placement Committee whose function shall include the interviewing of all Active members at regular intervals and the offering to them of a free choice of placements as provided in (F.) above.
 - 6. A Provisional Committee, whose function shall be to plan and direct the education and training of Provisional Members until such time as they are admitted to Active Membership.
 - 7. A Public Relations Committee.

- H. The books and accounts of each League shall be kept in accordance with sound accounting practices; each League shall maintain a community fund separate and distinct from its administrative fund; all money in the community fund shall be distributed solely for the benefit of the community. Annually a copy of the audited balance sheet (statement of Assets and Liabilities) and profit and loss statement (statement of income and expense) shall be distributed to each member of the League.
- I. A requirement that the Board of each League shall present to the membership all proposed major program activities for ratification.
- J. The Regional Director shall be invited to visit each League in her Region during her term of office. Acceptance of such invitation shall be at the discretion of the Director.

POLICY VIII - MINIMUM STANDARDS

- A. The course for provisional members of all Leagues shall be based upon all topics covered in the Association's basic provisional course outline. Each League shall send to the Association annually, an outline of its provisional course as soon as reasonably possible after the completion of the course.
- B. The Placement Committee of each League shall interview all active members at regular intervals in order to plan and supervise their free choice of community service as defined in Policy VII, F, and shall keep as nearly as possible uniform records concerning their activities.
- C. No individual League shall associate itself with nor endorse any welfare or other similar project, program or activity which does not meet accepted standards in its field, or show evidence of working toward such standards.
- D. All money-raising, on the part of individual Leagues, shall be consistent with standards of dignity and good taste and in keeping with the laws and customs of the community.
- E. Each League shall send to the Association annually a copy of its audited annual statement.
- F. Each League shall maintain the same standards as required of applying groups under Article 11-A, Section 2 of the Association By-Laws.

Association Procedures Applying To All Leagues

Arranging Inter-League Memberships:

Section 1.

Inter-League cards issued pursuant to Article II-B, Section 2, of the By-Laws, shall be for a term of one year. Extensions up to, but not more than two additional years, may be granted by the home League.

Section 2.

The League to which a member is temporarily accredited may charge such member for special privileges or for the actual cost of her membership.

Section 3.

- (a) A member desiring an inter-League card shall notify the Secretary of the home League.
- (b) The Secretary and the Treasurer of the home League in consultation with the Placement Chairman shall determine whether said member is in good standing.
- (c) The Secretary of the home League shall issue an inter-League card to the Secretary of the temporary League.

- (d) The inter-League card becomes effective immediately upon receipt by the Secretary of the temporary League.
- (e) The Secretary of the temporary League shall notify the Secretary of the home League that the inter-League card has been received.
- (f) The Secretary of the home League shall give to the member the name and address of the Secretary of the temporary League.
- (g) The member shall be responsible for contacting the Secretary of the temporary League.
- (h) The temporary League may charge such member for special privileges or for the actual administrative cost of her membership.
- (i) When the period of inter-League privilege expires, the Secretary of the temporary League shall return the card to the Secretary of the home League.
- (j) If the member requests an extension of the inter-League privilege from her home League and the home League determines that an extension is justifed, the Secretary of the home League reissues the card to the Secretary of the temporary League.
- (k) When the inter-League privilege terminates the Secretary of the home League shall cancel the card.
- (1) The Secretary of the home League shall notify the Association Headquarters of changes of address occurring as a result of the member's move to and from her temporary League area.

Arranging Transfer of Members

Section 1.

The Secretary of the League from which a transfer is made shall be responsible for filling in the information regarding the member's record called for by the transfer card supplied by the Association. She shall also certify that the transferring member is in good standing and shall then forward the transfer card to the Secretary of the League to which the transfer is made.

Section 2.

Transfers shall meet the conditions of acceptance provided in the Association By-Laws, Article II-B, Section 3, and shall be accepted by the Board of Directors or Executive Committee of any League, unless the member has no right to transfer under the provisions of the same Article. Transfers shall be accepted in order of application, except that applications of members under forty may be given precedence over those of Sustaining members. Transfers shall become effective upon acceptance. Within 15 days thereafter the Secretary of the League to which the transfer has been made shall notify, on transfer cards supplied by the Association, the Membership Records and Circulation Department at Association headquarters and the member's former League.

Section 3.

A member transferring from one League to another shall become subject to the jurisdiction of the League to which she transfers on the date on which such transfer is accepted. A League receiving a transferring member may charge such transferring member the actual administrative costs incurred by such League in connection with her transfer.

Section 4.

A member of a Junior League, who is also a member of an Applying Group which is taken into the Association, upon the acceptance of the new League into the Association, must either request a transfer from her home League or submit her resignation to the new League no later than March 10 of the Association fiscal year in which the new League is accepted.

A.J.L.A. GUEST ROOM INFORMATION

Junior League Section

The Junior League Guest Room Section of The Waldorf-Astoria is located on the 19th and 20th floors of the hotel's West (Park Avenue) side, and consists of 32 rooms.

For the convenience of our members, a lounge is maintained on the 20th floor. A waitress is in attendance from 2:00 until 9:00 p.m., to serve tea and beverages.

Cots and cribs may be put into guests' rooms upon request. A cot is \$5.00 plus 5 per cent city tax per night, but there is no charge for a crib.

Sitters for children may be secured through the AJLA Desk.

Cars may be stored at a nearby garage for \$3.75 per night, including pick-up and delivery.

Accommodations

16 rooms—double occupancy—twin beds and private bath. Rates \$17.00 and \$19.00 daily plus 5% city tax.

16 rooms—single occupancy—2 with private baths. Rates \$7.00, \$8.00, \$9.00, and \$10.00 daily plus 5% city tax.

Reservations

In writing for information or to make a reservation, always address Guest Room Hostess, Association of the Junior Leagues of America, Inc., The Waldorf-Astoria, New York 22, New York.

Reservations cannot be accepted more than three months in advance. In case of cancellation, an immediate wire is requested. Cancellations made less than 24 hours in advance will be billed at full rate. This not only protects the Association against loss, but prevents the turning away of members who otherwise could be accommodated.

Reservations received by wire are answered by Western Union collect. Please indicate the name of your League when making reservations,

Since there are so few rooms in the Junior League section, it is only possible to assign the best accommodations when the exact dates of arrival and departure are known in advance. It is often impossible to retain rooms longer than the time specified in the reservation, due to the fact that they are reserved for the very date they are to be vacated.

Registration

Length of Stay

Because of the great demand for accommodations, it has been found necessary to limit the length of stay to one month each six months.

AJLA Departure Time 12 noon.

Those retaining their rooms after departure hour will be charged for another day. Due to heavy bookings, we are unable to promise that accommodations always will be assigned immediately upon arrival.

Eligible Guests (other than League members)

Members of immediate families (husbands, children, parents, brothers and sisters) may be accommodated for a period not exceeding two weeks when the League rooms are not otherwise oc-

cupied. If accompanied by a League member the period is extended to one month.

Written authorization from a League member is REQUIRED for reservations of members of her family. Members are requested to write AJLA for the necessary form to be filled out in advance of making family reservations. No form is necessary, however, if the member accompanies her family.

Guests other than League members (or their immediate families) may be accommodated only when accompanied by a League member. League members need not request a form in advance when accompanying non-members. The daughters of Junior League members may be accompanied by friends when sponsored in accordance with established procedures.
