HISTORY OF THE ASSOCIATION OF JUNIOR LEAGUES OF AMERICA

The Junior League represents a serious endeavor on the part of young women to become active and constructive factors in the communities in which they live, to be intelligent citizens, and to assist in promoting human welfare. In addition to providing the member with channels of work and training for volunteer service, the Junior League helps her to realize two vital concepts: (1) that she is not an onlooker, but is herself a part of the community; (2) that the community, in turn, is not an isolated unit but part of the nation and of the world.

It was in 1901, at the beginning of a new era for American women, that the first Junior League was organized in New York. At that time Mary Harriman (Mrs. Charles Carey Rumsey) and Nathalie Henderson (Mrs. Joseph Swan) realized what might be achieved if a group of young women were encouraged to take a more active part in some form of active service to their own neighborhoods through the settlement houses and other organizations in existence at the time.

Soon similar organizations to that in New York were formed in various other of the large cities—Boston; Brooklyn; Portland, Ore.; Baltimore; Philadelphia, and Chicago. In the spring of 1912 six of the seven Leagues then in existence held their first national conference in New York City. In 1921 the Association of the Junior Leagues of America, Inc., was founded by the thirty Leagues then in existence. Mrs. Willard Straight (Mrs. Leonard K. Elmhirst) was elected president and a Board of Directors was appointed and instructed to draw up a constitution.

After 1921 the Association grew rapidly until, in 1923, there were sixty-three Leagues. In order to establish a closer contact between the Leagues and the Association, the country was divided into six territories and in each a League member was appointed regional director to act as liaison officer between the Leagues of the region and the Association and to serve on the latter's Board of Directors. Now there are twelve regions, in each of which the Leagues elect every second year a member to serve as their regional director.

At the time the Association was first formed most League activity was in the realm of social work but the Board of Directors, realizing the opportunities which would eventually offer themselves to Junior Leagues, set down in the constitution the social, economic, educational, cultural and civic fields as those in which Junior Leagues should interest their members.

Gradually the Leagues realized that a benevolent "doing for others" was not enough, that they must form a partnership with professional community workers to effect the improvement of conditions. To do this required knowledge. As evidence of this the first course for provisional members was established in 1921 and such a course, which includes an examination of the various forces at work in the community, has been a prerequisite for

active membership since 1927. Originally League projects were large enterprises-convalescent homes, day nurseries, curative workshops and the like. It was discovered, however, that to support these undertakings a disproportionate amount of time and energy often was going into money-raising to the exclusion of the educational process of volunteer service. Today where Leagues have projects the recommended type is one in which the demonstration element is present, the choice being based on the needs of the individual community in the light of the interest and money-raising capabilities of the League.

The League's realization of the need for expert guidance in their welfare activities soon led to the establishment of a trained social work staff at the Association's offices. Members of this staff were available for visits to Leagues to study the local situation and give advice. Similar service was then made available for Children's Theatre, Arts, Ways and Means, and Publicity. The Association also publishes the Junior League Magazine, issued monthly to each Junior League member. At the present time the Association has 181 member Leagues, 173 in the United States proper, one in Honolulu, one in Mexico City, and six in Canada, comprising a total of some 60,000 members.

HISTORY OF THE WINSTON-SALEM JUNIOR LEAGUE

The local League was organized in 1923 by about forty of the girls and young women of Winston-Salem with Mrs. Thurmond Chatham as president. We were the 46th League to be admitted to the Association, and the first in North Carolina.

During the second year, under the presidency of Mrs. Paul Montague, our League adopted the point system, and sponsored a pre-natal clinic, which, at the time, was the only one of its kind in North Carolina.

In 1925, with Mrs. Kenneth Mountcastle as president, we brought Will Rogers and the de Reschke quartet to town, opened a gift shop, and began a training course for Provisional members.

During Mrs. Fay Huntley Spencer's (now Mrs. Edwards) administration we undertook the financing of our Hospital for Incurables.

In March, 1928, Mrs. Charles Long became president and on the fifteenth of that month we opened a Beauty Parlor. On May fifteenth we had Paper Day. In this same year the Arts and Interests and Children's Play Committee was formed.

In 1929 Mrs. Ralph Hanes was elected president and was instrumental in starting our monthly Newssheet with Miss Dell Norfleet as its first editor.

In 1930-31, under Mrs. Elsie Hines Norfleet's (now Mrs. Charles Siewers) leadership, we became more nationally minded with respect to the Junior Leagues of America, and began to take a more active part in community affairs as well. We helped to organize the Civic Music Association, began our yearly assistance to the Community Chest Drive, opened a Rag Market (later the Thrift Shop), and initiated Occupational Therapy classes in our hospital.

With Mrs. James Hanes as president in 1932, work began on a placement system, and under Mrs. Linville Martin in 1933, we put the system into effect.

From 1934 to '35, with Mrs. James Hanes serving her second term as president, the League's most important work was the continued operation of the Hospital for Incurables.

In 1935, under Mrs. W. H. Sprunt's presidency, the Winston-Salem Play Group was chosen to represent the medium-sized Leagues at the Children's Theatre Conference in Baltimore.

In March, 1936, Mrs. W. K. Hoyt was elected president. During her term of office we employed a Professional Placement Secretary, and the League as a whole became more familiar with the needs of the community. On June 1, 1937, after the opening of the Forsyth County Hospital and the satisfactory placing of all our patients, the Hospital for Incurables was closed.

In the spring of 1937, we assisted in the organization of the Mental Hygiene Society of Winston-Salem. This society asked the League to finance a Child Guidance Clinic for a demonstration period, and on November 1, the Clinic was opened in the League's Hospital Building. Through professional Placement secretaries we were able to give specialized training to our volunteers.

In 1938, Miss Aurelia Plumly (now Mrs. Ralph Spaugh) was elected president. The League, at a cost of \$1,200 per year, continued to sponsor and finance the Child Guidance Clinic, which was under the supervision of the Mental Hygiene Society. Our projects included assistance at the Christmas Exchange, the new Hall of History, and the presentation by Jr. Programs, Inc., which we brought to town. The chief undertaking, however, was the bringing to the community of four New York Dramas of the Contemporary Theatre Series, from which a profit of \$5,000 was made.

With Mrs. A. S. Johnson as president in 1940, the Child Guidance Clinic was moved to new quarters, reorganized, and became affiliated, through its director, with the Bowman Gray School of Medicine in this city. The play group was most active and received national acclaim for its excellent work. Acting on advice from Mrs. Dingman, Secretary of Ways and Means of AJLA, our system of budgeting was revised and a plan for maintaining separate accounts for Administrative and Community Program funds was put into effect. A plan was worked out for conservative spending of the surplus over and above a contingency fund.

In March, 1941, Mrs. Linville Martin was elected to serve as Director of this Region for a two-year term.

The League joined with other interested community groups in forming the Children's Theatre Board, whose purpose is to provide a year-round program of entertainment for the city school children. The League is represented on this Board by the Children's Theatre Committee chairman and two other members of the committee. The Board is responsible for the promotion, financing, and transportation of the children to the entertainments it sponsors. The League's major production became a part of the Board's yearly series, and the League ceased the annual trouping of a smaller play to the city schools.

During the presidency of Mrs. Thomas Rice, from 1941-43, many changes took place. The program of planned expenditure of surplus, advised by the AJLA Staff, was begun: \$3,000 was donated to the Red Cross War Fund, \$1,000 was given to the Library Fund of the Winston-Salem Teachers College, and \$5,000 was given to the Family Service Agency for the establishment of a Child Placing Agency.

A Radio Institute, conducted by Miss Gloria Chandler, AJLA Consultant, began our entrance into the cultural field, and the League allocated \$4,500 to the Community Council for the development of the Radio Plan.

In 1942 the Director of the Child Guidance Clinic resigned, and no replacement was available. The Clinic was evaluated by a special committee which recommended that it be closed.

Mrs. Helen Lipscomb, of the Staff, conducted a Board Members' institute.

The League was very proud to have one of its members, Mrs. Linville Martin, elected President of the Association of Junior Leagues of America. On March 1, 1943, the gift shop was sold to Miss McPhail.

During the term of Mrs. Irving Carlyle, 1943-44, the League began to feel the full impact of World War II. Many of the younger members were away with their husbands, who were in service, while those at home devoted the major part of their volunteer service to war-related activities, such as Red Cross, Bond Sales, Rationing Board, and USO.

A Cultural survey of the community was made by Miss Virginia Lee Comer, AJLA Arts Consultant, which revealed a need for the development and expression of the creative arts.

From 1944 to 1945 Mrs. George Walker served as president. The League voted to support the Radio Council for a three-year period, allocating \$2,500 per year. A donation of \$1,000 was made to the Wachovia Historical Society to provide a part-time Director for its Museum. The League gave \$600 to the Piedmont Festival and assisted in the sale of tickets to its performances.

In 1945 the Beauty Parlor was sold because the League deemed it unwise to operate a shop in competition with local business, and its community service program was amply protected by a contingency fund.

In a Staff visit for the Arts Program, Miss Comer advised: "Conditions in Winston-Salem indicate that the League would be wise to strengthen already established agencies; i.e., museum, library, recreation department, public schools . . . "

In 1945-46, upon the return of many members who had been away during the war, the League expanded its program under the leadership of Mrs. Thomas Moore, and, on the advice of AJLA, donated the major part of its surplus to the community. Three Staff visits, two in connection with League finances, and one for the Arts program, helped to get the plans under way.

A portion of the invested surplus, consisting of four hundred shares of Reynolds B stock, was turned over to the community: fifty shares to the City-County Hospital; fifty shares to the War Memorial Building Fund; one hundred twenty shares to the Mental Hygiene Society; one hundred eighty shares to the City Library.

The Junior League Hospital Building was deeded to the Winston-Salem Foundation.

The League brought Mrs. Chester Marsh to the community for a three-year demonstration as Arts and Crafts Director for the City Recreation Department, which made space available for a Workshop to carry on the activities.

From 1946-47, Mrs. Bowman Gray served as president. During the summer a story-telling program was conducted at the Wachovia Museum. In January, a Staff visit for reorganization of the Thrift Shop resulted in improved management of this project, and we were advised to appoint a project-finding committee.

The League continued its financial support of the Radio Council and the Arts and Crafts program. A survey of fifty-six groups in the community revealed interest in the establishment of an Arts Council, and \$7,200 was put aside from surplus for the employment of a Community Arts Coordinator when the Council proved its readiness to handle the money. The remainder of the invested surplus was donated as follows: \$1,800 to the City Library; \$950 to the Radio Council.

The League contributed \$500 to the Piedmont Festival and sponsored a concert of the newly-formed Winston-Salem Civic Orchestra (now the Winston-Salem Symphony) by selling tickets and handling newspaper and radio publicity. \$750 was given the Leisure Time Division of the Community Council for a coordinator of youth activities at the Fairview Playground, which is in an area not served by any other organization.

During the two-year term of Mrs. Robert Lawson, from 1947-49, a change in the Arts and Crafts Program took place. Half-way through the three-year demonstration, the City Recreation Department withdrew its support when the building which housed the Department was sold. The advice of AJLA was sought, and a visit from the AJLA Arts Consultant, Miss Virginia Lee Comer, helped to clarify the situation. In the letter of recommendation following her visit, Miss Comer advised that a strong Board with committee structure be formed for the Workshop. An Interim Committee, composed of League members and others interested, was formed for the Workshop. This committee organized the Arts and Crafts Association, which assumed responsibility for the administration, financing, promotion of the Workshop. The League agreed to pay the salary of the Director for a three-year period ending October, 1950, and pledged its support to see the program stabilized in the community.

Further advice in Miss Comer's letter of recommendation was that: a Board Members' Institute be held; we considered ways of lightening the president's job in order that she might be able to serve for two years; our League should adjust its thinking concerning projects, and should know the workings of any agency with which we have a project in the future.

The League voted to contribute \$500 per year for a two-year period toward the support of the Children's Programming Committee of the Radio Council, and also loaned \$1,200 to this committee for the transcription of a radio series, "Storytime."

Mrs. Albert Butler, Jr., was president during the year 1949-1950, when our financial commitments to the Radio Council and to the Arts and Crafts came to an end. The League voted to continue its yearly appropriations of \$3,000 to the Arts and Crafts Association through March 1951, \$250 to the Piedmont Festival, and \$250 to the Winston-Salem Symphony.

Working with the Piedmont Festival and the Chamber of Commerce, the League helped to organize the Arts Council.

A Project-Finding Committee was appointed.

During the term of Mrs. Clifton Pleasants, 1950-51, the League voted to release the gift of \$7,000 which it had held

in trust for the Arts Council, and in August 1950, Miss Gertrude Elliot was employed by the Council as Coordinator.

The request of the Arts and Crafts Association for further support of the Workshop in the amount of \$3,000 was granted through March 1952. \$250 was given to the Winston-Salem Symphony Association. The Junior League play, "Indian Captive," was presented to the county school children at the Mineral Springs Auditorium.

From 1951-52 Mrs. John Whitaker served as President. The Arts Council established an Art Center by moving its member groups, including the Workshop, into a building owned by the Winston-Salem Foundation.

The Project-Finding Committee received a letter from the Arts and Crafts Association, requesting that "... the Junior League consider association with the Arts and Crafts on a permanent basis." The Board turned down this request for permanent support and recommended to the League that it ask the Association to make a specific request.

The League was advised by AJLA to evaluate, to continue Project-Finding, and to have a League Administration Institute. A comprehensive evaluation of the League's administration and program was made. Mrs. Emma Buettner, General Program Consultant from AJLA, conducted the League Administration Institute, and upon her advice a Manual of Procedure was compiled for the use of Board members.

The county school children were brought to Reynolds Auditorium to see the Junior League play, "Tom Sawyer."

After careful consideration, the Board voted to release the Children's Programming Committee from its obligation to return to the League the \$1,200 loaned it for the purpose of transcribing "Storytime."

On March 31, the League's financial contribution to the Arts field was completed through coordination of fund raising for the Arts groups under the Arts Council.

The League entered its 30th year with Mrs. Frank Borden Hanes as president. The Project Finding Committee was reactivated, and after long and hard studies in the many fields open for our sponsorship, a Children's Program emerged as the most popular field for a project. After further studies the League voted a three-fourths majority for a Children's Activities Program at the new City-County Library. A letter of contract was drawn up between the Library Board and the Junior League, allocating \$1,500 to the Program the first year, and limiting the League's sponsorship to three years.

The 30th anniversary was celebrated with a Mardi Gras Ball on February 6. Commemorating the League's 30 years of volunteer service, the Public Relations Committee published a Brochure interpreting the functions and purposes of the League.

The Thrift Shop was budgeted for \$5,000 to assure the League of sufficient funds to undertake its new project, maintain a contingency fund and continue its membership in local organizations. To help raise this money, a fall Fashion Show was

held and a Strip for Thrift dance during the anniversary celebration. Both of these functions netted the Thrift Shop approximately \$1,000 and they were able to turn over to the League in March, approximately \$4,800.

"Beauty and the Beast" was presented to the City School children in March.

The League continued its interest in the Arts Council by voting to give them \$500 to assist in financing their expanded program and again voted to support the Arts Follies one hundred per cent.

At the annual conference in May, Region V was divided and Region XIII formed. We thereby became a member League of Region XIII.

In 1953-54, under Mrs. Edward F. Heefner's leadership, the League launched the Children's Activities Program at the City-County Library and sponsored two art exhibits. These projects were made possible by The Thrift Shop profits of \$2,850.92. \$1,300.00 profit was used for renovations at the Thrift Shop.

Diversified Placement was achieved by volunteers serving on the above projects as well as our Children's Theatre Play, "The King's Balcony," a Thrift Shop Fashion Show and Commission Contest, projects of the Radio-TV Council, Arts Council, United Fund Divisions, and Recreational Therapy done in the Children's Wing of the Baptist Hospital.

The League was initiated into television by sponsoring a thirty-minute program on our Children's Activities Program at the Library, and being a co-sponsor of a program on the United Nations.

The Public Relations Committee honored Mr. Ralph Hanes and Mr. Meade Willis for their work at the Library by presenting certificates of appreciation to them, and books to the Library in their honor. The Public Relations Committee was also responsible for the making of smocks which are being worn by League volunteers.

A new system, whereby only the members of the Admissions Committee voted for League candidates, proved successful. Also inaugurated was a new system of the Executive Committee appointing the Nominating Chairman, rather than the Nominating Committee electing her.

For the first time, advertising paid for over half of the cost of printing the League Newssheet; and the League Administrative Fund balanced without dipping into surplus funds, with \$1,700.00 being added to our Contingency Fund in the Community Account.

A special Survey Committee answered the AJLA Questionnaire and suggested reducing the budget by reducing the staff of consultants to a limited number of general consultants, and eliminating many of the special consultants.

Mrs. Edward S. Heefner served again as our President in 1954-55. When it became necessary to vacate the Thrift Shop, a very successful Rummage Sale was held by the League. The two operations netted a total of \$6,602.53.

The Children's Activities Program at the Library completed its second year of operation with a good record of achievement.

The Public Relations Committee had a luncheon honoring the people in the community who have helped with the League program.

A record player was purchased for the Hospital Therapy Project at the Baptist Hospital.

League Volunteers counted over a thousand attendance at the Art Exhibit which was sponsored by the League.

Four performances of the "Camel with the Wrinkled Knees" was given by the Children's Theatre Group.

The TV Committee presented a series of shows, geared to elementary school children, based on material found in the Children's Room at the Library.

Volunteers also worked on the Arts Council and its Follies, in the Health and Welfare field, YWCA, Scouting, and on 38 different boards in the community.

The Provisional Course was streamlined, By-Laws were changed to conform with AJLA By-Laws, advertising in the Newssheet was increased thus cutting the cost of printing it, we served as one of the hostesses at the Sedgefield Regional Conference, and had a Mardi Gras Dance for our own membership which now totals 373.

Mrs. Royall Brown served as President in 1955-56. This was a year of projects—past, present, and future. Our three-year activity program for children was completed at the Public Library. During that time, \$4,500 was spent for film, records, exhibits, furniture, and programming. Many volunteers helped to make this a success.

Recreational Therapy at the Baptist Hospital was enlarged. Five hundred dollars was used to decorate and equip a room for their use. One hundred dollars is budgeted for operating expenses. The chairman of this committee was given a Board position.

In the cultural field the League is continuing with outstanding art exhibits at the Library. Three were shown, concurrently, to 1,500 people in the community. One hundred forty League girls acted as hostesses. Financial support has been promised to the Arts Council, a former League project, to help equip their new home.

Our future project, voted on unanimously, is in the field of health and welfare. We will fill an unmet need in the community by giving the salary for a primary education teacher for the handicapped at the Children's Center. Volunteers are already serving there.

During the year 62 members held 108 positions on 32 different

community boards.

The Rummage Sale was most successful, with a net profit of \$5,493. Every active member was required to help in some capacity. This was our sole source of income for our Community Trust Fund.

The Children's Theatre Committee presented "Cinderella" to 2,100 city school children, kindergarten through third grade.

Seventy-two League girls worked together to make the play a success.

Two By-Law changes were voted on. A 25-cent penalty was added to fines in arrears. The date of accepting provisionals was changed from February to April.

Upon recommendation of our Association President, the League participated in the local Civilian Defense Program. Eighteen girls took a training course given by the United States Army and volunteers worked with the Ground Observer Corps regularly.

On the social side, a public relations luncheon was given for people in the community who had helped the League in various ways during the year. Within the League we had a luncheon in June, a barbecue in October, and a dinner dance in February.

During this year Mrs. Agnew H. Bahnson, Jr., served as president. This was a year devoted primarily to strengthening already existing projects and adding to those services. Through the funds made available to the Children's Center, Miss Evelyn McNeely, a primary education teacher, was hired, to prepare the children there scholastically for entrance into the public schools when they are physically ready. The Children's Center Committee also organized a young adult program for the handicapped which they sponsor in co-operation with the recreation department. This was the first time anything had been done in the community for this group. In the other phase of activities in the health field, the playroom at the Baptist Hospital and the therapy program there, emphasis was placed on improving the program to provide better mental therapy. Fortyeight volunteers filled regular placement positions in these two projects, both of which meet with ever increasing and loyal support from the membership as well as from the staff involved in both localities.

Interest continued in the field of the arts with over 50 League volunteers filling positions with Arts Council groups, 70 members staffing League's spring art exhibition, "From Cloth of Gold to Printed Cotton" at the library (one of two presented by the League during the year), and with 42 members participating in the Children's Theatre Board production of "Heidi." Children were used in the production for the first time this year. This addition met with enthusiastic response from the community and the play was seen by over 4,000 children.

The placement program continued to be broad and volunteers were to be found throughout the community in responsible positions. Eighty-nine community board positions were held by members this year.

We were invited to be the hostess organization to take charge of the reception for special guests following the "Welcome Wake Forest" community celebration in September.

Our regional director, Mrs. Charles Gibbs, from Charleston, South Carolina was the guest of our League in December.

In addition to the regular June luncheon the League voted to have two other luncheons, one in December and one in March.

In February a formal ball was held at the Forsyth Country Club with 261 persons present.

The Rummage Sale made a net profit of \$6,150.60. For this each member was scheduled to work 4 hours marking and sorting and $4\frac{1}{2}$ hours during the sale.

To study the Rummage Sale picture, attendance records, the fine system, and other related subjects, an Advisory Planning Committee was set up. As a direct result of this, "coffee meetings" were held in February to discuss in small groups a questionnaire which had been prepared for this purpose. From these meetings came many excellent criticisms and suggestions to be used in present and future planning.

ANNUAL REPORTS OF BOARD WINSTON-SALEM JUNIOR LEAGUE

PRESIDENT

As the end of this Junior League year has approached, I have been giving serious and considerable thought as to how this year's aims, purposes and developments could be presented to you in their proper perspective. It is difficult, particularly at this time, to get far enough away from a desk covered with evaluation guides, annual reports, recommendations, statistical reports and summary sheets to look objectively at what has been attempted and accomplished. As one wit has expressed it. "Architects cover their mistakes with ivy, doctors cover theirs with sod, and brides theirs with mayonnaise." To this I'd like to add "and presidents of organizations with their annual report"! As of course you remember, this was the year of our Regional Director's visit and since she was a so-called outsider looking in. I would like to have you look with me at part of our League this year through her eyes. I do this for several reasons. Even though she had never been here before it was her job to know the back-ground of our League. She knew how a League doing a good job should operate and she could judge how well our program is fulfilling the Junior League purpose. She knew before she came that the Winston-Salem League has a very fine background and enviable reputation, that its standards have always been high and that we of the present day have much to live up to. She knew the fields in which we have been pace setters. She knew of our early emphasis on health and welfare, of our pioneering in the field of the arts and how behind almost every important cultural advance in our town one can find the name of the Junior League. She knew of how our admission policies have been copied throughout the country as well as our entire manual of procedure by many Leagues. Plus knowing this background, she was also aware that our fields of interest were expanding and that we had recently given financial aid and volunteer efforts to help support two projects in the health field in addition to our usual broad placement program. Another reason for looking at us through our director's eyes is that when she was here I am sure we put our best foot forward!

Naturally, we took her to the places where our present emphasis lies and I will briefly take you there also. First we took her by the City-County Library, where we terminated our children's programing project, to see the children's reading corner which has been furnished this year by the funds left over at the end of our three-year commitment. Four volunteers regularly tell stories there and one catalogs records in the children's room. We showed her the gallery rooms on the lower floor where art exhibits hang regularly, two of which this year were made possible by the Junior League grant of \$500.00 and which came about as a result of our cultural arts committee planning. During the Spring exhibit, 70 League members are scheduled to be in attendance for one period each.

Next, she went to the Arts Council and was shown tentative plans for the new Community Center to which our League last Spring contributed \$5,000.00, toward the Arts Council portion of the building. Although we have no reason to be other than modest concerning the fund drive itself, we are beginning to receive much credit all over the country for the large part we played in the beginnings of the Arts and Crafts and the beginnings of the Arts Council, without which it is doubtful that the two organizations would be in existence today, and certainly not in their present strong position. It is interesting to note that including children's theater, but not including the 70 members working one shift each during our art exhibit, there are approximately 100 League members who have this year done some volunteer work in the arts field. It is not difficult to see how much of the strength of Arts Council organizations has been due to Junior League volunteers. Though we sometimes grow weary of hearing about the arts at every turn we must certainly attribute this large number working somewhere in this realm to the fact that among us there is a deep concern for the development of these fields in our town. Another proof of this particularly close to us is the fact that we were 42 strong working on our play this year. And we reached a point in "Heidi" that we had hoped for for a long time-we used children in the children's parts. Because of this there was exceptional response from the community and about 4,000 school children attended the play which was presented on two afternoons. Parts of the play were also presented at the Children's Center and in the playroom at the hospital.

Next door to the Arts Council we took Wilmot to the Children's Center where our most recent project has its headquarters. Through funds made available by us for three years, the Children's Center Board last summer employed Miss Evelyn McNeely as a teacher on the elementary school level, to prepare the children there scholastically for entrance into the public schools when they are physically ready. Miss McNeely has also had eight years' work in recreation and so is doubly qualified for her important position. She is dearly loved by both children and staff and is filling a great need. Our Children's Center committee has also organized an adult program for the handicapped which they are sponsoring in co-operation with the recreation department. Before this was done there was nothing being offered to this group anywhere in the city. Four League volunteers are participating in this program, three others are regular volunteers at the Children's Center, six serve on the Board of Directors, with two on the Executive Committee.

They as members of the Board and as individuals have taken an important part in the planning necessary to make the new Children's Center building possible. Speaking of board members, Wilmot was astounded to hear that 89 community board memberships are held by Junior League members!

To see the other phase of our interest in the health field, we took Wilmot to the Baptist Hospital to see our therapy program there. Since the playroom was already decorated, the planning of the Hospital Therapy Committee has centered this year around improving the program to provide better mental

therapy. Twenty regular volunteers and four substitutes have staffed the playroom five days a week with two girls working each day during the winter months. During the summer nine provisionals helped the regular volunteers staff the playroom three days a week, and six professional girls are working now at night during visiting hours. A television set which was donated recently for use in the children's playroom is being used under supervision for entertainment purposes and is giving much pleasure particularly to burned patients who have been in the hospital for a long time.

These two projects in the health field are meeting with ever-increasing and loyal support from our membership as well as grateful praise from the staff members involved in both localities.

The restoration program at Old Salem was another thing Wilmot had put on her "must see" list, since it is a project in our town that has received nation-wide publicity. She was gratified to see that our League is taking an active part in this work with twenty girls staffing the restoration headquarters five days a week. Five others have been on call for publicity photographs when needed. In monetary terms expressed to us by Mr. Ralph Hanes this year, this is 1500 girl hours per year, which at local secretarial rates amounts to a yearly donation of \$2,500!

In addition to these concentrated efforts, this year found eight volunteers with the Red Cross Bloodmobile, two at the Child Guidance Clinic at Graylyn, fourteen telling stories and doing correlations for the Radio and TV Council, three at the Volunteer office, five at the Health Association, twenty-two in the Scouting program, three working with the Y-Teens program, and one as receptionist at the new YWCA Gymnasium. And, something new, two have taught cooking classes at the Red Shield Boys' Club! In addition, there have been short-term projects which have involved over 125 volunteers: The Piedmont Opera Company drive, the Arts Council fair booth and fund drive, the Christmas Toy Shop, driving for the Golden Age Club and, one of our largest single efforts, our part in the community-wide "Welcome Wake Forest"! We were the organization invited to take charge of the reception for the 2,000 special guests, which followed the large celebration in September in the Coliseum. The Hospitality Committee and board members were responsible for the success of this gala evening!

Our source of income to carry on our community projects was the Rummage Sale. Rummage for this was collected from active members, sustaining members, merchants and manufacturers, and through a Montaldo's fashion show with rummage as the admission charge. Each active and provisional member was scheduled to work four hours marking and sorting, and four and one-half hours during the sale. Our net profit from the rummage sale this year was \$6,150.60. These funds went directly into our community fund and from there were administered by our treasurer who has had the job which most of our husbands would classify as the most difficult in the organization—that of keeping women's finances straight!

This has been a year during which we have tried to strengthen our already existing program by studying our strengths and

weaknesses. This was our third rummage sale and after it was over the Board set up an evaluation study committee whose primary assignment was to look over the Rummage Sale picture, profit-wise, volunteer-wise, etc. and to present recommendations.

Also in the interest of taking a good look at ourselves, an attendance study committee was set up to look over attendance records for the past three years, study the fine system and present the entire picture, bad or good. Incidentally, attendance has been higher this year than in any other preceding year, an average of 121 at each meeting, 139 being the high for the year and 111 being the low.

As these two new committees started functioning it became apparent that there were other closely associated pieces that should fit into the same picture. As a result these committees were combined and were given a new name, Advisory Planning Committee, whose assignment was to study the entire League picture and not just one part. Out of this committee soon came the "coffee meetings," held in February to discuss in small groups the various aspects of the League. These were for the most part very successful and many fine suggestions and ideas came from them which are being incorporated in present and future planning. Of great value to the Advisory Planning Committee was the report Wilmot sent back after she had reviewed our activities.

Also in the area of trying to follow the desires of the membership were the questions asked at placement interviews in the Fall concerning luncheon meetings. It was almost unanimously agreed that more opportunities for getting together, not just for "business," would be desirable; so as a result there were two luncheon meetings in addition to the regular June luncheon. At the one in December we honored our Regional Director who, in case you thought we had lost her, is still looking over my shoulder! In addition, we honored our past presidents who were invited to sit at the head table with Wilmot. Among those, of course, was Libby Gray, our valuable sustaining representative on our board this year. At the March luncheon we honored our transfers for the past two years. Also in the area of good fellowship on a strictly social level was our beautiful Junior League Ball which was held in March and which met with high praise. The Hospitality Committee has had to be a large and, as you have been hearing, a very active one! "Active" is a word that can be correctly applied to all your committees, as a matter of fact, and they have served your organization intelligently and with imagination. The Magazine Committee has kept us well represented in "Tidings" and has sent in two impressive articles on our League program. It is hoped that one of these (which was requested by the magazine itself) concerning our part in the Community Center Building, will be used soon.

The newssheet has kept us well informed on AJLA, has

The newsheet has kept us well informed on AJLA, has helped us interpret our own program and policies, has scheduled us, amused us, praised us and has had several new features. Outstanding among these has been a series of articles written by outstanding citizens in the community expressing what, in their opinion, the Junior League means to our community.

To know our town better, to know our League better, to know ourselves better, and to have a better time has been the

scope of the Education Committee and they have accomplished this through a variety of excellent programs.

To let our program be known by our town and to continue our favorable relationship with it has been the aim of the Public Relations Committee. Recently also they have been working on a large size mobile exhibit which will be sent to conference and which will be used later to help interpret our activities to the community.

In addition to this, at the October Board meeting, Dr. Dale Gramley, sponsored by the By-Laws Committee, spoke to the Board, provisional members, plus any interested League members on "Parliamentary Procedure." This was scheduled as part of the regular provisional course. Because this course was planned to cover the entire year instead of taking place in a concentrated period we feel that the provisional members have been able to keep in closer contact with the League. As you have heard tonight, ten girls have successfully and with high commendation completed this course to take their places as active members.

Our hard-working and conscientious admissions committee has replaced them, as you have also heard tonight, with seventeen new Provisional members who will start their course immediately.

There have been twelve professional members this year who have been kept in contact with League activities by our vice-president. Despite the fact that their time for volunteer work has been limited, they have as a group managed to carry on an amazing amount of volunteer activity and in a variety of fields!

There have been twenty-four changes in membership status this year, the ones we are particularly delighted with are the six members who have transferred to our League from other communities!

Plus all these things that have been taking place close at hand you also were represented at the National Conference at Quebec last May, at President's Council in Charlotte in September, at a Civilian Defense Conference in Charlotte in October, and in January at the Regional Conference in Asheville, this time by two delegates, four observers, and by our member of the Regional Nominating Committee. This person also happens to have been our own Nominating Committee Chairman who with her important committee was responsible for delegates to all these conferences. The Nominating Committee is part of the life's blood of our organization. Through them tonight you have elected your Admissions Committee and future members of the Nominating Committee itself both concrete proof of a fair and democratic process in action. And it is through them that your new administration has been selected. They have done a particularly excellent job and have given you a strong, balanced, intelligent Executive Committee for the coming year and a president who will lead them with enthusiasm and devotion.

This has been a gratifying year for me working with my right hand—the Executive Committee, the Board, and with you, an amazing group of women. Who are you? Who is the Junior Leaguer? I will answer this by quoting our AJLA President, Barbie Foote, at last year's conference. "Who is the Junior

Leaguer? She is someone who has made a choice. Remember, she is typically wife, mother, and volunteer, in that order. Few, (if any), Junior Leaguers have unlimited free time. Our member has made a choice beyond mere leisure. She has a curiosity and a conscience about her community. She recognizes her stake in it and her obligation to serve it thoughtfully."

And so it gives me a great deal of pleasure to be able to turn over this gavel to your new President, Betty Alexander, a member who has made a choice!

VICE-PRESIDENT

The Professional members of the Winston-Salem Junior League held four regular meetings in 1956-57 in April, October, December and February. All meetings were held in my home except the latter one, which was the Coffee Meeting, and it was held in the home of one of the Professionals. There were 12 regular members of this group with an average attendance of 9 at each meeting. At the end of the year the members numbered 9, as one girl had moved away and 4 new Professionals were added to the group at the April meeting, making the total number 13.

All of the important business matters that occurred during the year were brought before the members, including a thorough discussion on the Professionals' place in League programs and how to make their volunteer work more effective.

Since the Professionals' ability to serve in various volunteer jobs has always been limited, I was pleased to find that this year, several of them are working at the Red Shield Boys' Club, in the Hospital Therapy Program, in the Civilian Defense Ground Observer Corps, and each girl worked on the Rummage Sale, both marking and selling.

I have found that the Professional members do not feel as close to the League and its activities as they would like, and, therefore, it is strongly recommended that a morning and an evening League meeting be held every month in order that the working girls will have the same program and a chance for closer association with the active members.

At the President's request, I attended two civic luncheons, representing the League and also served at the reception given for "Welcome Wake Forest."

CHILDREN'S CENTER

HOSPITAL THERAPY

In April the chairmen of the various committees met to discuss the duties of each chairman and to plan our summer program. Since the playroom at the Baptist Hospital was largely decorated, our planning has centered around improving our programming to provide better mental therapy.

At a two-evening workshop in October, Dr. Alanson Hinman spoke to a meeting of all regular workers, substitutes, and interested professionals. He indicated the most desirable type program and the best personal approach for helping convalescing children. Marjory Northup showed many media which could be successfully used in the playroom and skillfully demonstrated some applications of the various media.

A second general meeting was held in January to evaluate our program and make suggestions for improving it.

Twenty regular volunteers and four substitutes have staffed the playroom five days of the week with two girls working each day during the winter months. During the summer nine provisionals helped the regular volunteers to staff the playroom three days a week.

Six professionals with Sally Bet Cunningham as their chairman have started to work in the playroom at night during visiting hours. These girls work every other week on Monday, Tuesday, Wednesday and Thursday reading or visiting with those children who have no other visitors.

I would like to thank all committee members who have so cheerfully and efficiently cooperated during the past year.

PLACEMENT

The Placement Committee met with Mrs. Lois DeHart of the United Fund Volunteer Office in August to discuss plans for visiting the community agencies which use volunteers the following month. Mrs. DeHart suggested that we invite other volunteer organizations to accompany us this year; six other groups took part in the tour which proved to be worthwhile to them and to the agencies.

A new type of brochure, describing placement opportunities to the membership, was used this year. Also, the members of the committee made a duplicate file of the placement records, so that the chairman may now have a complete file at all times.

The Junior League volunteer program presents a well-balanced picture, with volunteer activity in the health, welfare, and cultural fields.

Twenty girls were regular workers in the Hospital Therapy Program at the Baptist Hospital, with 6 substitutes and 6 professional members taking part in an evening program started this year. The Children's Center had 3 regular volunteers, with 6 of the membership serving on its Board of Directors and 2 on the Executive Committee.

Salem Restoration Headquarters was staffed five days a week by 15 League volunteers; 5 others volunteered to be called upon for publicity photographs when necessary.

Nineteen volunteers did secretarial, committee, and board work at the Arts Council, 9 members were active in the Arts and Crafts Association, and 6 in the Little Theater. The Chairman of the Woman's Exchange is a League member, as is the volunteer chairman, and 12 other League members worked at the Exchange as sales personnel and 1 as a bookkeeper.

Seven volunteers are active in the new Winston-Salem Gallery of Fine Arts. The manager of the Winston-Salem Symphony is a Junior League member, as are the Assistant Chairman of the newly formed Symphony Guild and its chairman of children's concerts. One of our volunteers served as chairman of the Residential Division of the Arts Council Fund-Raising Drive and 1 as co-chairman.

The Children's Theater presented "Heidi" this year with 42 of the membership taking part in the play in some capacity.

It is interesting to note that including the Children's Theater, approximately 100 League members have done some volunteer work in the arts field this year.

The Rummage Sale was a great success, largely due to the 17 people who worked many hours before the sale. One hundred and fifty people marked merchandise for four hours and 120 were present at the sale for a four and one-half hour period.

An exhibit, "From Cloth of Gold to Printed Cotton," was scheduled for the month of April at the Library. One hundred and ten League members kept the exhibit open to the public every afternoon and evening.

The Red Cross Bloodmobile used 8 volunteers regularly, while 2 went regularly to the Child Guidance Clinic at Graylyn.

Twelve volunteers told stories and did correlations for the Radio-TV Council, and 4 told stories regularly at the Children's Room at the Library. One catalogued records in the Children's Room.

The Volunteer Office has used 1 regular volunteer, while 2 do research for that office. The Health Associations have had assistance distributing literature from 5 of our volunteers. Twenty-two are active in the Scouting program; 2 taught cooking classes at the Red Shield Boys' Club; 3 have taken part in the Y-Teen program; and 1 has been a regular volunteer receptionist at the new YWCA gymnasium.

There have been short-term projects which have involved the Junior League: "Welcome Wake Forest," the Opera Drive, Symphony Drive, Arts Council Fair Booth, Arts Council Fund-Raising Drive, Toy Shop, Driving for the Golden Age Club. These projects alone involved over 125 volunteers.

League members hold 92 community board memberships.

The membership takes an active part in PTA. Many are

grade mothers, garden club members, active in church work, alumnae clubs, and service leagues.

The Placement Chairman, or a representative, attended three meetings of the Volunteer Bureau during the year, making reports on our volunteer activities.

I want to thank the members of this committee, as well as the entire membership of the League, for their wonderful cooperation this year.

RUMMAGE SALE

By-Laws of the Junior League of Winston-Salem

ARTICLE I-NAME

The name of this organization shall be the Junior League of Winston-Salem, Incorporated.

ARTICLE II-OBJECT AND POLICIES

Object: The object of this League shall be to foster interest among its members in the social, economic, educational, cultural and civic conditions of the community, and to make efficient their volunteer service.

Policies: The policies of the League shall be in harmony with the policies of the Association of Junior Leagues of America, Incorporated.

ARTICLE III-MEMBERSHIP

Section 1. Classes of Membership

Only women under forty years of age who shall comply with the requirements of the Association shall be admitted to membership by the League. No member shall at any time be a member of more than one League. The classes of membership shall be as follows:

A. Provisional Membership

Provisional members are those who are engaged in complying with the requirements for admission to Active Membership and are not eligible to vote or hold office. Provisional members shall be required to complete a provisional member's course, which shall meet the standards set by the Association and a period of volunteer service satisfactory to the Placement Committee within twelve months after their election to provisional membership. An extension of time may be granted by the Board of Directors in the case of provisionals who for unavoidable reasons are unable to complete the course. Provisionals who have completed these requirements are admitted to active membership by a three-fourths vote of the Board of Directors. Those members failing to meet the provisional requirements shall be dropped from membership by a three-fourths vote of the Board of Directors and may not come up again for membership within two years.

B. Active Membership

Active members are those who have completed the requirements for provisional members and who, having been admitted to active membership, justify such membership through service to their communities. An active member shall enjoy all rights, privileges and obligations of membership until the end of the League Year (which need not be the League's fiscal year) in which she reaches her 40th birthday, provided, however, that any active member who holds a position as an officer or director of a League immediately prior to her 40th birthday, shall be considered an active member for all purposes until the completion of such term as officer or director. They shall justify their membership by the equivalent of one-half day's work per week in established community agencies using volunteers and/or activities identified with the Junior League.

C. Sustaining Membership

Sustaining members are those who have reached the age limit for active membership. They shall have all privileges of membership except that they may not hold office or vote.

D. Non-Resident Membership

Non-resident membership shall be open to active or sustaining members in good standing, living outside the County of Forsyth, North Carolina, nine months a year. They may not vote or hold office. Active members who become non-resident in a League town, may retain it for two years only, unless home League grants an extension.

A proposed member shall be from nineteen to thirty-three years of age, shall have completed her schooling, and shall have been a resident of Winston-Salem or its vicinity for at least one year. She shall have a personal interview with the President and the Provisional Chairman. Before she accepts the invitation, she shall agree to fulfill the duties and obligations of membership.

B. Proposal of Members

Each candidate shall be proposed by one member and seconded by two members on an application blank provided for the purpose. No candidate shall be proposed or seconded by a member of the Admissions Committee nor of the Executive Committee, nor by her relative (mother, mother-in-law, sister, sister-in-law, aunt, niece, or first cousin). No candidate shall be considered whose name has been proposed and voted on four times.

Application for membership shall be received by the Chairman of the Admissions Committee at any time during the year. The deadline for applications for those members to be taken in the following April shall be June 1. Only one blank for each candidate shall be accepted by the Admissions Committee.

Any eligible Active or Sustaining member may propose one candidate and second one candidate during a given year, but no member shall write to the committee in behalf of a candidate. No member of the League shall contact any member of the Admissions Committee in behalf of a candidate except at the open meetings held for this purpose.

C. Election to Membership

The chairman shall present the names of proposed candidates to the voting members of the Admissions Committee, and each shall vote by secret ballot. Eight affirmative votes of the Admissions Committee shall qualify a proposed candidate for membership. Invitations shall be mailed immediately to those elected, and the names of those who accept shall be announced by the Admissions Chairman at the April meeting.

If a candidate is unable to take the Basic Provisional Course or to transfer to another League, she must decline the invitation to membership. In this event, the invitation shall be re-issued the following year only.

Section 3. Changes in Membership

Applications for change to another class of membership shall be made in writing to the Corresponding Secretary and will be acted upon by the Board of Directors at any time during the year.

Inter-League Membership

A member of any League who is subject to frequent change in residence may have an Inter-League card issued to the Secretary of the League in which she will be temporarily residing by the League of which she is a member (hereinafter called the home League). Such card shall accredit her temporarily to the League in city where she is then residing (hereinafter called the temporary League). She shall have all privileges of membership in the temporary League except the right to vote or to hold office; or to propose or second candidates for membership in the temporary League, she shall comply with the requirements of and be subject to the rules of the temporary League, an Inter-League member shall continue to be listed as a member of, and shall pay her regular dues to the home League, and the home League shall have final responsibility for her in all matters. An Inter-League card is issued for one year unless extended by the League to which the card is issued. Any extension shall be limited to an additional year. A League to which a member is temporarily accredited may charge such member for special club privileges or for the actual cost of her membership.

Transfer of Members

Provisional, Active, Sustaining and Non-resident members in good standing shall have the right of transferring membership from one League to another. Members who are in a League special classification may not transfer in such special classification but may transfer only when in a classification recognized by the Association. The right of transfer granted in this section need not extend to a person who has been dropped or expelled from membership by the League to which transfer is desired. Provisional members shall take any additional training required by Leagues to which they transfer. A League may require all Active members who are applying for transfer to take an orientation course before their transfers are accepted. A League shall not be required to accept Transfers which exceed twenty-five per cent of all admissions to membership in any one year. If it is necessary for Transfers to be put on a waiting list, they shall be accepted in the order in which they apply.

Section 4. Resignations, Dropped Members, Re-instatements

A. Resignations

Any member of the League who is not in arrears in dues or in the performance of League duties may resign. Resignations shall be made in writing to the Recording Secretary of the League at least two weeks before dues become payable; otherwise members shall be liable for dues for the coming year.

B. Dropped Members

Members may be dropped from the League for cause by a three-fourths vote of the Board of Directors.

C. Re-instatements

Members who have resigned while in good standing may be re-instated by a three-fourths vote of the Board of Directors, upon paying a sum determined by the Board of Directors.

ARTICLE IV-OFFICERS

Section I. Personnel

The officers of this League shall consist of a President, Vice-President, Recording Secretary, Corresponding Secretary, Treasurer, and Assistant Treasurer.

Section 2. Nomination

The Nominating *Committee shall present a slate of one candidate for each office to be filled. The slate shall be sent by the Recording Secretary to each voting member of the League at least two weeks before the election meeting.

Independent nominations may be made in writing by five active members of the League, provided the nominee has given her consent.

It shall be the duty of the Nominating Committee to insure continuity of administration by retaining one or more members of the Executive Committee for two terms.

Section 3. Elections

Officers shall be elected at the February meeting of the League for a term of one year with the exception of the Treasurer, who shall be elected for a term of two years. They shall assume their duties immediately after the April meeting.

Section 4. Duties

The powers and duties of the officers shall be as follows:

A. President

The President shall preside at meetings of the League, Board of Directors and Executive Committee; shall appoint the Admissions Chairman and personnel of Committees, not otherwise provided for with the approval of the Executive Committee, and shall be a member ex-officio of all committees except the Nominating Committee. She shall, with the Treasurer, sign all contracts, and obligations authorized by the Board or Directors, and shall perform the duties pertaining to the office.

B. Vice-President

The Vice-President shall assist the President and perform the duties of the President in her absence.

C. Recording Secretary

The Recording Secretary shall keep minutes of the meetings of the League, the Board of Directors, and the Executive Committee. She shall keep a correct, classified list of the names and addresses of all members and shall maintain a file of essential records which shall be transferred to her successor at the close of her term of office. She shall, with the Corresponding Secretary, compile the annual reports and edit the year book, and she shall inform all independent nominees of their nominations.

D. Corresponding Secretary

The Corresponding Secretary shall conduct the general correspondence of the League. She shall assist the Recording Secretary in compiling the annual reports and editing the year book. She shall handle all correspondence in regard to changes in membership.

E. Treasurer

The Treasurer shall be custodian of the funds of the League and shall receive all monies except for those activities which have their own treasurer or other person specifically appointed to handle finances. Such persons shall be under supervision of the Treasurer. She shall serve as Chairman of the Finance Committee. She shall make payments in accordance with the budget on written authorization of the President: expenses not provided for in the budget shall be incurred and paid only upon order of the Board of Directors. She shall keep full and accurate accounts and shall present financial statements at regular meetings of the League and Board: she shall turn over to her successor all books and financial records and shall take a listed receipt therefor.

F. Assistant Treasurer

The Assistant Treasurer shall collect all dues and assessments, check attendance records, and assist the Treasurer when necessary.

Section 5. Executive Committee

There shall be an Executive Committee, composed of the officers, which shall assist the President in making appointments. It shall have all the powers of the Board of Directors during the months in which there are no regularly scheduled Board meetings. The minutes of the meetings of the Executive Committee shall be submitted to the Board for ratification at its next meeting.

ARTICLE V-BOARD OF DIRECTORS

Section 1. Personnel

The Board of Directors shall consist of the officers and the chairman designated by the Executive Committee each year. Chairmen are appointed by the President with the approval of the Executive Committee.

Section 2. Term of Office

Officers are elected for a term of one year; chairmen appointed for a term of one year. No officer or chairman shall hold the same office for more than two terms in succession.

Section 3. Duties and Powers

The Board of Directors shall have general charge and control of the affairs, funds and property of the League. It shall be the final arbiter in matters of interpretation of these By-Laws, It shall present to the membership all proposed major program activities for ratification.

Section 4. Vacancies

Vacancies among the offices shall be filled by election by the Board of Directors. Vacancies among the chairmen shall be filled by the President with the approval of the Executive Committee until the expiration of the term of office.

Section 5. Meetings

The Board of Directors shall hold regular monthly meetings from October through June. Special meetings may be called by the President and must be called upon the written request of three members of the Board.

Section 6. Quorums

Eight members of the Board of Directors and three members of the Executive Committee shall constitute a quorum respectively.

ARTICLE VI—COMMITTEES

There shall be the following Committees who shall present plans for work to the Board of Directors. No work shall be undertaken without the Board's approval.

A. Admissions Committee

There shall be an Admissions Committee whose function shall be to pass upon all applications for membership to the League (or) to make recommendations to the Board with respect to applications for membership. The committee shall be elected at the time and in the manner herein provided, and shall serve for one year.

(a) Personnel of Committee

The committee shall be composed of eleven members: A Chairman, who shall be appointed by the Executive Committee, and shall not be entitled to vote; a Sustaining member who shall be elected by the League, and shall NOT be entitled to vote; and nine voting members, who shall be elected by the League as provided in this Article.

(b) Eligibility to Serve on Committee

Eligibility to Serve on Committee
To be eligible for election to the Admissions Committee,
a member must have been active for at least one year,
and a resident of Winston-Salem or its vicinity- for at
least five years. A voting member shall be eligible to
serve for two consecutive years, and shall be ineligible
to serve for the following year, except as chairman.
The chairman may have been a voting member of the
Admissions Committee for two consecutive years prior
to her chairmanship but after her term as chairman
shall be ineligible to serve for the following year. The
Sustaining member shall have been sustaining no
longer than ten years and shall have served on the
Admissions Committee during her active membership.

No one who has a sister, sister-in-law, daughter, daughter-in-law, niece, proposed for membership shall serve on this committee.

No mother and daughter nor two or more sisters shall serve on the same Admissions Committee.

Neither the President nor the Vice-President shall be eligible to serve on this committee.

(c) Election of Committee

Election of this committee shall be held at the April meeting.

At the March meeting, the Nominating Committee shall present to the active members a list divided into three age groups of all active members eligible for election, and the names of those present members of the Admissions Committee who are eligible for re-election. These age groups shall be as follows: 21 to 29, 29 to 35, and 35 through 39. Each active member present shall nominate, by secret ballot, 4 members from her own age group, and 5 members from the present Admissions Committee Committee.

Consent of a nominee shall be obtained by the Nominating Committee before her name is placed on the ballot. At the April meeting, the Nominating Committee shall present a list of the 4 nominees receiving the highest number of votes from each age group, the 5 nominees receiving the highest number of votes from the present Admissions Committee, and 3 nominees from the Sustaining members.

Each active member present shall vote for 2 nominees from each age group, for 3 nominees from the present Admissions Committee, and for 1 Sustaining member.

In the event that close relatives are elected to this committee, it shall be the duty of the Nominating Committee to determine which of them shall serve.

In case of a tie vote, in either nomination or election of this committee, it shall be the duty of the Nominating Committee to determine which members shall serve.

The names of the Admissions Committee members shall be announced by the President.

(d) Vacancies on Committee

Vacancies on the Admissions Committee shall be filled by the Nominating Committee from among the nominees in the categories in which the vacancies occur. No sponsor of a candidate shall be eligible to fill a vacancy on this committee.

(e) Duties of Committee

It shall be the duty of the Admissions Committee to consider all proposed candidates by acquainting themselves concerning each individual's desirability and qualifications for membership in the League.

A secretary shall be elected by the Admissions Committee from among its members. She, with the Chairman, shall be responsible for keeping an accurate record of all names considered by the committee. These records shall be kept in a permanent file which shall be kept confidential and handed from chairman to chairman for reference by the Admissions Committee.

Members of the Admissions Committee shall take an oath of secrecy, as follows: "I swear that, to the best of my ability, nothing which is said in these Admissions Committee meetings shall be divulged by me, either by statement or implication. I swear that to the best of my ability, my vote will be cast considering the best interest of the Junior League, disregarding my personal feelings."

The Admissions Committee shall hold at least eight meetings during the year, one or more of which shall be open meetings.

B. Placement Committee

There shall be a placement committee whose function shall be to interview all active members at regular intervals for the purpose of offering them a free choice of available placements in the community service program conducted by the League. The Placement Committee shall keep as nearly as possible uniform records concerning the activities of the members under its supervision. The Placement Committee shall include the Placement Chairman, and a vice-chairman, the Interviewer, and such other members as they shall designate.

C. Education Committee

There shall be an Education Committee whose function shall be the planning and supervising of the total education program of the League. The Education Committee shall include the Chairman and a member of each committee responsible for any part of the Education program; these committees being designated by the Executive Committee each year.

D. Nominating Committee

There shall be a Nominating Committee whose function shall be to prepare slates of candidates for election to the various elective offices of the League. The Nominating Committee shall be composed of five members; one, the

chairman, to be appointed by the Executive Committee; one elected by the Board; and three elected by the League, one who has been active from one to four years inclusive, one active from five to nine years inclusive, and one who has been active over nine years. These shall be nominated from the floor at the April meeting from a roster of eligible League members. The Placement Chairman shall serve exofficio.

E. Public Relations Committee

There shall be a public relations committee whose function shall be to arrange for all newspaper, radio and television shall be to arrange for all newspaper, radio and television publicity for the League. It shall attempt to build good public relations by interpreting all League activities to the public so that community understanding, interest and support will result. The Public Relations Committee shall include the Public Relations Chairman, and a member of each committee responsible for each phase of the League program. No member of the League shall give out to the press any news item or information concerning the League without the approval of the Public Relations Committee.

F. Newssheet Committee

The Newssheet Committee shall consist of the Newssheet Editor, as Chairman, and such assistants as she may require. The duties of the Newssheet Committee are to edit and publish the Newssheet.

G. Finance Committee

There shall be a Finance Committee which shall function as the financial fact-finding committee to advise the Board on all matters relating to the financing of the League's own administration and that of its community program. Among its duties shall be the preparation of the budget for presentation to the Board each year. The committee shall include the treasurer as chairman, the assistant treasurer, the treasurer of any money-raising activity, either permanent or temporary, and a past League Treasurer.

H. Magazine Committee

There shall be a Magazine Committee or chairman whose function shall be to discover and report all developments in League activities which might be good material for the Junior League Magazine as well as to follow up suggestions and requests from the Junior League Magazine as a program aid in its own League.

I. Provisional Committee

There shall be a Provisional Committee whose function shall be to plan and direct the education and training of provisional members until such time as they are admitted to active membership. The committee shall be composed of a chairman, vice-chairman, and a representative from each phase of League activity in which provisional members are required to participate.

J. Special Committees

Special Committees shall be appointed by the President with the approval of the Executive Committee which shall designate their powers and the term of the committee's appointment.

ARTICLE VII-MEETINGS OF THE LEAGUE

Section 1-Annual Meeting

The annual meeting of the League shall be held in April for the purpose of receiving the annual reports and of installing officers for the ensuing year.

Section 2-Regular and Special Meetings

Regular meetings shall be held from October through June, the February meeting being designated for the election of officers. Other meetings shall be held at the discretion of the Board of Directors or upon written request of ten members of the League.

Section 3. Quorum

A quorum of the League shall consist of one-third of the voting members.

ARTICLE VIII-FINANCIAL ARRANGEMENTS

Section 1. Fiscal Year, Audit and Bonding

The fiscal year shall be from April 1 through March 31.

The books of account of this League shall be audited at least annually by a certified public accountant, and a copy of the complete audit shall be distributed to each member. Books shall be kept in accordance with sound accounting practices. The community funds and administrative funds shall be carried in separate accounts. All money in the community fund shall be distributed solely for the benefit of the community.

The Treasurer shall be bonded in the amount determined by the Board of Directors.

Section 2. Membership Dues and Fines

All classes of membership shall pay annual dues of not more than \$12.00, which shall include the Association dues of \$6.50, part of which covers the subscription to the Junior League Magazine. Provisional members shall pay an initiation fee of \$10.00.

There shall be a fine of one dollar to each active member for non-attendance of regular meetings, and a fine of two dollars for non-attendance of the Annual meeting. Sickness, absence from the city, or an unusual emergency shall be the only acceptable excuses for an absence. It shall be made in the form of a letter to the Assistant Treasurer, written the week of the meeting. Such fines shall be payable monthly. An additional 25-cent penalty for each month a fine is in arrears shall be added.

Any Junior League member, other than Non-Resident and Sustaining shall be required to pay annually on March 1st, in cash to the Junior League, any amount not otherwise contributed in rummage to complete her Rummage Sale quota.

A. Payment

Dues shall be payable on the first day of the fiscal year. The Assistant Treasurer shall send notices to each member on April 1. Members whose dues and fines are not paid by May 1 will be notified by card by the Assistant Treasurer. Members whose dues and fines are not paid by May 15 will be sent a registered letter. Members whose dues and fines are not paid by June 1 will be dropped. The only acceptable excuse for non-payment is financial disability, made in writing each year, and received by the Assistant Treasurer on or before June 1.

B. Refunds

Refunds of dues will not be made to members resigning during the fiscal year.

Refunds will not be made to Provisionals failing to meet the requirements.

C. A. J. L. A. Indebtedness

Members delinquent in paying this indebtedness to the Association shall be considered in arrears in their dues to this League.

Section 3. Association Dues

The Treasurer of the League shall pay yearly per capita dues for all classes of Membership to the Treasurer of the Association.

Section 4. Letters, Agreements and Contracts

Before any letter, agreement, or contract involving the expenditure of Junior League funds shall be signed and delivered, it shall be approved by the Board of Directors. If it involves more than \$500.00, it shall also be approved by the Junior League Attorney.

ARTICLE IX-DELEGATES TO ASSOCIATION CONFERENCES

Delegates to the Annual Meeting of the Association shall be Active members elected by the League.

Delegates to special meetings or conferences shall be Active members appointed by the Board of Directors.

The full expenses of delegates to conferences and the Annual Meeting of the Association shall be paid by the League.

ARTICLE X-AMENDMENTS AND RULES OF ORDER

The By-Laws may be amended by a two-thirds vote of the members present and voting at any meeting of the League, provided the proposed amendment has been mailed to each voting member at least two weeks prior to the date of the meeting; or provided the proposed amendment shall have been presented over the signature of five Active members at least one meeting prior to that at which action is taken, and due notice of such meeting or action is given the membership.

Roberts Rules of Order (Revised) shall be the parliamentary authority for all matters of procedure not specifically covered by the By-Laws or by specific rules of procedure adopted by the League.

STANDING RULES

- 1. It shall be the duty of the Board to enforce the By-Laws of the League and the Association Policies binding on all Leagues.
- 2. It shall be the duty of the Board to create, maintain, evaluate, and revise, the Manual of Procedure by which it carries out the duties and powers delegated to it in the By-Laws.
- 3. It shall be the duty of the Board (before the beginning of the working year) to present to the League a suggested program for ratification.
- 4. It shall be the duty of the Board, in drawing up the program, to give serious consideration to the interests and capacities of the members, and the number who can take an active part.
- 5. It shall be the duty of the Board to see that a contingency reserve be maintained in the community fund.

ASSOCIATION POLICIES BINDING ON ALL LEAGUES

AS REVISED APRIL, 1952

POLICY I — GENERAL

- A. The Association shall act in an advisory capacity to the Leagues except as otherwise stated in the By-Laws or in the policies and standing rules adopted pursuant thereto.
- B. The Association shall have the right to protect the Leagues from action by one League which may adversely affect the program, standing or fund-raising of other Leagues.
- C. The Junior League shall encourage their members to accept the responsibilities of good citizenship and to educate themselves in all legislative, political and governmental movements which affect the life of their communities, their countries and the world, and shall endeavor to stimulate their members to exercise their respective citizenships intelligently.

POLICY II — COOPERATION AND SPONSORSHIP

- A. The Association may participate in, cooperate with or sponsor any organization, movement or program, which in the judgment of the Board of Directors, as represented by a three-quarters affirmative vote of the members of the Board, will further the purpose of the Association. The Board will inform any such organization that active participation by the individual Leagues is optional. The association shall not engage in legislative action.
 - B. A Junior League may participate in, cooperate with or sponsor conferences or institutes of other national or international organizations, provided approval has first been obtained from the Association office.
 - C. A Junior League may hold or sponsor a group meeting of League members in connection with conferences and institutes of other national or international organizations, provided approval has first been obtained from the Association office.

POLICY III - ACTION

- A. A Junior League may take action on a national, international, state or local public question, provided that a study of the specific problems and the legislative or administrative measures involved has been made, and that the action taken by that League is compatible with the stated purpose of the Association and its member Leagues; does not adversely affect any other League; is not contrary to the policies of the Association; and is subject to the following:
 - 1. Action may be taken on a national or international public question provided the League has first obtained approval from the Board of Directors of the Association, as represented by a three-quarters affirmative vote of the Board of Directors.
 - Action may be taken on a state public question provided the League consults its Regional Director and follows Association legislative procedures.
 - Action may be taken on a local public question at the discretion of the League.

POLICY IV — FINANCIAL

- A. The Association shall not act for others as a fund-raising agent.
- B. The Association shall not make financial contributions to individuals, other organizations or agencies. Financial support may be rendered for direct services.

POLICY V — PUBLIC RELATIONS AND PUBLICITY

A. The Association shall endeavor to protect the name "Junior League" from misuse, and shall take all action which may be advisable to that end.

- B. All references to the Association should be based on accurate facts from current material made available from the Association. This material can be secured from the Regional Directors or the Association office.
- C. Any use of the Junior League name in connection with publicity shall identify the League or Leagues involved.
- D. Any publicity of a Junior League designed to extend beyond its community area must be approved by the Association office.
- E. A Junior League member may publicly identify herself as such only when such identification is in connection with an affiliation or activity compatible with the stated purpose of the Association and its member Leagues and the policies of the Association.

POLICY VI — COMMERCIAL ATTACHMENTS AND MONEY-RAISING

- A. The Association shall not recommend the exclusive use of a specific commercial product for the services of a specific commercial concern.
- B. A Junior League membership list shall not be made available for commercial purposes or for purposes of solicitation.
- C. A Junior League may cooperate with commercial concerns, provided the attachment is consistent with the standards of quality and dignity expressed by the Junior Leagues and the Association, and does not recommend exclusive use of a specific product or concern.
 - Sponsorship of a Junior League activity by reputable firms is permitted for local broadcast, telecast or other media of communication.
 - Sponsorship of a Junior League activity by reputable firms on a regional, national or international basis is permitted provided such sponsorship has been approved by the Association office.
 - 3. Direct selling in a commercial portion of a radio or television program, or in other media of communication, is permitted so long as it is in keeping with the quality of the presentation itself, feature articles in good taste, and does not recommend the exclusive use of a product by the Association, any member League, League member, or person representing the Junior League. Samples of the commercial copy must be submitted for approval by the sponsoring League to the Association office.
- D. A Junior League member may be identified as such in commercial endorsements, only in League publications and/or in connection with League money-raising projects. No Junior League member may be identified as such for personal gain.

Policies VII and VIII embody the "Minimum Standards which all Leagues require of themselves and each other. Their observance and enforcement are the responsibility of each individual League and its officers. Visiting Board and Staff members are obligated to point out apparent deviations from these standards, but the responsibility for constant self-evaluation rests with the League, not with the Association. These policies should be printed with each League's By-Laws. These are policies as revised April 1952.

POLICY VII - MINIMUM STANDARDS

Each member League shall incorporate in its charter, constitution, or By-Laws, the following material:

- A. A statement of its name, which shall be limited to the words "Junior League of (name of city, town or community in which located)."
- B. A statement of its purposes, which shall include the statement of individual purposes stated in Article I, Section 1 of the By-Laws of the Association.
- C. A statement that its policies shall be in harmony with the Policies of the Association.
- D. Provisions complying with the requirements of Article II

- of the By-Laws of the Association. (No other classes of membership shall be permitted; provided, however, that (a) individual Leagues may have a limited number of honorary members, and (b) Leagues which as of April, 1947 had classes, including life members, may continue such classes for their present membership, but shall not admit any additional members thereto.)
- E. A requirement that all provisional members shall complete a course which shall meet the standards set by the Association, and shall perform voluntary service for a period and in a manner satisfactory to the Placement Committee.
- F. A requirement that all active members shall justify their membership through some form of community service satisfactory, in quality and extensiveness, to the Placement Committee (the term community service being defined as including volunteer work for, and service on Boards and Committees of, any philanthropic or humanitarian community organization of high standing in the educational, civic, cultural or social welfare fields.
- G. A requirement for the following committees:
 - An Admissions Committee whose functions shall be to pass on applications for membership in the League or to make recommendations to the Board with respect thereto.
 - An Education Committee, whose function it shall be to plan and supervise the educational program of each League.
 - 3. A Finance Committee, among whose duties shall be the initial preparation of the annual budget of each League.
 - 4. Magazine Committee (or Chairman)
 - 5. A Nominating Committee whose function it shall be to prepare slates of candidates for election to the various elective offices of the League.
 - 6. A Placement Committee whose function shall be to plan and supervise the League's volunteer service so that the capacities and capabilities of the members of the League may be utilized in ways most valuable to the community.
 - 7. A Public Relations Committee (or chairman).
 - A Provisional Committee whose function shall be to plan and direct the education and training of Provisional Members until such time as they are admitted to Active Membership.
- H. The books and accounts of each League shall be kept in accordance with sound accounting practices; each League shall maintain a community fund separate and distinct from its administrative fund; all money in the community fund shall be distributed solely for the benefit of the community. Annually a copy of the audited balance sheet (statement of Assets and Liabilities) and profit and loss statement (statement of income and expense) shall be distributed to each member of the League.
- I. A requirement that the Board of each League shall present to the membership all proposed major program activities for ratification.

POLICY VIII — MINIMUM STANDARDS

- A. The course for provisional members of all Leagues shalf include all topics covered in the Association's basic provisional course outline. Each League shall send to the Association annually, for evaluation and criticism, an outline of its provisional course as soon as reasonably possible after the completion thereof.
- B. The Placement Committee of each League shall interview all active members at regular intervals in order to plan and supervise their free choice of community service as defined in Policy VII, F, and shall keep as nearly as possible uniform records concerning their activities.
- C. No individual League shall associate itself with nor endorse lany, welfare or other similar project, program or

activity which does not meet accepted standards in its field, or show evidence of working toward such standards.

- D. All money-raising, on the part of individual Leagues, shall be consistent with standards of dignity and good taste and in keeping with the laws and customs of the community.
- E. Each League shall send to the Association annually a copy of its audited annual statement.
- F. Each League shall maintain the same standards as required of applying groups under Article II-A, Section 2 of the Association By-Laws.

Association Procedures Applying To All Leagues

INTER-LEAGUE MEMBERSHIP PROCEDURE

Arranging Inter-League Memberships:

Section 1

Inter-League cards issued pursuant to Article II-B, Section 2. of the By-Laws, shall be for a term of one year, unless extended by the League to which the card is issued. Any extension shall be limited to an additional year.

Section 2.

The League to which a member is temporarily accredited may charge such member for special club privileges or for the actual cost of her membership.

Section 3

- (a) A member desiring an Inter-League card shall notify the secretary of the League to which she belongs.
- (b) The secretary, or other authorized League official, and the treasurer of the League in consultation with the Placement Chairman shall be empowered to determine whether said member is in good standing.
- (c) To a member in good standing the League secretary, or other authorized League official, shall issue an Inter-League card; notifying the Association headquarters that such card has been issued; and furnishing to the member the name and address of the secretary of the League to which the member may apply for temporary affiliation, and notifying that secretary about the member.
- (d) Inter-League membership shall become effective immediately upon presentation of the Inter-League card to the secretary, or other authorized League officials, of the League with which the member wishes to be temporarily affiliated. This League shall notify the home League within fifteen days of the date the Inter-League card is received.
- (e) When the period of Inter-League membership expires, the inter-League card shall be returned to its owner.
- (f) Upon return to her home League, an Inter-League member shall return her Inter-League card for cancellation to the secretary, or other authorized League official, who shall notify Association headquarters of the cancellation of the card.

Arranging Transfer of Members:

Section 1

The corresponding secretary and the treasurer of the League from which a transfer is made shall be responsible for filling in the information regarding the member's record called for by the transfer card supplied by the Association. They shall also certify that the transferring member is in good standing and shall then forward the transfer card to the secretary of the League to which the transfer is made.

Section 2.

Transfers shall be accepted by the Board of Directors or the Executive Committee of any League unless the member has no right to transfer under the provisions of Article II-B, Section 3 of the By-Laws. Transfers shall be accepted in order of application, except that applications of members under 40 may be given prece-

dence over those of sustaining members. Transfers shall become effective upon acceptance. Within 15 days thereafter the secretary of the League to which the transfer has been made shall notify on transfer cards supplied by the Association, the member involved, the treasurer's office at Association headquarters, and the member's former League.

Section 3.

A member transferring from one League to another shall become subject to the jurisdiction of the League to which she transfers on the date on which such transfer is accepted.

A League receiving a transferring member may charge such transferring member the actual administrative costs incurred by such League in connection with her transfer.

A.J.L.A. GUEST ROOM INFORMATION

Junior League Section

The Junior League Guest Room Section of The Waldorf-Astoria is located on the 19th and 20th floors of the hotel's West (Park Avenue) side, and consists of 22 rooms.

For the convenience of our members, a lounge is maintained on the 20th floor. A waitress is in attendance from 2:00 until 9:00 P.M., to serve tea and beverages.

Cots and cribs may be put into guests' rooms upon request. A cot is \$5.00 plus 5 per cent city tax per night, but there is no charge for a crib.

Sitters for children may be secured through the hotel. The usual charge is \$1.00 an hour until midnight, \$1.25 an hour after. Guests are requested to state the time they would like the sitter to arrive and about how long she will be required.

Cars may be stored at a nearby garage for \$3.25 per night, including pick-up and delivery.

Accommodations

16 rooms—double occupancy—twin beds and private bath. Rates \$14.00 and \$16.00 daily plus 5% city tax.

6 rooms—single occupancy—2 with private baths. Rates \$6.00, \$8.00 and \$9.00 daily plus 5% city tax.

Reservations

In writing for information or to make a reservation, always address Guest Room Hostess, Association of the Junior Leagues of America, Inc., The Waldorf-Astoria, New York 22, New York.

Reservations can not be accepted more than three months in advance. In case of cancellation, an immediate wire is requested. Cancellations made less than 24 hours in advance will be billed at full rate. This not only protects the Association against loss, but prevents the turning away of members who otherwise could be accommodated.

Reservations received by wire are answered by Western Union collect. Please indicate the name of your League when making reservations.

Since there are so few rooms in the Junior League section, it is only possible to assign the best accommodations when the exact dates of arrival and departure are known in advance. It is often impossible to retain rooms longer than the time specified in the reservation, due to the fact that they are reserved for the very date they are to be vacated.

Registration

8:00 A.M. to 9:00 P.M. — Upon arrival, please take the West elevators and go directly to the guest room desk in the AJLA office on the 19th floor to register.

 $9\!:\!00$ P.M. to $8\!:\!00$ A.M. — Upon arrival, kindly register at the front desk of the Waldorf-Astoria Hotel.

Length of Stay

Because of the great demand for accommodations, it has been found necessary to limit the length of stay to one month each six months.

A.J.L.A. Departure Time 12 noon.

Those retaining their rooms after departure hour will be charged for another day. Due to heavy bookings, we are unable to promise that accommodations always will be assigned immediately upon arrival.

Eligible Guests (other than League members)

Members of immediate families (husbands, children, parents, brothers and sisters) may be accommodated for a period not exceeding two weeks when the League rooms are not otherwise occupied. If accompanied by a League member the period is extended to one month.

Written authorization from a League member is REQUIRED for reservations of members of her family. Members are requested to write $AJL\Lambda$ for the necessary form to be filled out in advance of making family reservations. No form is necessary, however, if the member accompanies her family.

Guests other than League members (or their immediate families) may be accommodated only when accompanied by a League member. League members need not request a form in advance when accompanying non-members.

When bringing guests, it is well to send their names in advance. This insures holding of messages and communications received at the hotel previous to arrival.

MEMBERS SHALL BE RESPONSIBLE FOR ANY UNPAID INDEBTEDNESS INCURRED BY GUESTS INTRODUCED BY THEM.

Bills

Bills are mailed to guests after their departure unless they prefer to pay before leaving. Only United States Currency, checks on United States Banks or Checks on Canadian Banks payable in American funds can be accepted. CHECKS WILL NOT BE CASHED FOR MEMBERS UNLESS THEY ARE STAYING IN THE HOTEL AS JUNIOR LEAGUE GUESTS.
